The preponderance of evidence of intent, opportunity, and demonstrated capability; the wording, graphics and anarchist symbology in context and content show what appears to be escalation and corroboration of In Obscura assessment of HIGH Threat Warning. **Two developments in last 24 hours, one locally (screen prints below) are emphasized as potential incendiary justifications for increased violence**

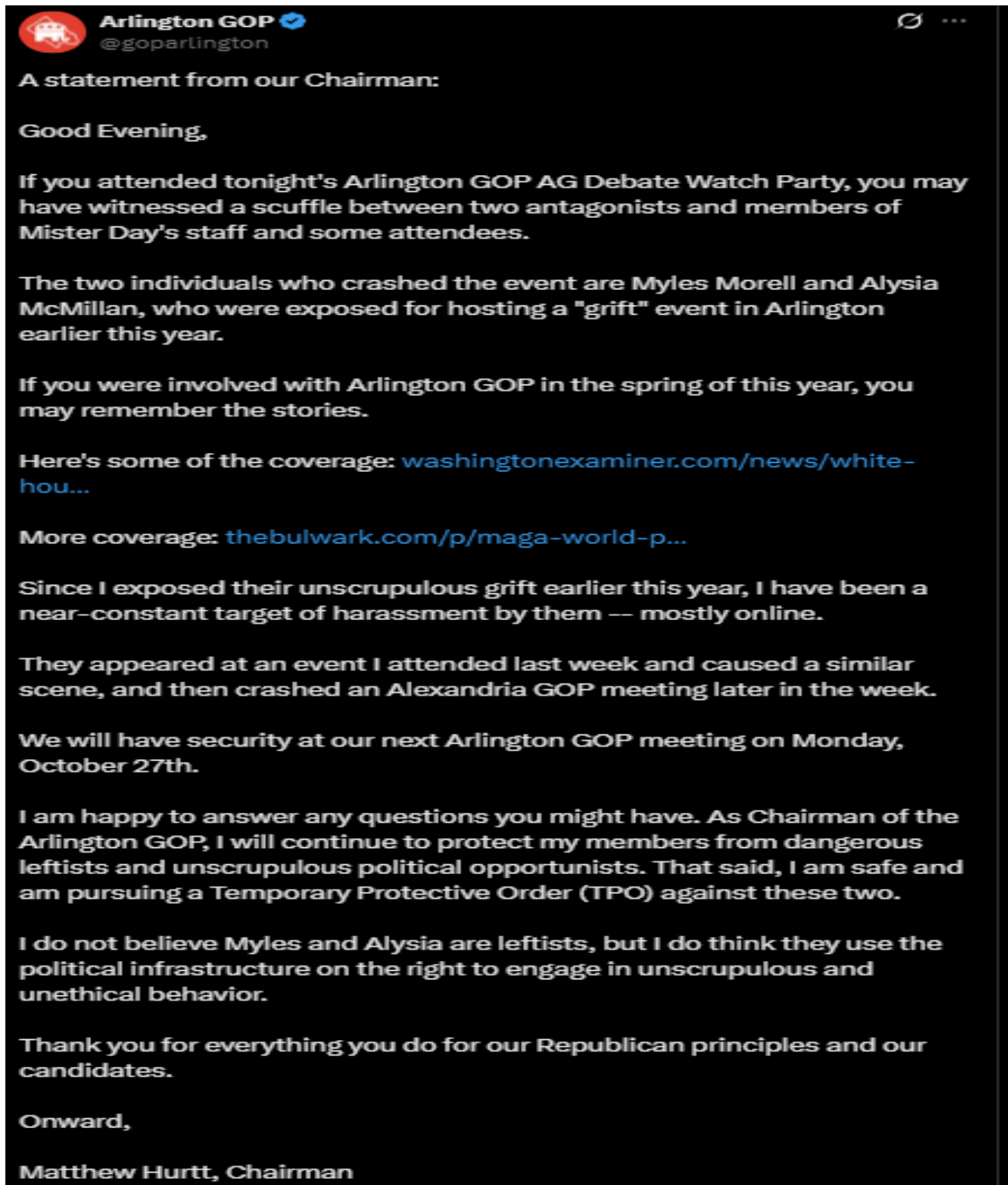

This is a call for you—yes, *you specifically*—to organize an anti-authoritarian bloc in your community for the “No Kings” demonstrations on October 18. If you are willing to do this, skip directly to the **how** section.

Fascism has come to power in the United States. People around the world are horrified. But simply marching in the streets once every few months is not enough. We have to get out there and draw people into concrete organizing and activity. No one else is going to do this for us.

Far-right billionaires have bought up practically all of the media outlets and communications platforms. Our best chance to reach people is in the streets, through grassroots initiatives. “No Kings” is not our only opportunity to reach out to people, but as Trump consolidates control, we can’t afford to let a single opportunity pass us by.

Anarchists are known for our courage; we have gotten used to **acting boldly** in an array of contexts. What is needed now is the courage to take the first step to establish public positions around which a fighting movement can cohere. This both scarier and simpler than many of the things we have done in the past.

To face down Donald Trump’s power grab and his **terror campaign** targeting “antifa,” we need everyone, of all walks of life, to proclaim that opposition to fascism is both laudable and urgent. We must contribute to a ferment that brings together everyone from the fiercest participants in the **George Floyd revolt** to the retirees that **protested** at Tesla outlets last spring. This does not mean limiting ourselves to lowest-common-denominator proposals—that is no way to make a big-tent movement. Rather, we need everyone to show up with their own political analysis and objectives and organizing culture, but with an understanding that we all need each other.

mobilize. Some people will appreciate you being there—those are the ones you have to reach at all costs.

However frightening it is to take this step, the consequences of not trying will be more frightening. **Remember, if you can read these words, there are others putting themselves out there at least as much as you are. That means you are not alone, and the struggle is not hopeless.**

We don't expect the October 18 "No Kings" rallies to be as widely attended as the ones last June. In June, a wave of protest activity was already sweeping the country, starting in **Minneapolis** and spreading to **Los Angeles** and **beyond**. Contrary to the liberals who fear that confrontation scares people away from movements, we have seen over the past decade that people are most likely to get involved in struggles when they see that there is something concrete immediately at stake.

Nonetheless, people will come to the "No Kings" demonstrations, and you should be there to engage with them. At the very least, you will be building skills and networks and a habit of acting that will serve you well in the months to come.

Hi all,

We want to address some confusion regarding an event currently being advertised under the “No Kings” name, scheduled for the same time and date as our No Kings 2.0 march, but at the ICE detention center on Macadam Avenue.

To clarify: **50501 is not affiliated with this action** at the ICE facility. We have never organized any events at that location. As with the original No Kings march on June 14th and all subsequent events, we will gather at the **Battleship Oregon Memorial**.

As organizers with 50501, we prioritize the safety of our community and respect the voices of the most impacted groups. The ICE facility has repeatedly been a **hot spot for violent federal response**, particularly from DHS and other law enforcement agencies. We are concerned that a large crowd there could become a flashpoint and place participants in harm’s way.

To clarify: 50501 is not affiliated with this action at the ICE facility. We have never organized any events at that location. As with the original No Kings march on June 14th and all subsequent events, we will gather at the Battleship Oregon Memorial.

As organizers with 50501, we prioritize the safety of our community and respect the voices of the most impacted groups. The ICE facility has repeatedly been a hot spot for violent federal response, particularly from DHS and other law enforcement agencies. We are concerned that a large crowd there could become a flashpoint and place participants in harm's way.

At the June 14th No Kings march, over 50,000 people gathered and moved peacefully through the city. However, a smaller splinter group later marched to the ICE facility, where they were immediately met with violence and the event was declared a riot. More recently, on October 5th, another peaceful group marched to the ICE facility, where they were again confronted with force, including tear gas deployed against children and elderly protesters.


This is a clear pattern, and it cannot be ignored.



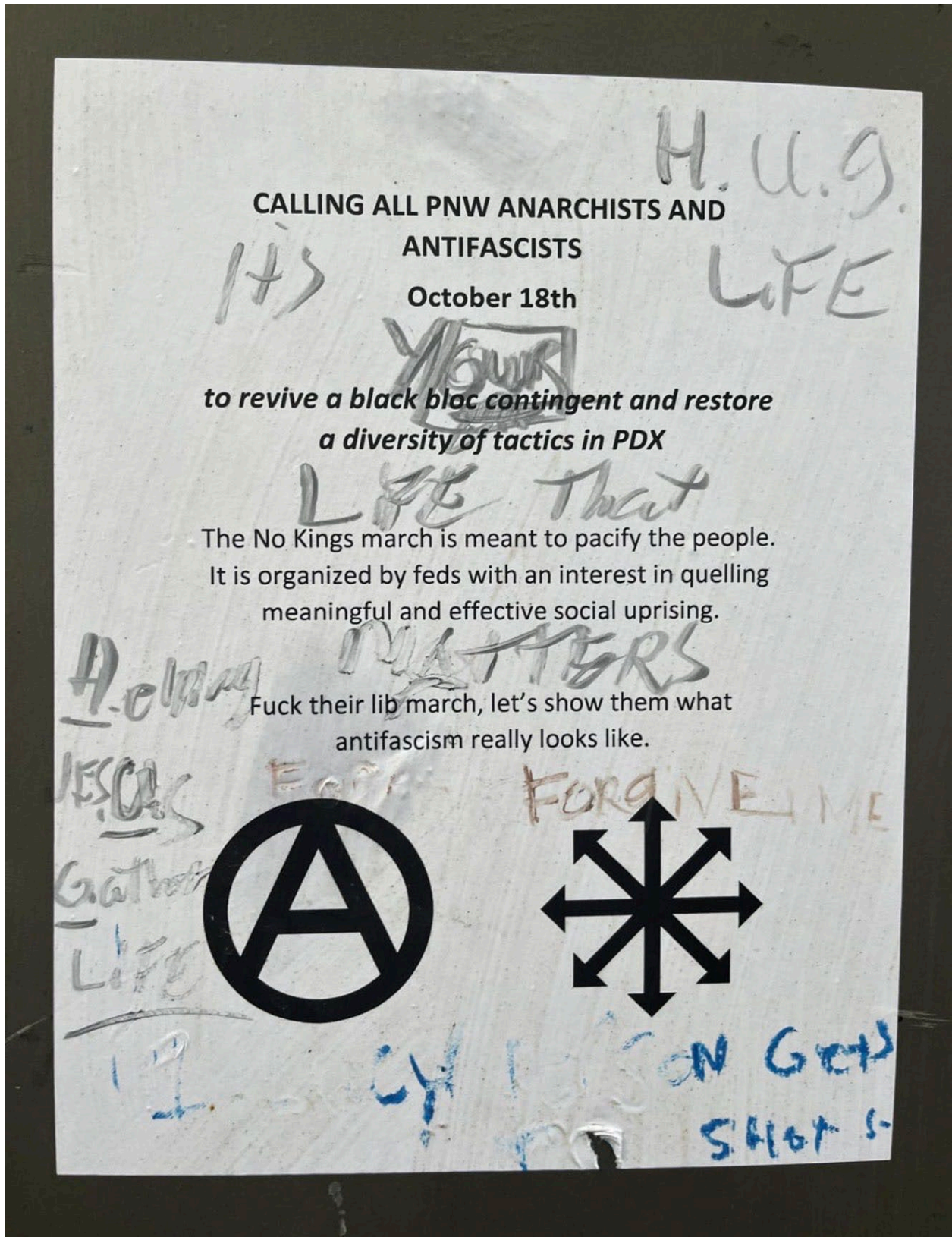

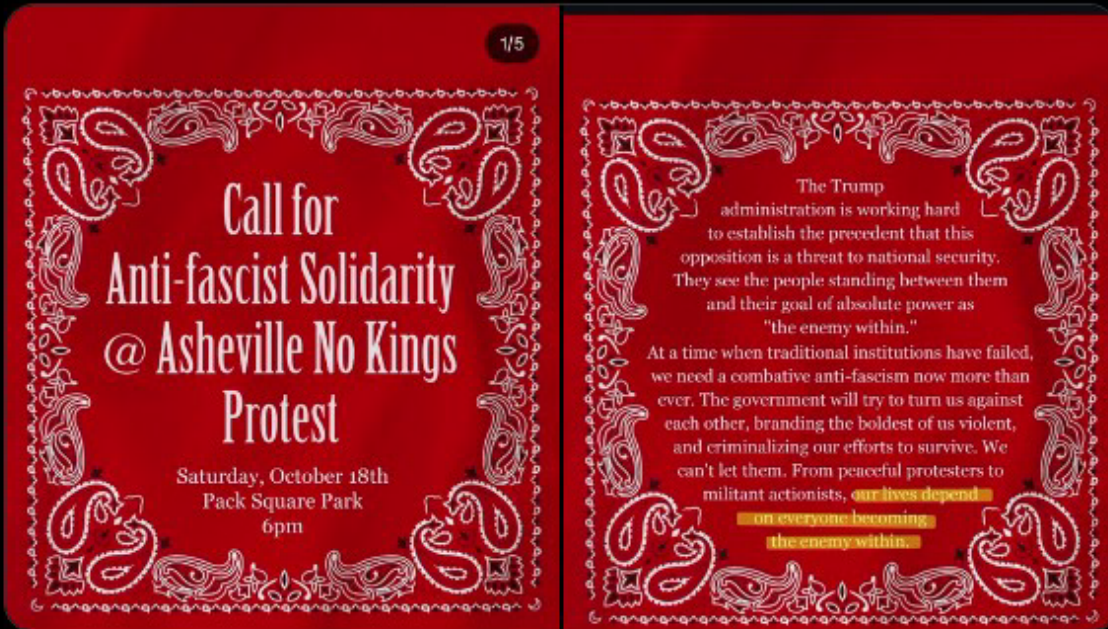

Color	When should it be used?	How may it be shared?
 TLP:RED For the eyes and ears of individual recipients only, no further disclosure.	Sources may use TLP:RED when information cannot be effectively acted upon without significant risk for the privacy, reputation, or operations of the organizations involved.	Recipients may therefore not share TLP:RED information with anyone else. In the context of a meeting, for example, TLP:RED information is limited to those present at the meeting.
 TLP:AMBER Limited disclosure, recipients can only spread this on a need-to-know basis within their organization and its clients. Note that TLP:AMBER+STRICT restricts sharing to the organization only.	Sources may use TLP:AMBER when information requires support to be effectively acted upon, yet carries risk to privacy, reputation, or operations if shared outside of the organizations involved.	Recipients may share TLP:AMBER information with members of their own organization and its clients, but only on a need-to-know basis to protect their organization and its clients and prevent further harm.
