SYNOPSIS

This is both an intelligence report and threat warning. Essentially high school students at two high schools, members of the Muslim Students Association chapters at each school recorded and posted videos to social media. In each video, recorded on school property, member students depicted what would happen to members who chose not to attend an upcoming chapter meeting (forced kidnapping, hood over the head). The school system has suspended the students and initiated their own investigation. Open source media includes no evidence of law enforcement engagement. What is troubling is the second school incident where the system immediately opened an internal investigation using a large law firm, which in action and effect any criminal investigation.

ANALYSIS

These are reportable terrorism threat indicators of intelligence value. These indicate the mindset, sentiment and atmospherics of the students involved, the cultural domain of the school system, proven over time, and the casual encouragement of what can be termed acting out what they learned. The rationalization of “kids being kids” does not apply here, this is a very serious indicator. This is Islam terror tactics, techniques and procedures. This also is how children are indoctrinated in terror nation states from infancy.

Fairfax County Public Schools, where the Muslim Student Association (MSA) chapters became prevalent across the school system, members of two high schools (Thomas Jefferson and Langley recorded videos (termed skits) promoting an upcoming MSA meeting. Muslim students are “kidnapped” by others when they say they don’t plan to attend. It is stated only students were involved in the videos, but still, there’s quite an investigative gap and a conflict of interest with the school taking the investigative advantage. As of this writing, no evidence in media or department communications that the county district attorney or police have intercepted.

The Council on American-Islamic Relations (CAIR), which immediately announced they are “representing” the students’ families, argues the reaction has been excessive and rooted in bias. CAIR leaders say the children were imitating a “kidnapping trend” popular on social media and not making a political statement, and that related videos by non-Muslim students have not faced the same backlash.

IN OBSCURA also notes Justice High School, with its own MSA chapter also-is known for a Abram Omeish, Muslim County supervisor’s graduation speech calling for the student’s personal jihad and condemned western capitalism during summer 2021. “...These videos depict violence, including kidnappings, with victims being hooded and placed in the trunk of a car, among other things...” was only one part of vitriol.

Historically in just open source reporting alone, Fairfax County has been a prevalent location of Islam and Jihad operational focus. There is no need to include sourcing on this statement, the facts are well known. What is not well known to the public or the residents is the threat environment and operational prevalence. That the local police acknowledges an investigation remains to be determined as well as why intelligence available to the nation's capital is not where it needs to be.

The school system stated the video was "traumatizing" to Jewish students and faculty due to "world events," likely referring to the Oct. 7, 2023, kidnapping of Israelis by Hamas. The MSA and with emphasis, Jihad portrays Islam as a "religion of peace" in the face of global hegemony by unhampered genocide. Christianity is a direct fluid target over several decades, essentially continuation of the Crusades.

At the June 2021 graduation speech to Justice High School student, and elected official, current Fairfax County Supervisor, Abrar Omeish was tasked with delivering the graduation keynote address for Justice High School in Fairfax County, Virginia, on June 7, where she made sure to tell the students that the world into which they were about to embark is an awful, awful place.

"Our world is overwhelmed with need. We struggle with human greed, racism, extreme versions of individualism and capitalism, white supremacy, growing wealth gaps, disease, climate crisis, extreme poverty amid luxury and waste right next door. And the list goes on," Omeish said, according to Fox News, which noted that **Omeish switched between English, Spanish, and Arabic during the address.**

Additionally evidencing the culture and human domain here, In November 2024, law enforcement search warrants on the home of George Mason University students, also members of the Students for Justice in Palestine at the university. At the home in Springfield, VA, they "...raided the family home of two Palestinian American students at George Mason University..."

Two of the Palestinian American family's daughters attend George Mason. One is an undergraduate student and the co-president of Mason's chapter of Students for Justice in Palestine. The other is in a master's program at Mason and a former president of the school's SJP chapter.

On the day of the search, Nov. 7, law enforcement officials removed "long guns" from the residence, sources say. A day later, Mohammad Chanaa voluntarily relinquished his 9mm handgun and concealed carry permit, [according to court records](#). He was not charged with a crime—Virginia's red flag law gives gun owners 14 days to petition a judge to return their firearms, and Mohammad Chanaa did so on Nov. 21. A Fairfax County circuit court judge [granted his request](#) as part of the civil case.

However, when officers entered the Chanaa family home, they found firearms—modern weapons, not antiques—as well as scores of ammunition and foreign passports, all of which sat in plain view, according to [court documents](#) obtained by the *Free Beacon* and sources familiar with the investigation. Also found were pro-terror materials, including Hamas and Hezbollah flags and signs that read "death to America" and "death to Jews," according to court documents and sources familiar.

Police seized the weapons under Virginia's red flag law, arguing that Mohammad Chanaa, the students' brother and a George Mason alumnus, was "linked to destruction of property in connection with a large group of people with like-minded rhetoric" and posed a danger to others given his possession of "terroristic" materials.

The MSA has spread awareness about Palestine by organizing a demonstration which was approved by Justice High School. They were joined by a few hundred students, both Muslim and non-Muslim. A video of the demonstration was posted on Instagram. Retal Mohammad, secretary of the club, described many of the responses as “hostile.” Despite this reaction from strangers, members of the MSA did not respond in kind. Club President Dania Eldirdiri says, “Instead of meeting hostility with hostility, we wanted to have a conversation. We took time to respond to comments with the message that Islam is a religion of peace.”

MSA seeks to bridge understanding across cultural divides by welcoming non-Muslim students to their events. Every Friday, the club hosts a prayer during the day called Jummah. Non-Muslim students who wish to learn more about other religions are invited to participate.

Suado Ali, faculty sponsor for the MSA, says, “I am so incredibly proud of all MSA leaders and members at Justice! As their sponsor, it has been a privilege to witness their growth, dedication, and leadership. They consistently go above and beyond, showing what true leadership looks like with their commitment to making a positive impact within our community. Their hard work, compassion, and determination inspire me daily.”


