## US v ZIMKO SALAH

### ANALYST COMMENT

Well before In Obscura became a thought, while my church's first Security Director, I did an analysis of extraordinarily complex neutralized attacks on four churches, over a three-state region. SALAH conducted target surveillance of four churches, probably more churches but undetected by staff. His tradecraft and motives brought forth pre-attack indicators found by investigation. He was arrested because of great police work and expanded steps after his traffic stop. A Texas Trooper detected his surveillance of her vehicle. In that vehicle a lot of evidence produced investigative leads. The case grew exponentially in a three-state region. In one church, he zip tied a backpack to a bathroom toilet, as a hoax bomb.



Zimnako Salah visited four churches in Arizona, California, and Colorado in late 2023, according to evidence presented at his trial earlier this year. Salah placed black backpacks inside two of the churches -- one in Sacramento, California, and another in Scottsdale, Arizona. Congregants and security personnel found the backpacks. The Scottsdale backpack was left among pews during a service by a masked man, per details in federal court documents. Police found clothing inside it.

***B. BRIEF OVERVIEW OF EVIDENCE***

10. There is probable cause to believe that on Sunday, November 12, 2023, SALAH committed a bomb hoax at a church located in the Eastern District of California. SALAH is an Arizona resident. Between September 24, 2023, and his arrest in San Diego County on November 28, 2023, SALAH visited at least four churches, one in Arizona, two in California, and one in Colorado. During each of the trips, SALAH visited only briefly and did not attend church services. Each time, SALAH carried a backpack. At two of the four churches, he placed a backpack in the church and immediately left. Specifically, at the Arizona church, he left the backpack in the sanctuary. In one of the California churches—the church located in the Eastern District of California—he tied the backpack to the toilet in the men’s restroom. Church employees at both churches treated the backpacks as potentially containing a bomb. As a result of the Eastern District of California bomb hoax, the church has increased security and incurred substantial additional security costs.

11. During his travels around the western United States, SALAH frequently changed license plates on his vehicle in what appears to be an attempt to avoid detection by law enforcement. On November 25 and again on November 28, SALAH was arrested with a loaded firearm under the driver’s seat of his vehicle. Additionally, prior to visiting the Colorado church, SALAH rented a storage unit located approximately fifteen minutes from that church. SALAH stayed overnight in the unit and stored component parts for a destructive device or a hoax device, such as a propane cannister with wires taped to it, and strips of duct tape lined with nails. As pictured and discussed in detail below, an antisemitic statement was scrawled on the wall of the storage unit in Kurdish along with a reference to the Prophet Muhammad.

***C. SALAH TRAVELS FROM ARIZONA AND TIES A BACKPACK TO A TOILET IN A ROSEVILLE, CALIFORNIA CHURCH***

12. Based on information from a law enforcement database, a green/yellow 2008 Toyota Prius (“Prius”) registered to ZIMNAKO SALAH (“SALAH”) was in the parking lot of a Christian church located in Roseville, California at approximately 8:32 a.m. on Saturday,

1 November 11, 2023. According to the law enforcement database, the Prius began to back out of  
2 a stall at the church parking lot at approximately 8:49 a.m.

3 13. Law enforcement databases also indicate that the Prius traveled in Roseville,  
4 California and neighboring Rocklin, California at several times between the hours of 2:23 a.m.  
5 and 11:15 a.m. on November 11, 2023.

6 14. Based on my review of local police department reports, security camera footage  
7 from the aforementioned Christian church located in Roseville, California, and information  
8 provided by members of the church and church staff, I know that on Sunday, November 12,  
9 2023, at approximately 9:40 a.m., an individual later identified as SALAH approached a side  
10 entrance of the church, poked his head through the door, and then entered the church from that  
11 side entrance with a backpack. Once inside, he looked behind himself and then walked directly  
12 to the men's bathroom. He was in the bathroom for approximately 35-40 seconds and exited the  
13 bathroom without the backpack. He immediately left the church through the same side entrance.  
14 At one point as he was leaving the church, he jogged. SALAH arrived during the 9:00 a.m.  
15 service, so there were no witnesses to his activity in the lobby. He was, however, captured on  
16 the church's security footage. He was wearing a hat while in the church. The church did not  
17 have security cameras in its parking lot, so no additional footage was captured of SALAH in the  
18 church parking lot. The local police department obtained footage at a nearby intersection of the  
19 Prius with an Arizona license plate registered to SALAH at approximately 9:36 a.m., 9:45 a.m.,  
20 9:48 a.m., and 9:49 a.m. on November 12, 2023, which is immediately before and shortly after  
21 the incident at the church in Roseville.

22 15. According to church members and church staff, when church staff became aware  
23 of the backpack, they photographed it and called the local police department. Police officers  
24 arrived at approximately 1:20 p.m. In the interim, a church staff member removed the backpack,  
25 opened it, and located a pillow inside.

26 16. The photograph that the church staff took is below. As the photograph depicts, it  
27 was tied to the toilet.

"If somebody is not able to control their impulses and they reach that point, I don't think it really matters who the victim is at the time. If it got them to that level of anger, they're going to lash out at whoever – it just happened to be his grandmother," he said.



Any Berkeley undergraduate who has made it through an expository writing class or engaged with an American history

course could easily make chopped garbage out of Kirk's bigoted stupidities.

And anyone can find online numerous statements by Kirk and his followers which expose the vile character of his real message and influence. A few examples of Kirk's and Turning Point's typical rhetoric should make clear that Turning Point's actual method for our university community is not about "free speech" or "freedom of debate." **It is about the intimidation of free speech—especially in an academic setting. It is about bringing an end to free debate.** Its real aim is to popularize and normalize the violent method of the 6 January 2021 mob attack on democratic government at the Capitol in Washington, DC and to cultivate submission to the police-state regime Trump is spreading across the country. Turning Point wants to start recruiting—now—some young thugs for Trump's inevitable attempt at military occupation of the Bay Area—including in particular our campus, with its rich traditions of free speech and intellectual debate.

Berkeley students, teachers, and the entire Berkeley community can and must make sure Turning Point fails in its mission—Charlie Kirk's mission—of crushing intellectual freedom and ending the possibility of open dissent and protest of Trump's neofascist program for America.

The real Charlie Kirk was a fascist white nationalist and misogynist who promoted fascist propaganda to recruit youth in
