EXECUTIVE SUMMARY

It is In Obscura assessment that this is a terror attack. Period.

This report analyzes the targeting and attack on a church by insurgents during their operations in Minneapolis and its metropolitan areas. The church was chosen specifically because intelligence revealed Pastor, by name is the current acting Director of the ICE ERO Field Office in Minneapolis. Local Police responded but Homeland Security Investigations and Minneapolis FBI assumed primary jurisdiction. The Case Agent filed a Criminal Complaint and an Affidavit for Arrest and Search Warrants, but the US Magistrate Judge refused to approve them and added a pen and ink annotation of no probable cause.

In Obscura reporting has clearly corroborated the direct nexus of foreign intelligence services as the control elements supporting, training, tasking, and recovering proxy operators in the growing guerilla and irregular war on our streets. The comments during the recording by the insurgents during the attack stated more of these church attacks would come. In Obscura collection of elected officials demanding more church attacks are attached below.

Obscura review of the redacted District Court Criminal Complaint established using insurgent recorded operational discussions with the former CNN reporter (Redacted) during last minute planning and movement to the target that this was a clandestine operation and known as Operation Pullup and constant reminders by the leader defendant to maintain OPSEC, knowing they were being recorded by that former CNN recorder.

Recent media coverage by an investigative journalist (redacted) on Twitter (X) has identified intelligence collection, tradecraft and operational communication by these insurgent groups using the Signal platform. It is assured that nationwide, the operations are massive and covert.

Anarchist groups are in direct support and direct support reinforcing alignment under “mutual aid.” This means every Communist-Islamist group operates as one axis power. Accordingly, Christians across the US, Europe, the Islamic Maghreb, Sahel, and Levant and now deeper into Africa are under direct, sustained, genocide.

Curiously, but not at all surprisingly, my efforts before and after In Obscura was founded, have received no traction, cooperation, or interest. Direct involvement with clergy, local police, state, and federal agencies all in positions to help, all in possession of threat intelligence well beyond unclassified have refused to engage. NGO, self-touted faith-based security organizations from which I terminated membership have yet to confront and neutralize these threats. News media alone chronicles the attacks and bloodletting. Churches remain soft-targets, duly exploited, and attacked. The scandalous target surveillance and intelligence collection against churches and related support operations concurrent with the silence has not escaped the attention of Almighty God.

These forces are known as the Red-Green Alliance for decades, also active across Europe. In prior reporting, In Obscura intelligence collection and analysis has consistently reveals targeting Christians is part of the focused Insurgency to collapse the US Government.

THE ATTACK ON CITIES CHURCH

Complex direct-action attack by strong arm entry into the unsecured sanctuary, during the worship service at Cities Church, located at 1524 Summit Ave, St. Paul, MN 55105, <https://www.citieschurch.com>. The attack team of what appears to be 30-40 members of the Racial Justice Network, Black Panthers Minnesota, and Twin Cities Metro. Upon entry this team physically surrounded the congregation which were seated in the pews and confronted the pastors.

They directly threatened the church, congregation and pastors with statements such as “...time for judgment...and it will begin in the house of (G)od...this will not stand, they cannot pretend to be a house of God, while harboring someone who is commanding ICE agents to terrorize our communities...Hands up, don’t shoot...ICE out.”

Fired CNN anchor Don Lemon who live streamed the attack. Lemon claimed that he was just a “journalist” and not an activist, however many are questioning how Lemon knew the anti-ICE agitators were going to storm that specific church at that exact time.

Lemon travelled there and joined the team at least 24 hours prior, as pre-attack briefing and the next day was part of this attack, including a confrontation with the officiating pastor. Protestors could be heard chanting, “Hands up, don’t shoot” and “ICE out” throughout the video.

According to Lemon, the protestors interrupted the opening prayer of the Sunday worship service. The protestors were alleging one of the church’s pastors was a member of Immigration and Customs Enforcement (ICE) within the Department of Homeland Security, Lemon said in that video. Fired CNN anchor Don Lemon live streamed the incident with critics accusing Lemon of issuing threats to ICE supporters, **Christians, and churches about what’s to come: “This is the beginning of what’s going to happen here,”**

The team deliberately invoked fear and provoking speech and gestures, causing the congregation to evacuate and the attack continued outside where two were injured. They specifically threatened a church pastor by name whom they knew was a federal officer, Director (Acting), Minneapolis Field Office Enforcement and Removal Office, DHS Immigration and Customs Enforcement. Local media claims to have confirmed this. Despite local, national, and international media coverage, there is no information concerning the police response, arrests, detentions. There is no record of a police press conference.

Below contains substantive video and imagery evidence discovered on social and news media sources. In one video Lemon who travelled to the city, met with the attack team and leaders the previous day. His statements made it very clear there was target intelligence collection, and at one point on the video the news anchor cautioned the plans are secret, then the video stopped during a portion of this meeting indicating that the discussion was “classified.” Post attack scenario details seem lacking, although later some of the victims were interviewed by news media. She claimed to be and ordained reverend and dismissed the possibility of an investigation by the U.S. Department of Justice as a distraction from immigration enforcement efforts in Minneapolis-St. Paul. "When you think about the federal government unleashing barbaric ICE agents upon our community and all the harm that they have caused, to have someone serving as a pastor who oversees these ICE agents is almost unfathomable to me," Armstrong said.

While inside the target she stated "...When you think about the federal government unleashing barbaric ICE agents upon our community and all the harm that they have caused, to have someone serving as a pastor who oversees these ICE agents is almost unfathomable to me. If people are more concerned about someone coming to a church on a Sunday and disrupting business as usual than they are about the atrocities that we are experiencing in our community, then they need to check their theology and the need to check their hearts," she added.

In this video statements made it very clear there was target intelligence collection, and at one point on the video the news anchor cautioned the plans are secret, then the video stopped during a portion of this meeting indicating that the discussion was "classified." Post attack scenario details seem lacking, although later some of the victims were interviewed by news media.

The Criminal Complaint established probable cause to charge the insurgent, strangely with civil rights violations. The congregation was not free to leave, surrounded at one point, and parents were physically blocked by the insurgents from removing their children from the childcare center and escaping from inside the church. The children while inside were

assaulted by confrontation from the insurgents placing them in fear. These are terrorist tactics in totality, context, and content.

Statements made quoted by the insurgents per criminal complaint are:

“...But this is the beginning of what’s going to happen here.” When you violate people’s due process, when you pull people off the street and start dragging them and hurting them and, um, and not abiding by the constitution, when you start doing all of that, people get upset and angry.” goes on to suggest that according to the Constitution, there are no limitations to protesters on where and when they can exercise their Constitutional rights. That’s the whole point of it is to disrupt, and that’s what they’re doing and that’s what I believe...” and

“...I told [inaudible] that Victim 1 is a pastor here and he also serves as a Director of the Field Office for ICE in St. Paul. asked, “Are you sure that he’s...?”

ARMSTRONG answered, “Yes, Cities Church, and that’s why we’re here. We’re demanding justice for Renee Good and letting them know that this will not stand. They cannot pretend to be a house of God while harboring someone who is directing ICE agents to wreak havoc upon our community and who killed Renee Good, who almost killed a six-month-old baby. Enough is enough. I am a reverend, on top of being a lawyer and an activist...”

KEY JUDGMENTS

In coordinated effort over the last several months, is the wanton and deliberate public statements by US elected officials (state, local, federal) supporting, defending, and launching insurgent activities. Note this same exploitation at the Roe v. Wade SCOTUS reversal and the felony espionage leak of the documents on the timeline of the bombings and arsons at a minimum targeting everything Christian.

Despite this growing insurgency, and increasing target intelligence collection by insurgent cells, Christianity remains a very vulnerable soft target across the United States. Christians, Churches, Clergy have been targets increasingly since the Summer of Rage, the anarchist mobilization upon the reversal of Roe v Wade. That effort included bombings and arsons of churches, and pro-life centers across the nation. Closely aligned under the

anarchist mutual aid axis, the Summer of Love saw insurgent activity based on black anarchist violence, nationwide and officer involved shooting in Minneapolis.

The tactical, strategic, and operational optic and intelligence mission of In Obscura as stated and with this analysis yet again focuses on the direct targeting and collateral attack damage to Christian equity. Proving the very existence of intelligence collection and target surveillance of churches predicts these are targets and will be attacked. The terror attack the subject of this report has been termed a “protest,” despite active and layered anarchist intelligence collection and targeting of federal agents, the families, and homes. Do not be deceived, these are insurgent warfare tactics and terrorism by action and definition. The acting deputy director of ICE was identified by enemy intelligence and the church was targeted.

Churches, Christians are symbols of a particular ideology, a set of values, historical ties, political ties, racial connections, or a culture. Extremists may target a house of worship or other religious organization in response to those symbols, viewing them as a physical representation of what they see as a wider enemy population, according to the Tony Blair Institute for Global Change.

Sixty-seven percent of targeted violence incidents against U.S. faith-based institutions between 2009 and 2019 were motivated by hatred of a particular religious, racial, or national identity, CISA reports. This notably differs from targeted or mass violence overall in the United States. A U.S. Secret Service study of five years of mass attack incidents found that half were sparked by personal or workplace disputes or grievances; only 18 percent of the attacks were strongly influenced by extreme or hate-based beliefs.

KEY TAKEAWAYS

- Deliberate, incendiary verbal and social media statements by elected officials at the state, federal and local levels, have rewarded the attack of this church and added that more churches be attacked.
- There have been no disclosures that Cities Church has a security team. It is not clear why, during an insurgency attack and the region already notorious for guerilla warfare, the church had no defense in depth. Interestingly and should have been expectantly

during the current attacks, the church took no known countermeasures, knowing full well a Pastor is a federal supervisory special agent, AND insurgents nationwide are collecting intelligence on agents and families and not afraid of arrest or consequence. As should have been expected, that Pastor was the target. In Obscura experiences over the last five years indicates this is the conscious choice of most churches.

- Federal, state, and local law enforcement fusions centers MUST immediately engage these threats to churches. Close distance with churches, initiate contact and conduct initial liaison with organic security staffs. Increase training, surveillance and suspicious and anomalous activity recognition reporting and neutralization.
- The current practice of competing for federal and state grants to increase security protections is far too reactive and ineffective. Agencies MUST start allocating funds to transform security countermeasures to meet and exceed the terror and general crime threats
- Security staff MUST be state law enforcement trained and certified as armed, commissioned security officers. Expecting the unexpected and security must be proactive and prepared to defend churches, congregations, related facilities. Churches are soft targets which have already been visited and assessed as targets.
- Regional Church Security Threat Working Groups. Build relationships to share information, suspicious and anomalous activity. Mutual, competent training, including those state agencies. Threat briefings and training, to name a few. Local police are mandatory to facilitate these groups and receive lead information.
- The Christian church does NOT have a proponent agency like the Jewish Federation of North America's Secure Communities Network. This alone leaves churches exceptionally vulnerable. This must end. In Obscura efforts, locally were met with silence, rejection, complacency by church security staffs and government agencies posed to help increase security countermeasures but silently refused by inaction.
- One Pastor, identified by his X post below, has already made a public statement of preparing for Martyrdom. It is the mission, vision and biblical standing to object and





But Christian, you need to know your Bible well enough to be able to expose counterfeits like Talarico. This is where the battleground is now.


