A complicated crime scene and uncooperative witnesses hindered Salt Lake City police efforts to investigate a shooting outside funeral services at a Church of Jesus Christ of Latter-day Saints house of worship. Two people dead and six injured, including five who remained hospitalized with police protection.

Thursday. Investigators say the shooting erupted from a dispute between people who knew each other and were attending a funeral. No arrests had been made as of mid-day Thursday, a day after the gunfire. The Church of Jesus Christ of Latter-day Saints is widely known as the Mormon church. Authorities say they do not know whether the shooting was gang-related and that they are having trouble getting witnesses to cooperate.





BREAKING: An independently owned Marriott hotel in Bloomington, MN confirms to @FoxNews they have ID'd & fired an employee who doxxed ICE agents by leaking their names, emails, and surveillance images of them as they checked in at the front desk. The images appeared in an anti-ICE Reddit post that went up last night. I took screenshots of the posts before they were deleted, and I have blurred the names, emails, and faces of the ICE agents. The hotel in question was the Residence Inn in Bloomington. The photos appeared to be from the perspective of an employee at the front desk, were posted to an "ICE WATCH MN" thread, and had the captions "ICE staying at Residence Inn in Bloomington by MOA" & "Three males & three females staying at this hotel. Company email and some of their names."

I reached out to Marriott last night for comment, and they referred me to the independent ownership, CSM Lodging. In a statement to FOX, CSM Lodging confirms they identified and fired the employee.

CSM Lodging statement to FOX:

"The privacy and safety of our guests is of the utmost importance to us. Upon learning of this situation last evening, we immediately investigated the matter and identified the person responsible for capturing the images in the post. This individual is not longer an employee of our organization."





In social media accounts, Macklin Good described herself as a "poet and writer and wife and mom." She said she was currently "experiencing Minneapolis," displaying a pride flag emoji on her Instagram account. A profile picture posted to Pinterest shows her smiling and holding a young child against her cheek, along with posts about tattoos, hairstyles and home decorating.

INBOX: “Revolutionary Communists of America” handed out these pamphlets on how to organize a “class struggle” resistance against the “Capitalist ICE.”

They describe recruiting union members to organize a “militant defense” to drive ICE out, deliver justice to Renee, and criticize Walz and Frey for not coming down hard enough on ICE.

The pamphlet contains the following text:

Trump is using Senolts—and immigrant workers in general—as scapegoats, attempting to pit workers against each other. The capitalist state persecutes and terrorizes immigrant workers in order to drive down wages and conditions for everyone. These are the class-war methods of our enemy. We must respond with class struggle methods of our own.

FIGHT ICE WITH CLASS STRUGGLE

Immigrants are not responsible for the crisis we face today. It is the capitalists and their failing system that are to blame. Workers must meet ICE terror with militant class defense, and the struggle against ICE must be a struggle against the system as a whole.

An injury to one is an injury to all, and the labor movement has a responsibility to lead this fight. The existing union leadership is well positioned to do so. Over 300,000 workers in Minnesota are organized in the AFL-CIO, including the 80,000-strong Minneapolis Regional Labor Federation. The union leaders support immigrant workers in words, but so far, they have failed to take decisive action, like pickets, strikes, and mass protests against ICE.

The unions in Minneapolis should mobilize workers in a drive to organize the unorganized and establish workers self-defense committees in every neighborhood and workplace targeted by ICE. These self-defense committees could coordinate an assembly to elect a citywide leadership and coordinate the struggle to drive ICE out of Minneapolis entirely.

And we shouldn't stop there. Similar committees should be organized in every major city in the country to put an end to ICE terror and the capitalist system that creates it.

TRADITION OF STRUGGLE

Minneapolis has a rich history of class struggle and these methods have been successfully deployed here before. During the 1934 Minneapolis Teamsters strike, 47 people were shot by police at a picket line on “Bloody Friday,” July 28. Many were bystanders and a majority of those injured were shot in the back. Two workers were killed: Henry Ness and John Holter.

In response, Teamsters Local 574 linked up with unions across the city to coordinate a one-day strike of the transport workers. This included taxi drivers who refused to transport National Guardsmen mobilized to break the strike, the July 28, roughly 40,000 people—1/3 of the city's population—attended Henry Ness's funeral in the words of Patrick Dobbs, one of the strike's leaders and a member of the Communist League of America, “There was not a cry in sight as the grim thousands gathered.” The police were fleeing, powerless in the face of a coordinated working class.

The lessons of the 1934 strike are clear: The capitalist class and their state are highly organized. Workers need our own organization to meet their forces with our force. The leadership of the Communist League of America was essential to our force. The leadership of the Revolutionary Communists of America are the Teamsters' victory in 1934. The Revolutionary Communists of America are building the same type of party today, in connection with our comrades all over the world in the Revolutionary Communist International.

NO TRUST IN DEMOCRATS OR THE COURTS

Since the shooting, Mayor Jacob Frey and Governor Tim Walz have called for the removal of ICE, but their words are empty. Neither Democrat has done anything to protect immigrant workers. If anything, they've given credence to Trump's racist accusations against Senolts.

Both Democratic and Republican administrations have attacked immigrant workers. Nearly 4.4 million immigrants were deported under the Biden-Harris regime. The difference between Trump and the Democrats is that Democrats want to deport immigrants as quietly as possible, while Trump wants dramatic scenes to distract from his failures and try to shore up his fracturing MAGA base.

Frey has counseled Minneapolis to meet ICE's “hate with a whole lot of love.” Both Frey and Walz have called for “peace and calm.” ICE murdered Renee Good less than a mile from where police killed Floyd nearly six years ago, and Minnesota has not forgotten that Walz deployed the National Guard during the George Floyd uprising in 2020. Now he has mobilized the National Guard once again, and has it ready to deploy against anti-ICE protests.

Neither can we rely on the courts to deliver justice for Renee Good and end ICE terror. The courts ultimately maintain the exploitative relationship between workers and capitalists. We need to look no further than the ruling on Derek Chauvin—the cop who murdered Floyd. He was convicted and imprisoned, but racist police violence continues to smelt havoc in neighborhoods across the country. Safety and justice can only be guaranteed by the organized and mobilized working class.
