Pastor Paul Chappell, senior pastor of Lancaster Baptist Church, echoed that sentiment, seeing the disruption as both a violation of religious freedom and an act of "spiritual warfare." "The book of Hebrews commands Christians to gather and assemble," he said, citing Hebrews 10:25. "As I saw protesters wearing profanity on their shirts and hats, I realized that this was also, as Ephesians 6 describes, a matter of spiritual warfare. We have an adversary who seeks to discourage people from obeying God's commands." The Christian leaders are calling for federal action, saying the agitators' actions were a clear violation of the FACE Act.

One anti-ICE agitator who yelled at children and families during a worship service Sunday in St. Paul, Minnesota has also harassed congregants at Secretary of War Pete Hegseth's church in Washington, D.C. William Kelly, who shares videos of himself clashing with law enforcement on social media under the "dawokefarmer," was among the left-wing mob that disrupted service at Cities Church in St. Paul.

Earlier videos show Kelly outside Christ Church DC, the Capitol Hill church where Hegseth attends service, calling congregants "fucking nazis" and "spineless little bitches." In another video, Kelly screams "traitor" at Hegseth, telling him "you're going to learn how to do a pull up in prison." "I've been waiting for this for a long time," Kelly [told](#) podcaster Jesse Dollemore in a Dec. 9 video. "I go to his church almost every Sunday, and I miss him every time. So this was a long time coming."

While the world slept, a free South Korea is being torn apart by pro-China leftists. Britain has always claimed to be a land of faith and freedom--but those words ring hollow in Whitechapel. A planned "Walk With Jesus" march has been banned, not because it is illegal or violent, but because authorities fear it might offend others. Peaceful Christians are now being told they cannot proclaim their faith in public without risking arrest. This is more than a local police decision; it is a warning about the direction of an entire nation.

The Metropolitan Police's decision to halt the event, scheduled for January 31, centers on Whitechapel's large Muslim population. Organizers promoted the procession as a Christian worship event during what they called "the month dedicated to the holy name of Jesus." Yet, authorities deemed marching there "reckless," citing intelligence suggesting a hostile reaction that could lead to disorder. The march can proceed elsewhere--but not in the neighborhood chosen by the faithful.

Muslims, who initially entered the United Kingdom largely as impoverished refugees seeking humanitarian assistance, have undergone a notable transformation in their social and political presence.

On an almost daily basis, reports, videos, and images now circulate depicting Muslims harassing, intimidating, and even terrorizing native Britons. (See the video version of this article for numerous examples.) One illustrative example emerged on October 25, when a video surfaced showing large numbers of Muslim men—masked and uniformly dressed in black—marching through London. The visual symbolism bore a striking resemblance to that commonly associated with ISIS and appeared intended as an expression of ideological solidarity.
