Allen's sister told the Secret Service and Montgomery County Police in an interview after the attack that her brother had allegedly made radical statements and would often refer to a plan to do "something" about the current state of the world. She also alleged to investigators that Allen would regularly go to a shooting range to train. She claimed that her sibling had purchased two handguns and a shotgun and he stored the weapons at their parents' home, though they were unaware of such. (One of the weapons is believed to have been used in the April 25 shooting, law enforcement officials told CBS News.)

Allen's sister further claimed, per White House officials, that Allen was part of a group called "The Wide Awakes," and he attended a "No Kings" protest against Trump in California. The White House official also alleged in their statement to PEOPLE that Allen "had a ton of anti-Trump and anti-Christian rhetoric on his social media accounts."

“The SPLC is manufacturing racism to justify its existence,” said Acting Attorney General Todd Blanche. “Using donor money to allegedly profit off Klansmen cannot go unchecked. spectrum of the political left” and that “far-right extremists use similar tactics” to the Trump administration in condemning Antifa.

According to local law enforcement sources, Mafi’s arrest is not just the tip of the iceberg within one of the largest Iranian diaspora communities in the world, but also a direct consequence of law enforcement failures. Local law enforcement has consistently raised concerns over Iran-linked operatives through the Los Angeles Joint Regional Intelligence Center and Orange County Intelligence Assessment Center, but federal authorities often do not make these concerns a top priority.

Yet Mafi was known to both local and federal authorities, and her quiet arrest illustrates that federal officers had flagged her and were prepared. Media outlets noted her statements to immigration and federal agents, claiming that “her work was focused on arranging shipments of medical aid to African countries through the Gulf,” but this now appears to have been part of her cover.

Mafi’s arrest comes a month after the United States listed Sudan’s Muslim Brotherhood wing as a Specially Designated Global Terrorist and Foreign Terrorist Organization, as well as the Trump administration’s clampdown on Iran’s activity worldwide.

“He came behind me and put his arm on my shoulder, just leaned over, saying ‘amen, amen,’” Cato said. “At that point, our minister’s security just ushered him off the stage, and I just kept preaching.”

No injuries were reported inside the church, but some congregants said they were shaken by the encounter. Prince George’s County Council member [Wanika Fisher](#), who was attending the service, said the situation caused alarm. “I think everyone’s blood pressure went up because people know about church shootings,” Fisher said. “You don’t know what the person’s having if he had the mind to kill church members. He was on the altar, above everyone, and the congregation was sitting ducks.”

According to court documents, Koroma’s behavior escalated after he left the church. He is accused of carjacking a vehicle with a person still inside. The victim jumped from the moving car to escape shortly before Koroma allegedly crashed into another vehicle. Koroma was ordered held without bond on the carjacking charge.

Court records show Koroma, a 32-year-old Air Force veteran, has been arrested several times this year. During a bond review hearing, a judge said he suspects the man may be dealing with mental health issues. Cato said he hopes Koroma receives help.

Two broad motivating factors have been suggested to explain this increase in arsons. The first of these relates to a series of announcements regarding potential unmarked burials at some former residential schools (the network of boarding schools for Indigenous children instituted by the Canadian state and mostly administered for over a century by Christian institutions) starting in May 2021. The second possibility is that the arsons reflect anti-Christian or anti-religious sentiment growing in the country.

As of the time of writing of the report, no groups or individuals have claimed responsibility with respect to any organized arson campaign, and less than 4 per cent of the arson incidents over the 2021–23 period have resulted in charges. So, the identities and motivations of the arsonists responsible for more than 96 per cent of arsons remain unknown.

### **Woman Busted As Blaze Tears Through Southeast OKC Church**

An early Sunday fire tore through a southeast Oklahoma City church, ending with a woman in custody on a complaint of first-degree arson, officials said. Fire crews were dispatched to the 200 block of S.E. 45th Street and reported seeing a large plume of smoke as they approached. When they arrived, firefighters found smoke coming from the basement and upper floors. The blaze caused an estimated \$8,000 in damage, and no injuries were reported.

#### *Not The First Southeast-Side Church Blaze This Year*

The arrest comes against a backdrop of earlier reports of church fires and vandalism on the southeast side of the city. As reported in a February incident, investigators previously examined a case in which a teen was eyed in a string of arsons and graffiti affecting a neighborhood congregation. Authorities have not said whether those earlier cases are connected to the fire at New Dimensions Ministries.

Recipients may therefore not share TLP:RED information with anyone else. In the context of a meeting, for example, TLP:RED information is limited to those present at the meeting.
 <p><b>TLP:AMBER</b></p> <p>Limited disclosure, recipients can only spread this on a need-to-know basis within their organization and its clients. Note that <b>TLP:AMBER+STRICT</b> restricts sharing to the organization only.</p>	Sources may use TLP:AMBER when information requires support to be effectively acted upon, yet carries risk to privacy, reputation, or operations if shared outside of the organizations involved.	Recipients may share TLP:AMBER information with members of their own organization and its clients, but only on a need-to-know basis to protect their organization and its clients and prevent further harm. Note: if the source wants to restrict sharing to the organization only, they must specify TLP:AMBER+STRICT.
 <p><b>TLP:GREEN</b></p> <p>Limited disclosure, recipients can spread this within their community.</p>	Sources may use TLP:GREEN when information is useful to increase awareness within their wider community.	Recipients may share TLP:GREEN information with peers and partner organizations within their community, but not via publicly accessible channels. TLP:GREEN information may not be shared outside of the community. Note: when “community” is not defined, assume the cybersecurity/defense community.
 <p><b>TLP: CLEAR</b></p> <p>Recipients can spread this to the world, there is no limit on disclosure.</p>	Sources may use TLP:CLEAR when information carries minimal or no foreseeable risk of misuse, in accordance with applicable rules and procedures for public release.	Subject to standard copyright rules, TLP:CLEAR information may be shared without restriction.
