Large Public Gatherings Attractive Targets for Violent Extremists

SCOPE: This product is intended to help public safety officials and private sector partners plan and respond to terrorism threats against mass gatherings that are not contained within a secured perimeter. Gatherings that are not official events or tournaments and where tickets are not required for attending are particularly vulnerable. This product is a resource for public safety officials and is not in response to a specific threat against the homeland. It provides background based on previous terrorist plotting and attacks and general terrorist attack tactics, techniques, and procedures (TTPs). The considerations in this product are not exhaustive.

Violent extremists remain interested in attacking large public gatherings such as sporting events, music venues, high-profile special events, or symbolic locations. Attackers may have unrestricted access to public gatherings that occur or extend beyond a secured perimeter, including sporting event fan zones, special event watch parties, or mass gatherings before or after an event. Terrorist media regularly advocates for attackers to use vehicles, edged weapons, and firearms against easily accessible targets where large crowds are gathered. Information about common attack methods and event vulnerabilities of large public gatherings can help the coordinators and security planners prevent, mitigate, or respond to threats or crises at these types of events.

- In March 2025, a HAMAS spokesperson issued a global call to arms for supporters to violently resist the United States' proposed plan for Gaza, with the HAMAS spokesperson urging supporters to use whatever means available to resist the US proposal.
- In January, an ISIS-Khorasan flyer highlighted a list of cultural events and festivals in Europe and the United States as targets because they were expected to draw large crowds. In May 2024, a pro-ISIS outlet published at least one graphic suggesting that an attack against a specific Cricket World Cup match in New York would draw international media attention.
- On New Year's Day 2025, a now-deceased ISIS-inspired US citizen drove a rented truck through a crowded street in New Orleans during early morning celebrations, killing 14 and injuring more than 50 individuals.
- In August 2024, authorities disrupted a plot by two teenage ISIS supporters who planned to drive an explosives-filled car into crowds outside a concert venue in Austria. Between 20,000 to 30,000 fans were expected to gather outside the stadium during the concert, a location that would probably not have had sufficient security checks and safety mechanisms to prevent such an attack.

ANALYST COMMENT

Many mass gatherings within the target set of Christians, Churches and related facilities and gatherings are now historic. Clergy and church security teams must engage and initiate liaison with local, state and federal agencies within your areas of operations to be proactive and yes, innovative to establish a partnership to stay ahead of this now, demonstrated threat. 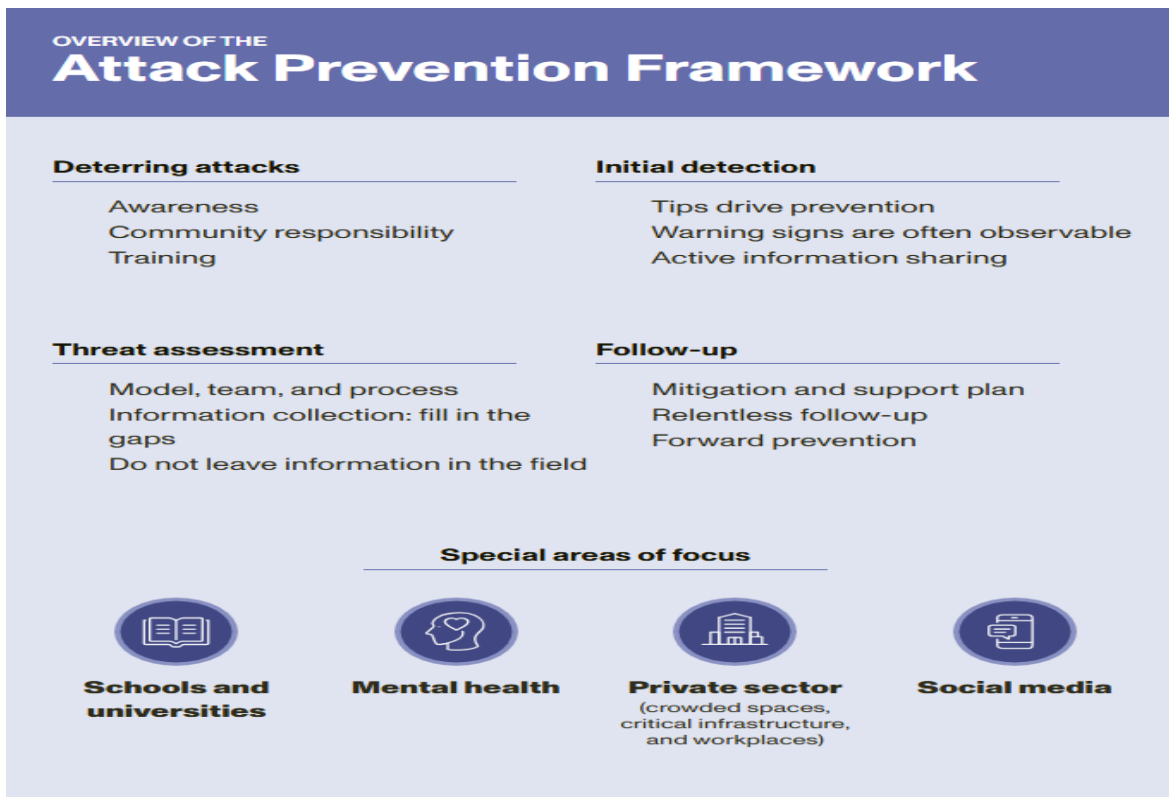

At the center of the May Day mobilization, which has expanded from earlier indications, is a network of communist, socialist, Marxist and other far-left organizations, led by chapters of the [Democratic Socialists of America](#) and a network of groups – including the People’s Forum, the Party for [Socialism](#) and Liberation, ANSWER Coalition and Code Pink – funded by an American-born tech tycoon, Neville Roy Singham, based in Shanghai, promoting the propaganda of the Chinese Communist Party.

The Communist Party of the USA has [rallied](#) workers to "rise against MAGA on May Day," promoting [leaflets](#) by the "People’s World," its Marxist-Leninist publication. The Revolutionary Communist Party has [put out a call](#) to dismantle the "[capitalist-imperialist system](#)." The Maoist Communist Union [has](#) summoned members to join the "Anti-Imperialist Contingent" at the New York City protests.

The deeper concern, critics say, is that the pro-communist and pro-socialist network, symbolized by the color of red, is promoting May Day events with traditionally blue organizations that make up the Democratic Party network, including nonprofits Indivisible, [MoveOn.org](#) and the American Federation of [Teachers](#), as well as at least 13 state and local chapters of the Democratic National Committee, including the California Democratic Party.

DISO is a Los Angeles-based graffiti group whose work has largely focused on pro-Palestinian and anti-Israel messaging. Graffiti in support of Iran's theocracy has appeared in one of the most prominent Iranian-American neighborhoods in the United States, prompting concern among some residents about intimidation and the spillover of political tensions into diaspora communities. One of the markings found in the area bore the name "DISO," a Los Angeles-based graffiti group whose work has largely focused on pro-Palestinian and anti-Israel messaging.

The group's Instagram page includes several posts opposing the US-Israeli war on Iran and expressing support for the Islamic Republic. It has also openly criticized prominent opposition leader and exiled prince, Reza Pahlavi.

The DISO marking was found on a billboard structure along the northbound side of Westwood Boulevard, just north of Missouri Avenue. The graffiti appeared alongside color patterns resembling the flag of the Islamic Republic.

In a separate incident, "Stop War" was spray-painted over photographs of slain Iranian protesters displayed on a nearby memorial wall. There is no evidence that the vandalism of the memorial wall was carried out by DISO.

Christians call for protection of pastors in Colombia after murders, kidnappings

A new campaign has been launched aimed at restoring special protection to religious leaders in Colombia, following a series of killings and kidnappings by armed groups. The campaign zeroes in on Decrees 1066 and the National Protection System (NPS). In 2023, the government removed religious leaders from the list of people considered particularly vulnerable to attack, meaning they no longer have access to special security and protection programs. Christian Solidarity Worldwide, which is behind the campaign, said that since December 2024, 11 religious leaders have been killed, disappeared or kidnapped. Among them was Pastor José Otoniel Ortega, who was shot and killed by gunmen while celebrating at a New Year's event.

Current Events From the Trenches

Ahead of the third No Kings worldwide day of protest on March 28, we published a call for anarchists to engage with the rallies as an opportunity to draw people into more concrete forms of organizing and action, and offered handouts for that purpose. Here, we share highlights and reports from some of the participants in the day's events.

Organizers claim that a total of eight million participants in the protests, up roughly a million from the (sic) October 18 No Kings rallies, which we had also published a call to engage with. Donald Trump's popularity has reached an all-time low, as he continues to an unpopular war with Iran after his attempt to use Immigration and Customs Enforcement to terrorize cities like Minneapolis was thwarted by grassroots resistance. Yet concrete mass resistance has yet to take shape in most of the country.

This makes anarchists' efforts to demonstrate a way forward especially important. In Phoenix, in response to a local call for an anarchist contingent in No Kings expressing opposition to borders, ICE, and repression, anarchists displaying banners reading "Solidarity with the Prairieland Nine" and "First they came for the anti-fascists" marched at the very front of the crowd.

Many of the flashpoints of March 28 took place at locations that have already become battlegrounds under the Trump administration. In downtown Los Angeles, protesters hurled chunks of concrete at Department of Homeland Security mercenaries outside the same federal detention center that was at the center of the clashes that touched off the uprising against ICE in June 2025.

The church in Montenach, a commune near the French border close to Sierck-les-Bains, was destroyed by a fire on Thursday. Videos broadcast live on social media showed thick smoke, followed minutes later by flames several metres high, as the blaze ravaged the Saint-Cyriaque church. The roof and bell tower appeared to disappear into the immense fire within a matter of minutes.

Firefighters attended the scene with an aerial ladder, but the flames had already extensively damaged the wooden structure of the parish church. "A disaster, our children were due to get married there on Saturday," one internet user lamented. According to Fabien Didier, Controller General and head of the Moselle fire service, emergency services were alerted at 1.19pm to a "vegetation fire near the church." Upon arrival, "they unfortunately observed smoke coming from the bell tower." Fanned by winds that reached gusts of 50 km/h on Thursday afternoon, "the fire spread rapidly to the entire roof of the church."

Voluntary church, mosque, and synagogue security guards would not be burdened by state licensing requirements under a bill on its way to the governor. [SB 52](#) is sponsored by Sen. Don Gaetz, a Republican from Crestview, and in the House by Republican Reps. J.J. Grow from Iverness and Omar Blanco from Miami. “The purpose of the bill is simple: to improve safety for congregations, reduce financial burdens on churches, and provide clear statutory authority so these volunteers operate responsibly and not informally,” Grow said on the House floor Wednesday.

Paid, private security officers are regulated by the state and must hold a Class D security officer license and Class G firearm license. The bill exempts volunteer security teams at churches, mosques, and synagogues from those licenses. The D license requires 40 hours of training for unarmed guards and the G license requires [28 hours](#) of firearm training.

The House passed the bill, [111-1](#), Wednesday afternoon. The Senate unanimously approved the bill last month after receiving unanimous approval in all three of its committees.

Yet [a new report](#) from the Hartford Institute for Religion Research shows signs of a shift — for the first time in two decades, attendance is up. More people are volunteering, and there also seems to be a renewed sense of optimism among pastors and other clergy. “The headline finding is cautious optimism,” Alison Norton, co-director of the Hartford Institute for Religion Research, told reporters at the annual conference of the Religion News Association, meeting in Atlanta. We need to look no further than the ruling on Derek Chauvin—the cop who murdered Floyd. He was convicted and imprisoned, but racist police violence continues to wreak havoc in neighborhoods across the country. 

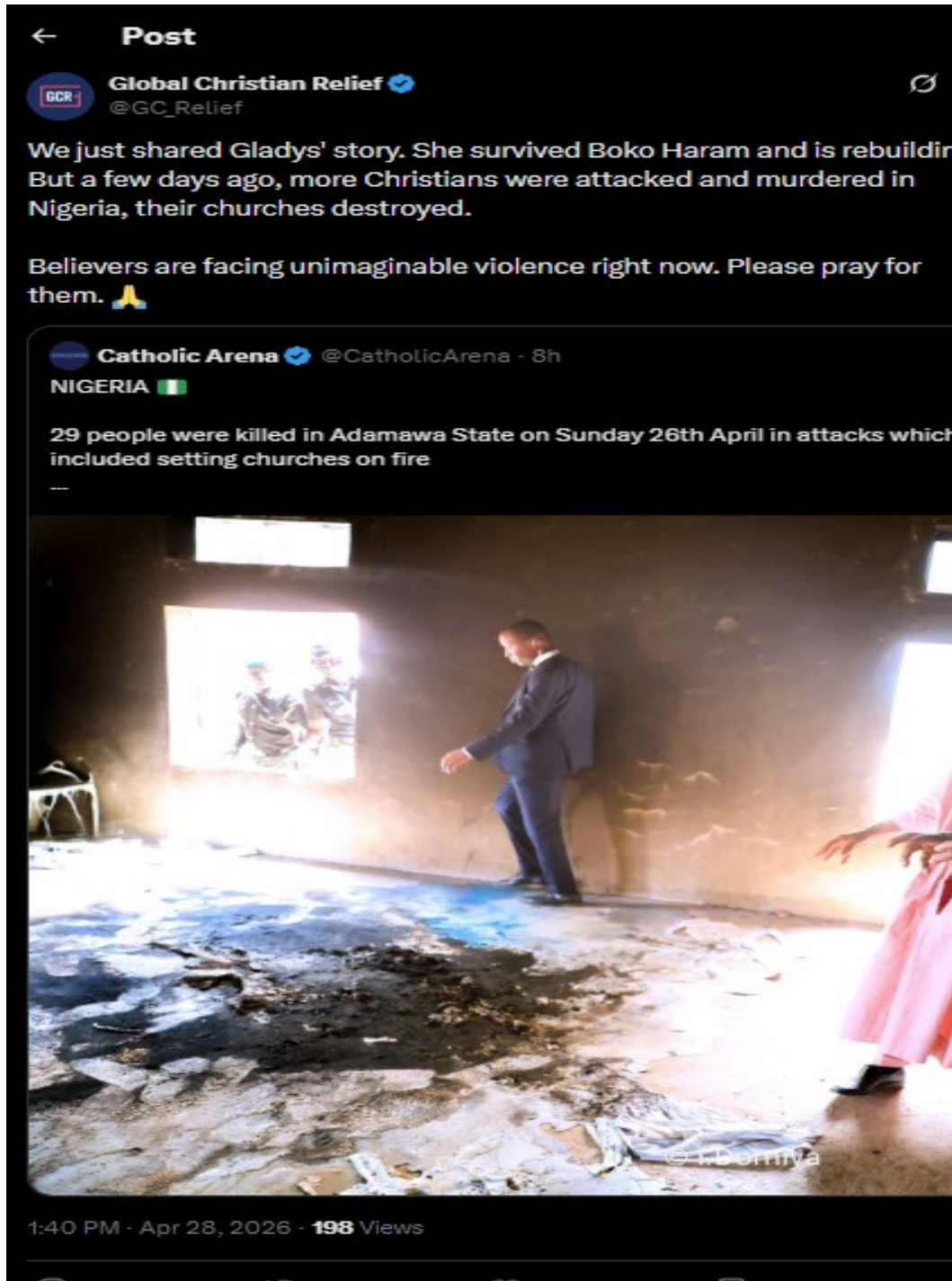
