WASHINGTON, D.C. -- This morning, Family Research Council President Tony Perkins testified before the House Judiciary Committee in a hearing titled '[The Southern Poverty Law Center: Manufacturing Hate](#).' The hearing focused on "the role that the Southern Poverty Law Center (SPLC) has played in distorting civil rights policy in recent years. Perkins testified in part:

"...In November 2010, SPLC shifted its focus beyond violent groups and began targeting Christian organizations opposing efforts to redefine marriage and human sexuality. Family Research Council was among the most prominent of that first wave.

"In August 2012, FRC joined Governor Mike Huckabee in supporting Chick-fil-A Appreciation Day after the company was boycotted because its leadership publicly affirmed traditional marriage. **Two weeks later, on August 15th, LGBT activist Floyd Corkins entered FRC headquarters carrying a 9mm pistol, fifty rounds of ammunition, and fifteen Chick-fil-A sandwiches. ST. CHARLES COUNTY, Mo. — A man is facing charges after police say he used an AI voice generator to call in threats to a St. Charles County church. Jordan Gipson was charged with harassment and making a terroristic threat in connection with phone calls made to the Church of Jesus Christ of Latter-day Saints on Monday, May 11. According to the probable cause statement, a church member called police after receiving a threatening phone call.

The church member said the voice on the other line seemed to be AI-generated and said church members would "burn in Hell" for believing in false prophets. The church member said they hung up and denied a call from the same number a few moments later. Shortly

after, the church member said they received a call from a private number, and when they answered, they heard the same AI voice. The member said the voice made similar threats, but the AI voice dropped out, and a different voice threatened to "shoot up" the church located on South Old Highway 94.

Officers said they responded around 7:22 p.m. May 20 to Cokesbury Methodist Church, located at 14806 Blackburn Road in Woodbridge, for a reported assault. During the encounter, police said Polk assaulted two male staff members before Good Samaritans restrained him. St. Paul A.M.E. Church's pastor, church members, community preachers and leaders are expected to hold a press conference at 3 p.m. May 20 in front of the church to speak out against offensive and disturbing language discovered on the property May 19.

On May 16, the church, located at 718 NW Seventh St., was the scene of a fire that severely damaged the building, leaving the newer wing safe but the older section unsafe. Ocala Fire Rescue firefighters battled the blaze and determined it was electrical and accidental. The Rev. Dr. Shaleda Mirra, the church's pastor, told a Star-Banner reporter the finding makes her angry and protective of the members and the community.

"It's extremely concerning that this happened and this was intentional," she said. The church has been at the site since 1951, and the sanctuary where the fire occurred has been around since 1973, according to Mirra. Mirra said whoever is responsible illegally entered the property to “desecrate our house of worship.” She said someone used the toilet and did not flush.

Former Arkansas Republican State Sen. Jason Rapert said he's faced intense persecution and backlash from liberal groups in the years after he helped erect a monument of the Ten Commandments at the State Capitol.

In an exclusive interview with The Western Journal, he recalled an epic saga in which the biblical monument was erected, destroyed, and replaced, setting off a firestorm of litigation. Rapert, who is the founder and President of the National Association of Christian Lawmakers, helped pass Act 1231 in 2015, after which a discussion began about placing the monument on Capitol grounds.

By 2017, he had helped form the American History and Heritage Foundation, which raised money for the display and obtained the necessary approvals for it to go up.

"Less than 24 hours after that monument was put in, and we took pictures and celebrated that it had finally been installed at the Arkansas Capitol, a man filmed himself running over the monument and destroying it," he told The Western Journal.

The email appeared to come from Pastor James Williams, reaching out to a parishioner in need of “discreet assistance.” He was too busy to take calls, the email explained, and asked that the recipient reply by email for further details. The signature was his, the church address was correct, the logo familiar. Everything looked as it should.

Still, something gave the recipient pause — enough to pick up the phone and dial the church directly. Fortunately, this person called staff to verify because the pastor had never sent the email. In fact, it had not come from anyone associated with the church. It was a scam.

Had the reporting party replied, they would likely have been instructed to buy gift cards and relay the card numbers to the scammer, or to buy cryptocurrency or another form of digital currency from a local crypto ATM. This is just one of many similar scams reported in the Cowboy State, all targeting Wyoming churches and their members who trust them. The scam takes on slightly different permutations with the goal of tricking churchgoers out of money by preying on their kindness.

Sometimes, criminals request gift cards for families in need or for other church programs, and typically lend their messages an air of legitimacy by including the actual pastor’s name, AI-generated logos impersonating the church, and biblical passages.

Do Canadian Authorities Even Want to Know Who’s Burning Down Their Churches?

A group called The Democracy Fund (TDF) has launched an independent investigation in Canada to the intensifying and expanding pattern of church and synagogue fires that are now plaguing the country. According to a CBC broadcast network investigation, from May 2021 through December 2023, there were 24 confirmed church arsons in Canada, but the total number of churches that were destroyed by fire totaled 33.

That may not be the whole of it. The Catholic Register, using data from Statistics Canada, reported that arsons were committed against religious establishments in the country at a rate of 45 in 2011, 44 in 2012, and 36 in 2013. More recently, in 2021, there were 90 such arsons, and another 74 happened in 2022 and 2023. These statistics include churches, synagogues, and other religious buildings.

While there are no confirmed statistics from these sources for 2024 and 2025, it seems that at a minimum, the current rate of church and synagogue arsons is in line with those of recent years and perhaps increasing.

According to the TDF, a certified fire investigator is leading its investigation, “to conduct an expert analysis of the wave of arson attacks and vandalism against churches and synagogues that has swept Canada since 2021.”

TDF says this is the first known independent forensic review of the arsons that have targeted religious organizations, particularly Christian and Jewish ones.

The main culprit behind the attacks was Jama'at Nusrat al-Islam wal-Muslimin (jnim)—al Qaeda's most significant African affiliate besides Somalia's al-Shabaab. However, one particularly shocking aspect of this offensive is the fact that jnim joined forces with the Azawad Liberation Front (fla). The fla is not a terrorist group but merely seeks independence for the Tuareg ethnic group. The fla is actually a rival of jnim, but the two united against their common enemy last year and have wreaked havoc on the Malian government over the past few weeks. To add insult to injury, the Islamic State in the Sahel (known as IS-Sahel), though not part of the jnim-fla union, took advantage of the violence to launch its own attacks. It claims it seized two camps.

Perhaps most significantly, the rebels retook Kidal. Mali often cited its 2023 capture of Kidal, a former jnim stronghold, as proof it could contain the terrorist threat. It can no longer make that claim.

Overall, the situation is terrible for Mali. A suicide bomber killed Mali's defense minister, and footage shows insurgents using advanced weaponry owned by the state—meaning parts of Mali's defenses have been completely overrun.

Perhaps the worst part about Mali's situation is its lack of foreign backers. In fact, it may have just lost its most significant supporter.

In 2023, Mali kicked out French and American soldiers and invited Russia to be its top security partner. Mali began hosting troops from the Russian mercenary Wagner Group, now called the Africa Corps. Russian troops have helped Mali fight terrorism for years, but these attacks were an embarrassment.

The day after the attacks, the Africa Corps confirmed it had struck a deal with the insurgents to allow its departure. It seems this departure was negotiated before the attacks were launched; jnim pledged not to attack Russians if they stayed out of the way. The Africa Corps left behind a lot of military equipment.

Russia suffered this embarrassing loss even though it has more troops in Mali than in any other regional ally—about 1,000. One senior Malian officer accused Russia of betraying Mali.

ISIS leader killed in Nigeria during joint US operation, Trump says

United States and Nigerian forces killed a senior leader of the Islamic State linked to terror attacks against Christians and the mass kidnapping of schoolchildren during a joint operation in the Lake Chad Basin in northeastern Nigeria, President Donald Trump announced.

Trump wrote on Truth Social that the mission that eliminated the global terror organization's second in command, Abu-Bilal al-Minuki, was "meticulously planned and very complex." With his removal, Trump said the Islamic State (also known as IS or ISIS) global operation is "greatly diminished."

"Abu-Bilal al-Minuki, second in command of ISIS globally, thought he could hide in Africa, but little did he know we had sources who kept us informed on what he was doing," Trump wrote. "He will no longer terrorize the people of Africa, or help plan operations to target Americans." The president praised the Nigerian government for partnering in the operation.

The Nigerian president's office confirmed the operation and said early assessments established al-Mainuki's death. Several of his lieutenants were also killed.

A Christian rights group is calling on Mexican authorities to investigate the disappearance of a 79-year-old Protestant missionary who has been missing for more than six weeks after armed men abducted him from a town in the southern state of Guerrero. The U.K.-based group Christian Solidarity Worldwide urged state and federal authorities to open an immediate inquiry into the case of Benito Guevara Arcos, who was last seen on March 31 in San Vicente, a community in the municipality of Chilpancingo de los Bravos.

Guevara Arcos had traveled from the nearby town of Ocotito to preach and distribute Bibles. He was staying with a fellow Protestant Christian, who went looking for him when he failed to return at nightfall.

Neighbors told the friend that armed men had objected to the missionary's preaching and forced him into a vehicle. The friend later confirmed that an organized criminal group was holding Guevara Arcos, claiming to be verifying his identity even though he carried official identification documents at the time, CSW said.

CLARIFICATION ON RECENT REPORTS REGARDING THE NEUTRALISATION OF TERRORIST COMMANDER ABU-BILAL AL-MINUKI

The Defence Headquarters (DHQ) wishes to provide clarification following emerging public discourse regarding the recent neutralisation of a high-profile terrorist commander, Abu-Bilal Al-Minuki, during a joint operation with the United States Africa Command on 16 May, 2026.

Certain media reports referencing a similar operation in 2024 have mentioned the elimination of a terrorist commander bearing the same name. This has understandably generated questions about the identity of the individual recently neutralised.

It is important to state that within the North East region and across the Lake Chad Basin, the use of similar or identical names, aliases and nom de guerres is common among ISWAP and Boko Haram terrorists.

This is essentially part of their indoctrination program which is aimed at deliberately obscuring identities. This fact has been established over the years in the course of counter terrorism operations in the Northeast of Nigeria.

The Abu-Bilal Al-Minuki eliminated on 16 May, 2026 has been positively identified through human intelligence and technical surveillance as a senior global operative within the Islamic State network, with direct links to international terrorist coordination, funding and operations across the Sahel. There is therefore no ambiguity in his identity.

The strike is a significant milestone in our counter-terrorism efforts.

The Armed Forces of Nigeria, in partnership with the United States, remain committed to dismantling terrorist networks and will continue to provide verified information through official channels. The general public and the media are please urged to rely only on these sources to avoid confusion from coincidental name similarities.

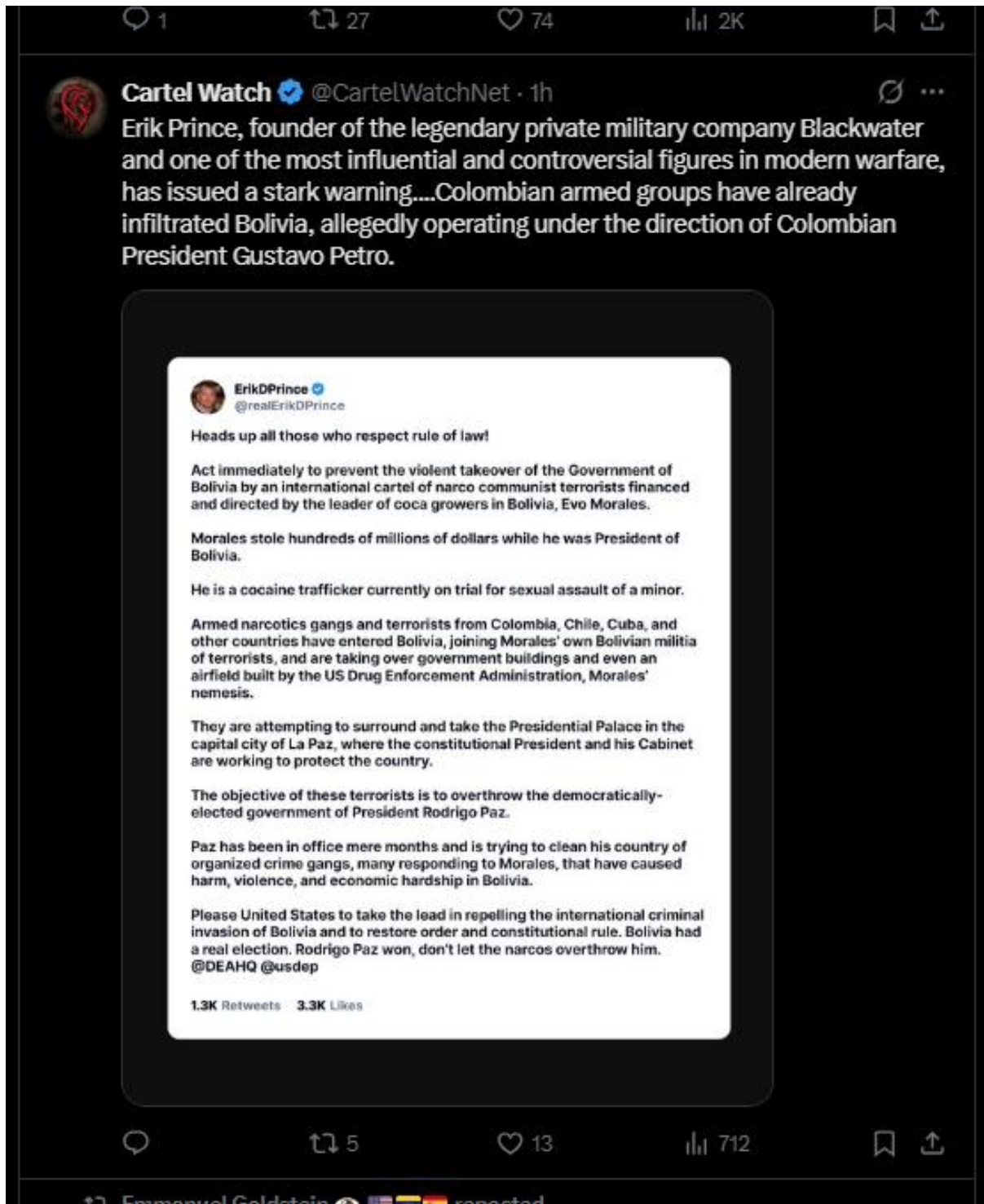
