Data from the Center for Strategic and International Studies, reviewed by the [Wall Street Journal](#), has revealed that overall, domestic attacks and plots against the US government have hit their highest level since at least 1994. Of the 20 attacks and plots recorded in 2025, 10 were categorized by the center as originating from the extreme left, while eight came from the extreme right.

Of those 10 at the hands of extreme leftists, half of the incidents were aimed at immigration officers and facilities. Another attack was aimed at the Dickinson County Republican Committee Headquarters in Michigan.

While some attacks have involved weapons such as knives and guns, which the suspected WHCD gunman was in possession of at the time of his arrest, The Wall Street Journal reported, "last year's weapon of choice was the Molotov cocktail." The incendiary device was used in at least seven attacks or plots, including an attack on Pennsylvania Governor Josh Shapiro's residence, and two instances of attempts to attack immigration agents. One man said in January of 2025 that he wanted to throw Molotov cocktails at the feet of Scott Bessent, the then-Treasury Secretary nominee, while another man in California set fire to a post office.

Satellite imagery has confirmed the demolition of two historic Christian churches in Stepanakert, the main city in the Nagorno-Karabakh region held by Azerbaijan since September 2023, with Armenia's church authorities calling it a deliberate campaign to erase Armenian religious heritage from the territory.

The Holy Mother of God Cathedral, the principal site of Christian worship in Stepanakert, called Khankendi by Azerbaijanis, has been razed, Radio Free Europe reported, based on satellite imagery taken on Sunday. Construction of the cathedral began in 2006, and the site was consecrated in 2019. During the Azerbaijani military offensives in the 2020s, the cathedral's basement was used as a bomb shelter by residents.

A social media post from early February showed a construction-type fence surrounding the cathedral. The building is believed to have been demolished by early April.

One individual lamented the loss, expressing heartbreak for those who had planned to marry in that sacred space, stating, "A disaster. Our children

system facing Christians as a restrictive legal and administrative structure incompatible with international standards of religious freedom.

According to the ECLJ, the state has now closed 58 evangelical churches, forcing worshippers underground. The report identifies Algeria's 2006 decree regulating non-Muslim worship and its 2012 law on associations as tools that control and restrict Christian life.

Executive Summary

At the start of this Administration, President Donald J. Trump signed Executive Order 14202, Eradicating Anti-Christian Bias, highlighting decisions made by the Biden Administration that evinced discriminatory treatment of Christians.¹ He established the Task Force to Eradicate Anti-Christian Bias to investigate those concerns; to identify where religious discrimination may have informed the Biden Administration's policies, practices, or decisions; and to take immediate steps to rectify weaponization of government and unlawful conduct affecting Christians.

Led by the Department of Justice (DOJ), the Task Force consists of seventeen principals from departments and agencies across the federal government. This report compiles the Task Force's findings to date and summarizes what its members are doing to detect and eliminate anti-Christian bias. By addressing anti-Christian bias and religious discrimination directly, Americans can make religious discrimination unthinkable for all faiths.

Our Nation's origin and system of government bear the imprint of a Christian worldview and ethic, even as its laws protect religious pluralism. A dangerous dissident republican group, the New IRA, which is allegedly linked to Iran and Hezbollah, claimed responsibility Tuesday for a car bomb outside a Belfast police station before warning of further attacks, according to reports. The blast targeted a Police Service of Northern Ireland station in Dunmurry, and police increased patrols after the group threatened to target officers at their homes.

A 2020 report by [The Times](#), citing information from an MI5 informant, alleged connections among the New IRA, Lebanon-based Hezbollah and Iran's Islamic Revolutionary Guard Corps (IRGC). The report said individuals linked to the group signed a book of condolences after the 2020 killing of Iranian [Gen. Qassem Soleimani in a US drone strike](#) in Baghdad, raising concerns about possible external support, including weapons and funding.

“The New IRA–Hezbollah link is a useful data point in a much larger pattern: the operationalization of the so-called axis of resistance,” former Defense Department intelligence officer Andrew Badger told Fox News Digital. “This joins Russia, Iran, China, North Korea and an expanding bench of aligned non-state actors into a working logistical and tradecraft network across the globe,” Badger said.

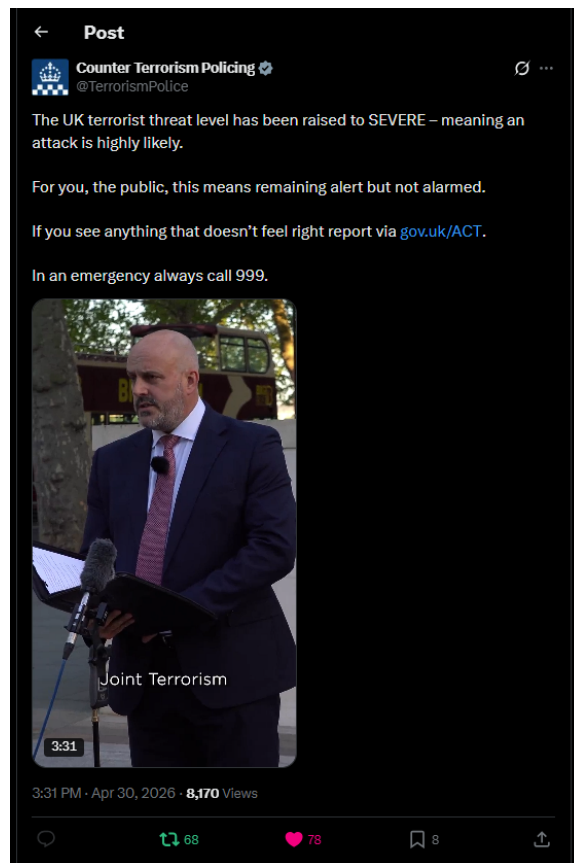

An Irish Republican group New IRA could be behind an overnight car bomb attack outside a police station near Belfast late on Saturday, authorities said. According to the Police Service of Northern Ireland (PSNI), although there were no fatal casualties, two infants were among the residents evacuated after the explosion in Dunmurry, southwest of the Northern Irish capital. The car bomb went off after a "gas cylinder-type device" was placed in a delivery driver's hijacked car and driven to the location, police said.

The attack followed a similar attempted bombing on 30 March, when the device failed to explode outside a police station in the nearby town of Lurgan, with paramilitary group the New IRA claiming responsibility for that attack.

Alfred Kitenga was beaten and stabbed at about 9:30 p.m. along the Northern Bypass in Kawaala, Wakiso District, after he and his wife, Anna Grace Nabirye, were returning home from preaching in the Namungoona area of Kampala, she said.

After the couple spent the evening preaching in Namungoona as part of an evangelistic team, four people who identified themselves as motorcycle taxi drivers approached them, saying they were Christians who had attended the event, and offered them free transport home, according to Nabirye. “We believed them because they said they were fellow believers who had listened to the message,” Nabirye told Morning Star News. ***During the journey, the riders suggested an alternative route through Kasangati, citing traffic congestion and the late hour, she said, and the couple agreed to the change.***

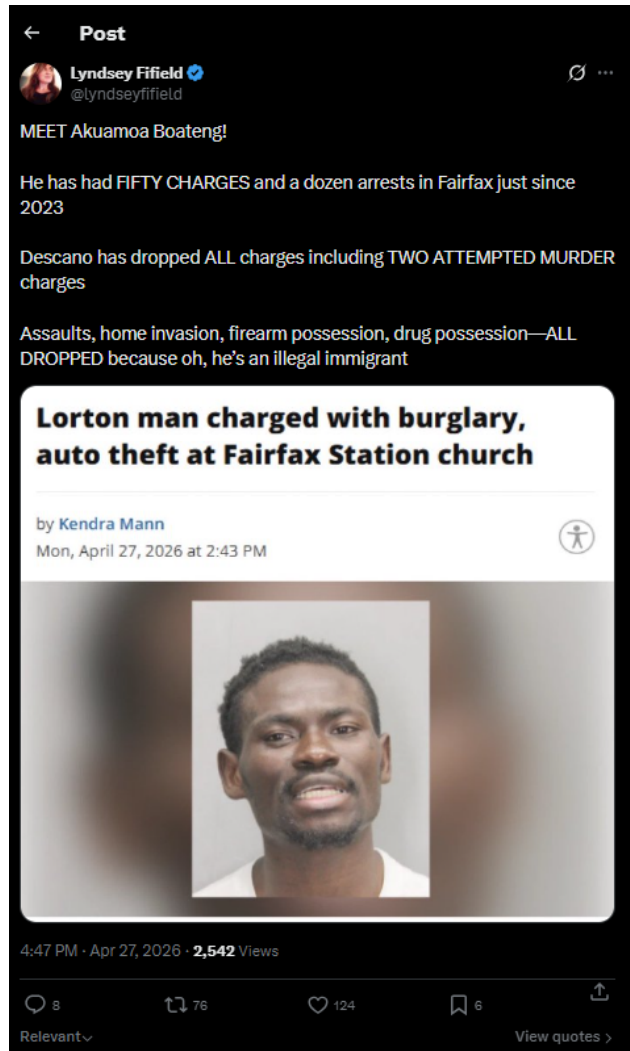
Through their investigation, detectives learned a vehicle owned by the church was also stolen.

Chaos During the Call to Worship

Grimaldi Martinez, the pastor overseeing the church's Spanish services, described the scene as surreal. “It was a shock,” Martinez told reporters on the scene. “This is the first time the church has experienced a threat of this nature in its 25-year existence, and certainly in my 12 years at the helm.”

Suspect Arrested in January 2026 Rose Park Shooting

SALT LAKE CITY — Detectives with the Salt Lake City Police Department Homicide Squad have arrested 32-year-old John Vea Uasike Jr. in connection with a deadly shooting in the Rose Park area.

There is no information regarding the church and clergy reporting activity are classic anomalies in behavior patterns and in this case as so many others culminating in violent attack. Here, the introduction of deadly weapons into the church environment with no details given. This elevated the threat environment to an attack scenario, inferred or actual, not the issue. SUBJECT may have decided NOT to attack on that day. There is no indication of the church actions on that day, or afterward. Another example of clergy unaware of indicators which MUST be briefed to security and police. This is a classic insider threat. This means pastoral counseling as well.

Also, an example of a risk from my experience would be counseling which reveals a very concerning divorce action with which indicators of actual or potential violence or abuse are present. Clergy must act. What can happen off church property will, will happen on that property. Clergy MUST listen to the wise counsel of their Watchmen as executive support staff and then decide on actions forward, policy, training, evaluation of that training with exercises.

My experience over the last six years is complete and utter disregard and rejection, passionately trying to get clergy and local police involved, and area churches networked into a liaison threat group force multiplier. I have brought all of the professional skills I acquired over decades, Praise God. Had this been reported to police, Fedex would never have cleared this SUBJECT for hire in a background check. It is time for fervent prayer. That little girl might be alive today. I do not need to provide an analysis and countermeasures here. I am certain the reader understands fully my angst as the Watchman.
