ANALYST COMMENT

The concerns here are of course counterterrorism, primarily target surveillance, but also criminal investigative concerns related to the same concern of surveillance for a different motive, burglary underneath a targeted location (bank or art gallery as examples) Sewer intrusions are felonies, and considering media reporting of these two distinct operational cells ten miles apart and their change of clothing, the police silence is quite expected. Several men were caught on video entering a sewer manhole in Brooklyn and then **emerging from it hours later Friday morning**. Now, police are trying to determine exactly what they were doing underground.

Caught on camera

CBS New York obtained video showing what appears to be a group of at least seven men gathered around a manhole on McDonald Avenue and Colin Lane in Flatbush late Thursday night. Some of the men appear to be wearing waders and gloves.

One-by-one, the seven descended below ground, using flashlights as their guide and cars to light up the area.

They appeared to change clothes after climbing out. A few appeared to be shirtless on the side of the road. In the video, what seems to be the sound of a manhole cover being replaced can be heard before the group leaves the area.

NYPD investigating

Police said a 911 call brought officers to the scene, but the men were gone before they arrived. Later Friday afternoon, the NYPD returned to the area to investigate.

Crews from the Department of Environmental Protection were also on scene. They lowered what appeared to be a camera with a light into the manhole as they inspected the sewer system.

A DEP spokesperson said they are inspecting the sewer infrastructure in the area to make sure nothing was damaged. "Entering the sewer system is both illegal and extremely dangerous. - Two sewer mysteries unfolded overnight Friday in Brooklyn. Police say two groups of people were seen exiting manholes in Williamsburg and Gravesend.
- The incidents, around an hour apart, happened at opposite ends of the borough.
- Eight people were caught on video entering the sewer system at around 1 a.m. at Heyward Street and Bedford Avenue in Williamsburg, according to police. They say the group exited the sewer a short time later and took off in a car.
- About an hour later, seven people mysteriously emerged from the sewer system in Gravesend near McDonald Avenue and Collin Place. Police say it is unclear how long the group was in the sewer system or what they were doing there.
- Surveillance video from the Flatbush Scoop shows the Gravesend group exiting the manhole one by one before gathering near two parked cars, where they appear to remove their soiled clothing and clean themselves off.
- A large police scene took over the Williamsburg neighborhood Friday evening, where emergency service vehicles and officers flooded the street.

A man arrested for vandalizing a Charlie Kirk memorial in Loveland has pleaded guilty to arson. David Gilroy, now 65, of Loveland, was sentenced May 14 to six months of unsupervised probation after pleading guilty to second-degree arson and damaging property valued between \$300 and \$1,000, a Class 2 misdemeanor.

Gilroy was arrested Sept. 15, two days after Loveland police responded to a report that a Charlie Kirk memorial at a residence in the 200 block of East 23rd Street had been set on fire. Police described the damage as extensive and said a large rock had also been thrown at the rear window of the resident's vehicle.

ANALYST COMMENT

Texas man allegedly made online threats directed toward an upcoming Turning Point USA event and the CEO of the conservative nonprofit, Erika Kirk. Jacob Wenske, 26, is charged with a third-degree felony count of making a terroristic threat involving public fear of serious bodily injury or public disruption.

An investigation into Wenske began after a local newspaper published a Facebook post promoting the TPUSA Women's Leadership Summit scheduled for June, which features Kirk as a keynote speaker. The event is set to take place June 5–7 at the San Antonio Marriott Rivercenter on the River Walk. "I know exactly where to bomb," Wenske allegedly replied to the post. In a separate post within the same thread, Wenske wrote, "I can't wait to be the valet for her escort," authorities said, according to a report from KSAT-TV.

"Death to Erika Kirk and every single speaker there!! America will live on without those scum on this earth. Every Christian nationalist shall perish in the bombing that will take place at every single Turning Point rally and event," he allegedly wrote in a subsequent email.

Police radio traffic showed law enforcement received a call for a “suspicious noise of gunshots” at Barrett’s suburban home, but the dispatcher warned that it could be fake given that a “high priority resident of the county” lived there.

“Yesterday evening at approximately 9:02 p.m., officers responded to a swatting call at the residence of U.S. Supreme Court Justice in Fairfax County,” the Fairfax County Police Department told The Hill. **“The call was received through the department’s non-emergency line.**

"Officers immediately coordinated with Supreme Court Police personnel assigned to the residence and quickly determined that the report was fictitious," it continued. "No additional police resources were utilized." The incident comes after Barrett said she and her family have received pizza delivered to them that they had not ordered in order to stoke fear, and judges nationwide have also reported receiving pizzas, sparking an investigation by the U.S. Marshals Service. Last year Barrett’s sister was also the victim of a bomb threat in South Carolina.

Swatting, Hoax Bombs, Suspicious Packages, Elicitation, Bomb Threats and other unexpected critical incidents have and will continue to be of dual use to terror, insurgent and guerilla cells. The congregation at Antioch Missionary Baptist Church in Corbin says they're grateful no one was inside when the bullets came through the walls. Investigators are trying to figure out who pulled the trigger. Clergy believes it was an accident and that the shots came from trailers behind the woods. They counted five holes. One bullet was found on the fellowship hall floor, where the congregation eats every service. It damaged the cabinet right above the sink. "If anybody had been sitting in that row, they could have been struck and could have been killed but it does make it frightening when you start thinking that way," Pastor Fore said.

Additional shots fired

Fore said after realizing the church had been shot, he brought his congregation to the front porch. More shots rang out, missing the church. "We're praying for the persons that did this, we're praying for them, we pray they get right with the lord, we would love for them to come to church and get right, antioch, it's open to everybody," Fore said. The Fores said service will continue and the congregation isn't scared. Laurel County Sheriff John Root confirmed the shooting is under investigation.

Sudan | Christians Targeted On All Sides in Hidden Conflict

In 2019, the ousting of Sudan's notorious dictator, President al-Bashir, gave Christians in Sudan, and the entire population, high hopes for the future. Crowds on the streets were singing of religious freedom and equality. A transitional council was created. Civilians sat alongside army chiefs, and the religious police were dissolved. When the death penalty for leaving Islam was abolished, there was joy.

But, behind the scenes, relations between General al-Burhan, head of the Sudanese Armed Forces (SAF), and his civilian colleagues soured. In October 2021, civilian council members were arrested in dawn raids. General al-Burhan and his deputy General Hemedti—leader of the RSF—disagreed about how Sudan might return to civilian rule. When Hemedti began moving armed units within the country, his former ally and boss saw a threat.

A protester prominently displayed lewd materials outside a St. Paul, Minnesota, church in the presence of children, saying she intends to prevent kids from attending services.

Protests have dogged Cities Church, an evangelical Reformed congregation affiliated with the Southern Baptist Convention, since Immigration and Customs Enforcement surged to the Twin Cities.

In January, agitators opposing Immigration and Customs Enforcement took over the sanctuary during a service, chanting, "Who shut this down? We shut this down." A federal grand jury indicted 38 people on charges of violating the Freedom of Access to Clinic Entrances Act and the Ku Klux Klan Act for that incident. Yet protests outside the church have continued.

Photos of a protest outside the church on Mother's Day reveal that a protester's car had two dildos attached to the windows. One of the church members confronted the protester about the sex toys, and the protester responded by telling church members not to bring their children to church. The church's pastor claims the protester "harasses" the church weekly.

The Church Protection Bills

Oklahoma Gov. Kevin Stitt, a Republican, signed Senate Bill 743 in February. The law criminalizes disruption of church services and imposes up to a \$500 fine or up to one year in county jail for a first offense, with higher penalties for repeat offenses. The law also bans the use of profanity and rude or indecent acts during worship services.

Idaho Senate Bill 1296, which the state’s Republican governor, Brad Little, signed in March, makes it a misdemeanor to intrude into a church or house of worship with the intent to intimidate, harass, or disrupt the service. The law, which goes into effect on July 1, imposes up to six months in jail and fines ranging from \$500 to \$1,000 for a first offense, with escalating penalties for repeat offenses.

Louisiana House Bill 294 strengthens existing laws to give churches, synagogues, and other places of worship clear authority to quickly remove disruptive individuals. HB 68, meanwhile, imposes harsher penalties for intentional disruptions, adding a mandatory 30-day jail sentence to disturbing-the-peace charges for incidents at houses of worship. Gov. Jeff Landry, a Republican, signed both bills last month.

The Kansas Legislature overwhelmingly passed House Bill 2018, which criminalizes interference with the conduct of a religious assembly, in March. Gov. Laura Kelly, a Democrat, allowed the law to take effect without her signature. She warned that the law “prioritizes” one fundamental right—to freely practice religion—over another, the right to freedom of expression.

While Americans have the right to protest and engage in free speech, that does not extend to invading church services and taking them over. Legislators have introduced similar bills in at least seven states, The Associated Press reported.

Meanwhile, the New York Civil Liberties Union has filed a lawsuit to block a similar ordinance passed in Nassau County, New York. That ordinance, passed two days before the Cities Church invasion, appears to have come in response to harassment against a Manhattan synagogue.

Thursday, Las Cruces police said Matthew Albian Alarcon was charged for attempted burglary and "possession of a suspicious device." On May 4 at about 4:30 a.m., security video from St. Genevieve's Catholic Church on Espina Street showed a man parking a dark-colored car, LCPD said. The man got out of the car and started shooting the gun toward the church.

A week later, LCPD said one of its officers noticed Alarcon and 36-year-old Juan Manuel Garcia loitering near a car in front of Miller Guns and Ammo on north Telshor Boulevard. The officer determined they were planned to break into and burglarize the store, police said. After searching the car, officers found a handgun. Alarcon claimed it was his, but LCPD said it was reported to be stolen. LCPD said officers compared video of the car from the church shooting and determined it matched the car in front of the gun store, which Alarcon drove.

🚩 Earlier today, I attended a Palestine Action Global Workshop led by Serita Braxton. Keep in mind, Palestine Action has already been proscribed in the United Kingdom, which makes the content of this workshop even more alarming.

Braxton walked participants through “covert” and “accountable” direct action, explaining that covert actions allow activists to hide their identities and act “again and again,” while accountable actions mean “you can do more damage” because you are not planning an escape.

Braxton also described the group’s action agreement, which states that its actions seek to “disrupt, damage and destroy” targeted companies. She emphasized that actions operate on a “need to know basis” and warned participants involved in covert actions to ensure they cannot be identified in photos or videos.

Government and law enforcement can look away if they want, but that is on them. The purpose of this workshop was to recruit and mobilize like-minded individuals. This is not going away. It is spreading, organizing, and clearly ramping up.

He is now suing the Los Angeles County for religious discrimination and harassment.

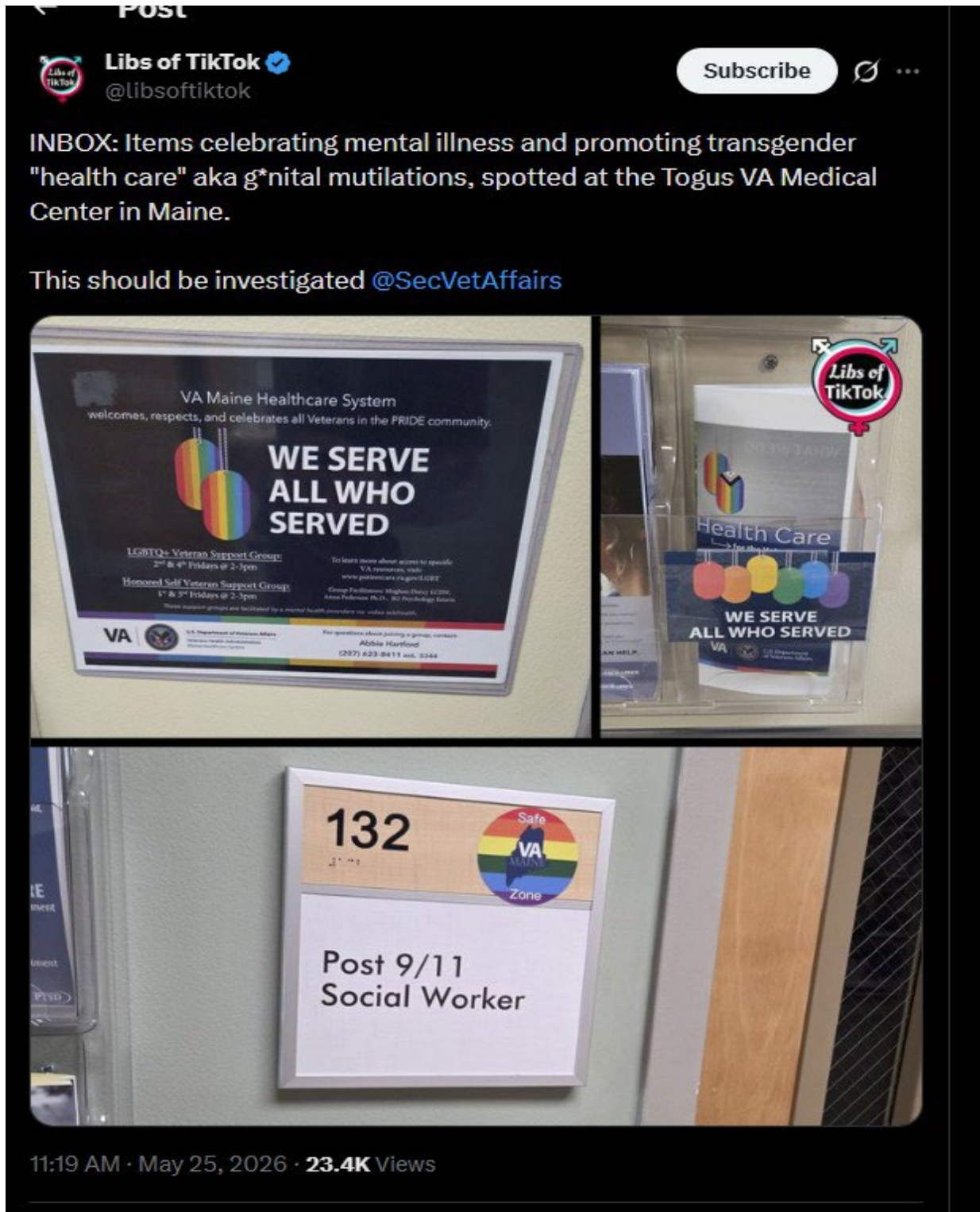


