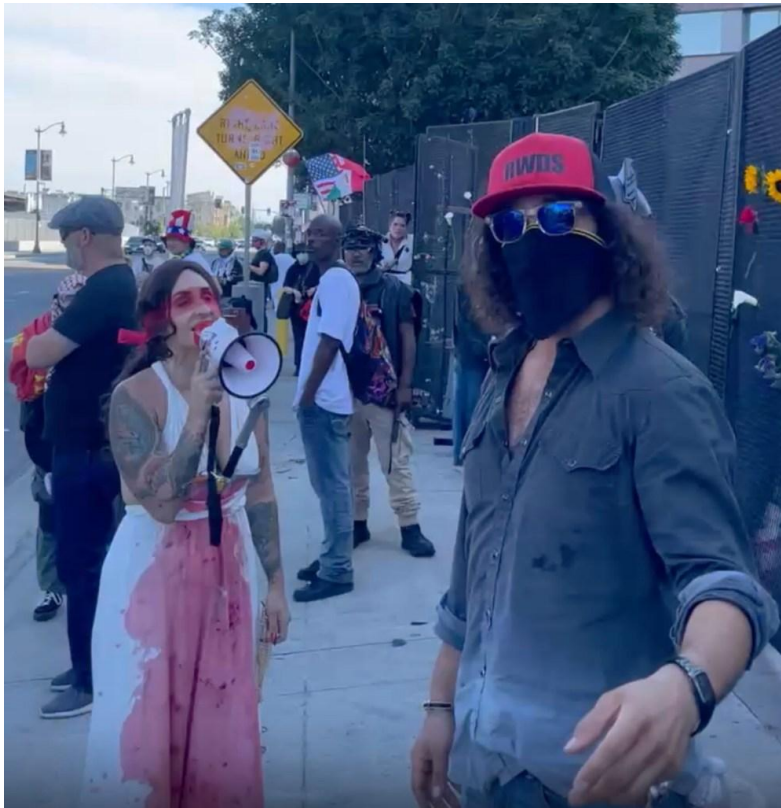

The Jan. 6 rioter who was turfed from Spencer Pratt’s election night party was swarmed by a group of anti-ICE protesters outside the Los Angeles Metropolitan Detention Center on Saturday in a disturbing incident caught on video. Footage shows Jon Mellis, 39, known online as @PatriotWildMan, being repeatedly taunted as a “pedophile worshipper,” chased, and allegedly doused with gasoline by masked protesters as he attempted to escape the confrontation. He managed to outrun the pursuing mob, although he was allegedly struck several times in the head per the video. “Me and my friend went to the anti-ICE protest, we masked up, and we were, you know, lightly telling people that asked that we worked with the DNC,” Mellis claimed.

Half a century after Steven Spielberg challenged audiences to think about what lies beyond the starry canopy that defines our universe in *Close Encounters of the Third Kind*, the director is again challenging accepted precepts of faith and singular belief in a supreme being. His new film *Disclosure Day* sees him revisit the possibility of aliens: “I absolutely think that they have been here, and they are here,” he outlined in an interview with CBS News.

“‘Disclosure Day’ is about how, if somebody had the power and if somebody had possession of the entire archive of visual evidence of what’s been happening for the last 80 years, what would happen if they decided to do a data dump across the entire world all at once?” Spielberg said, adding it is as much a “chase” movie as it is a reflection on our very being. “And the people who are trying to stop that data dump from happening, that is basically the core of this chase movie.”

MARPLE TOWNSHIP, Pa. (WPVI) -- A potential tragedy was averted in Delaware County after police arrested a man accused of making threats against a Catholic church in Marple Township.

Christopher Henderson, 37, of Exton, is now jailed on charges of making terroristic threats on Facebook targeting St. Pius Catholic Church in Broomall, according to police.

According to the criminal complaint, Henderson posted Tuesday morning that he was driving to St. Pius X Catholic Church, writing, "I'm sending all you (expletive) to hell."

"I firmly believe we stopped a tragedy before it happened. He had no weapons on him, but you don't need weapons to commit violence," said Marple Township Police Chief Brandon Graeff. A pre-dawn fire tore through a two-story church in the Broadway Manchester section of South Los Angeles on Monday, collapsing part of the roof and sending thick smoke across the neighborhood. Firefighters fought the blaze for about two hours before declaring a knockdown, and while the building was heavily damaged, no injuries were reported. Nearby streets were shut as emergency crews locked down the scene.

Helicopter video from AIR7 captured a partial collapse of the church roof as flames chewed through the upper level. Crews declared a knockdown just after 7 a.m., following roughly two hours of firefighting, according to ABC7. **Arson investigators were called to the site**, and the Los Angeles Department of Building and Safety was set to evaluate whether the structure was still sound. Broadway was closed in both directions near the scene while that work unfolded.

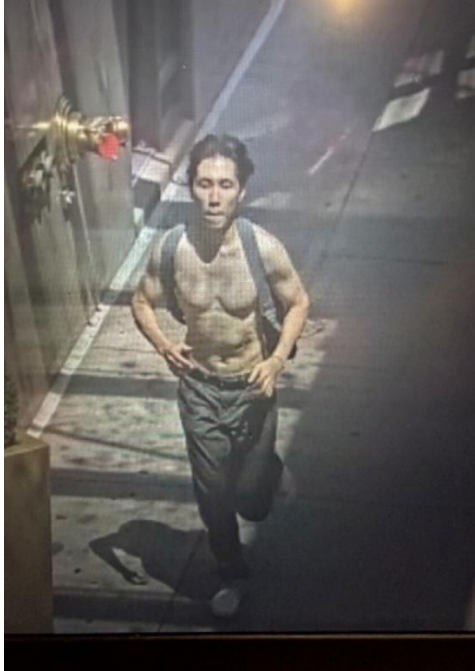
Chicago police Wednesday released a picture of a person they suspect lit a cross on fire in the middle of the afternoon in Grant Park, alarming officials, faith leaders and the public. A shirtless male was seen fleeing the park, where a large cross was set ablaze in the [600 block of South Columbus Drive](#) around 2:30 p.m. Tuesday. Firefighters extinguished the blaze; no injuries were reported. In a community alert circulated Wednesday, police described the arson suspect as a male wearing dark pants, white shoes and carrying a backpack.

The FBI also is assisting with the investigation, and said it is “assessing all potential violations of federal law with local law enforcement and prosecutorial partners.” Meanwhile, faith leaders have offered a \$10,000 reward for information leading to the arrest of the male, and officials including Mayor Brandon Johnson and a City Council member said they were “deeply disturbed.”

ST. PAUL, Minn. – A network of about 500 groups with an estimated \$3 billion in combined annual revenues is behind the coordinated nationwide "No Kings" protest Saturday, including communist groups who are using the day to call for a "revolution," according to a Fox Digital News investigation.

According to a copy of the permit for the "flagship" march in St. Paul, Minn., Indivisible, a national well-heeled Democratic political advocacy organization funded by billionaire George Soros, is the lead coordinator for the protest.

But Fox News Digital has also identified key participation by a network of radical socialist and communist organizations funded by Neville Roy Singham, an American tech tycoon and avowed communist living in China.

The activities of this network have motivated a group of tech sleuths on the X — @DataRepublican, @Astrarce, @bitchunee soap and @gunshymartyr — to penetrate these groups, their Signal chats and their operations like a digital Avengers squad.

According to Fox News Digital's analysis, the network behind the Delaney Hall protests includes about 100 groups, some of them big names like the ACLU, Indivisible and [Democratic Socialists of America](#). Together, these organizations report collective annual revenues of about \$825 million, approximately equal to the [annual budget](#) of Newark. The groups didn't respond to requests for comment.

About 70 of the groups have received special designations as charities by the IRS, have status as regular 501(c)(3) and 501(c)(4) nonprofits, as well as labor union 501(c)(5) and 501(c)(6) nonprofits, enjoying tax-deductible donations and certain tax-free benefits.

In recent months, Treasury Secretary Scott Bessent and lawmakers on the House Ways and Means Committee, the House Judiciary Committee and the House Oversight Committee have launched investigations into the alleged [abuse of nonprofit laws](#) to instigate conflict, sow discord and even inspire political violence.

The Delaney network — which one expert calls the "Delaney Hall 100" — message around shared language assembled in a strategic communications document, called the "Delaney Hall Creator Brief," which Fox News Digital obtained from X user @b----unneedsoap. The strategy document directs content creators to call the detention center a "concentration camp" and label detainees "imprisoned prisoners" and "captives." It tells activists to eschew saying detainees were arrested, but rather assert they were "kidnapped/abducted/taken."

Their tactics mirror the system deployed in Minneapolis earlier this year to protest ICE actions, and military experts say the operations resemble the tactics of an insurgency. "We should be very concerned about the Delaney Hall 100," said Chuck Flint, a nonprofit expert and former U.S. Senate chief of staff. "Protests like the kind we're seeing outside Delaney Hall are not organic protests. These are manufactured strategic, calculated endeavors by an army of nonprofits meant to push subversive activity."

WASHINGTON—House Committee on Oversight and Government Reform Chairman James Comer (R-Ky.), Taskforce on the Declassification of Federal Secrets Chairwoman Anna Paulina Luna (R-Fla.), and Subcommittee on Delivering on Government Efficiency Chairwoman Marjorie Taylor Greene (R-Ga.)—along with Republican members of the panel—are investigating the financial and political activities of Neville Singham, a U.S. billionaire with ties to the Chinese Communist Party (CCP), that may be linked to the ongoing riots and violence in Los Angeles, California, as well as the far-left organization Code Pink.

Arizona Republicans want to make it a crime to disrupt religious activities, but critics warn it’s little more than a thinly veiled attempt to protect anti-LGBTQ and anti-abortion protestors. On Tuesday, the state Senate gave preliminary approval to House Bill 4117, which would punish “interfering” with a religious service or activity with jail time. At a minimum, doing so would be a class 1 misdemeanor, which carries with it fines and a six month jail sentence. Repeat violations or the use of threats, force or physical intimidation could escalate that punishment up to a class 6 felony.

If it becomes law, “interfering” with a religious service or activity would happen when a person blocks someone from entering or exiting a place of worship or engages in a “protracted commotion, utterance or display” that disrupts proceedings in a place of worship.

Omeish also said that while "America has a lot of good things," the best thing Muslims can do for the United States is help guide it with the guidance of Islam.

Omeish is a board member of the Dar Al-Hijra Islamic Center. In 2007, Omeish resigned from a Virginia state commission after saying in a video that pro-Palestinians should "pursue the way of jihad" in opposing Israel.



The Dar Al-Hijra Islamic Center in Falls Church, Virginia, where Omeish is a board member, has several alleged links to terrorism and the Muslim Brotherhood. Its former imam was U.S. Specially Designated Global Terrorist Anwar Al-Awlaki, a top leader of Al-Qaeda in the Arabian Peninsula (AQAP).





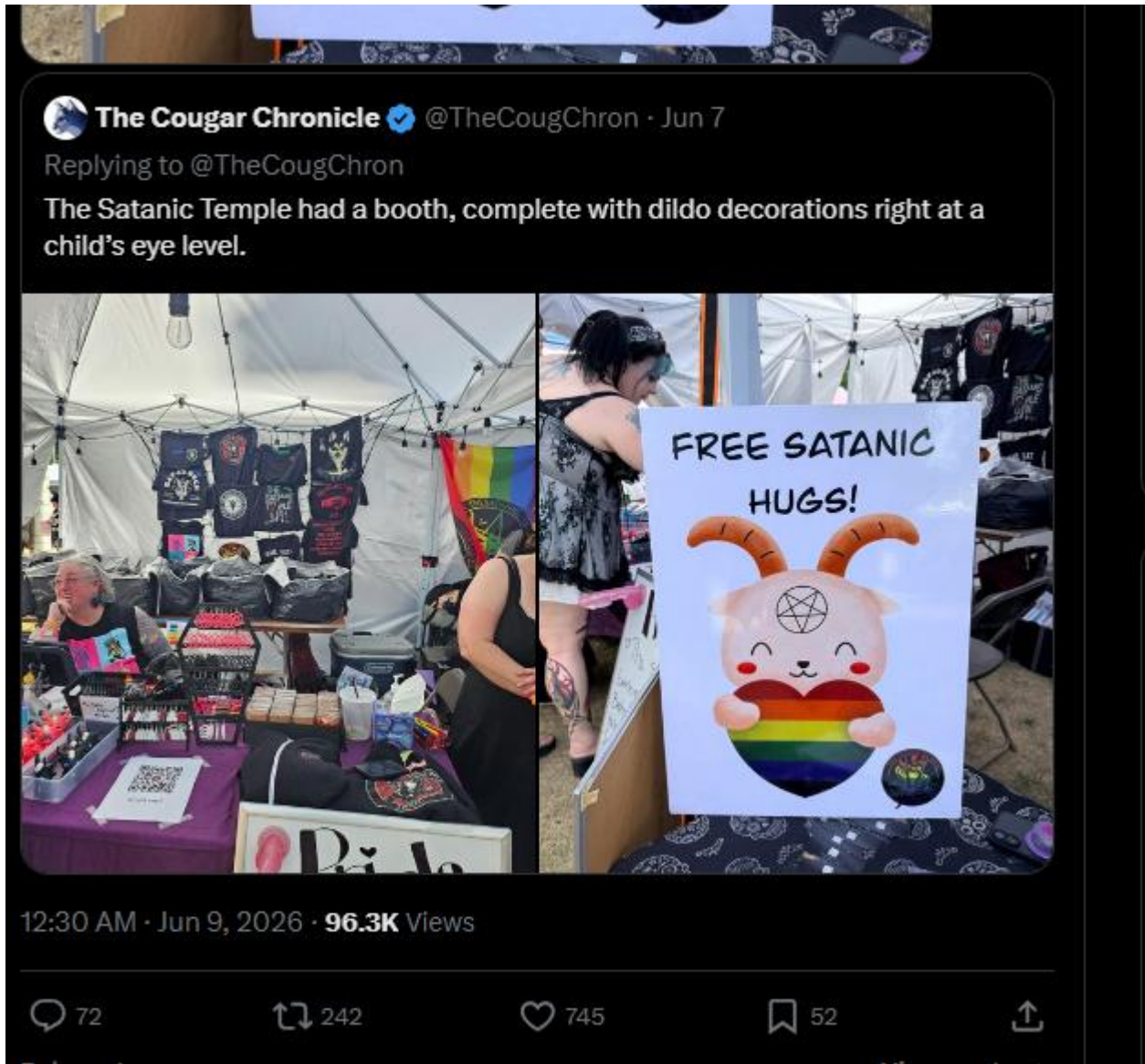

Oregon Man charged with Domestic Terrorism After Series of Fires in Wheeler County

A man was taken into custody after setting a series of fires at power poles and other properties near Fossil, Oregon, according to the Wheeler County Sheriff's Office.

The charges include two counts of domestic terrorism, along with burglary, arson, theft, criminal mischief, reckless burning and interfering with a firefighter.

According to the indictment, the crimes were committed between June 2 and June 4. The domestic terrorism charges stem from allegations that Burlingame unlawfully and intentionally disrupted services provided by critical infrastructure and intentionally destroyed or substantially damaged critical infrastructure.

No motive for the fires has been released.

Athens, GA: The neo-Nazi hate group Blood Tribe, founded by Christopher Alan Pohlhaus, was spotted yesterday disrupting the city's Pride event.

Witnesses report members gave Nazi salutes, shouted "Heil Hitler," and marched with a swastika banner.

Pohlhaus, former Maine resident and tattoo artist, has openly associated with prominent extremists, including Jon Minadeo II. In 2022, he posted a photo of himself tattooing the Nazi Totenkopf ("death's head") symbol on Minadeo's arm, a symbol historically associated with Nazi SS units.

The same Totenkopf tattoo is prominently displayed (and now covered) on the chest of Graham Platner, who is currently running to represent Maine in the U.S. Senate.
