Water utility hack

The Iran-linked threat actor Handala this week boasted to have hacked California Water Service (Cal Water) and published 5 gigabytes of data allegedly stolen from the US water utility. In a post on their blog, the hacking group said the intrusion was retaliation for recent US actions in Iran and claimed they had the ability to disrupt water access but chose not to. Note Bakersfield, Visalia, Chico water systems were attacked.

The cybersecurity firm says that Cal Water's Chico District has been confirmed as the victim of the attack. Data leaked by Handala shows it likely accessed a customer billing database and Cal Water's internal RTKBase application. "The RTKBase instance had been operational for approximately 783 continuous hours. Handala's dump appears to be a bulk database export containing personally identifiable information (PII) such as names, addresses, phone numbers, account numbers, and payment histories.

Linked by the US to Iran's Ministry of Intelligence and Security (MOIS), Handala has been active since at least 2008 and is also tracked as Handala Hack, Banished Kitten, Dune, Hanzalah Hacking Group, Homeland Justice, Red Sandstorm, Storm-0842, and Void Manticore. The group is known for engaging in a broad range of activities, from hacktivism to destructive attacks, with a primary focus on data exfiltration, the deployment of wiper malware, and psychological operations.

"Handala's operational pattern frequently involves an initial claim followed by escalated action. Security teams should treat the current disclosure as a possible precursor to a destructive follow-on and posture accordingly," Dataminr notes¹.

An Iran-linked hacker group Handala claims to have breached FBI drones and has threatened to target the World Cup that kicked off this week, a monitoring group said Friday. The SITE Intelligence Group, an organisation which monitors non-state groups, published a statement from Handala saying they had had access "for months" to "every image and every suspect" captured by first-person view (FPV) drones used by the FBI.

The hackers said the drones featured facial recognition and license plate screening deployed for counterterrorism.

"Better tighten your World Cup security, we don't like some of those teams at all. Don't forget: FPVs are everywhere; you never know when one might end up right in your team's bus," Handala said in the statement quoted by SITE. **The FBI is deploying drones around 2026 World Cup stadiums to protect against unauthorised aircraft.**

Drone flights will be banned over US stadiums hosting matches, as well as over fan events related to the tournament that kicked off on Thursday. The Justice Department has previously warned of the potential for cyberattacks by Iranian actors following the US-Israeli strikes on Tehran in February that triggered the Middle East War.

Handala published photos and footage, it said, that were taken from hacked drones, but SITE disputed the claim.

The piece calls on supporters to reject the tournament and explicitly encourages “lone mujahideen” to carry out violent attacks, particularly in U.S. host cities.

Illegal Alien Felon Arrested for Flying Drone in World Cup Restricted Airspace after Prior Deportations, Monday, June 15, 2026, For Immediate Release,

ATLANTA – Lorenzo Rojas-Martinez, an illegal alien from Mexico with a prior cocaine distribution conviction, faces federal charges for flying a drone over Centennial Olympic Park during the FIFA Fan Festival in Atlanta and for illegally reentering the United States after two prior deportations.

According to U.S. Attorney Hertzberg and the criminal complaint: on June 12, 2026, federal agents allegedly observed Lorenzo Rojas-Martinez operating a drone in restricted airspace near Centennial Olympic Park during the 2026 FIFA Fan Festival in Atlanta while standing in a nearby parking area and recording video of the event. After requesting his identification and reviewing his driver's license, agents allegedly confirmed that he was unlawfully present in the United States following two prior removals. Rojas-Martinez has a prior conviction for cocaine distribution among other charges.

Lorenzo Rojas-Martinez, 37, of Mexico was charged in a federal complaint on June 15, 2026, with operating a drone in a temporary flight restricted zone and illegal reentry by a removed alien. Members of the public are reminded that the complaint contains only charges. The defendant is presumed innocent of the charges, and it will be the government's burden to prove the defendant's guilt beyond a reasonable doubt at trial. This case is being investigated by the Federal Bureau of Investigation and Immigration and Customs Enforcement.

About half of Evangelical Christians believe President Donald Trump's conduct of the Iran war and his immigration enforcement policies do not align with their Christian values, according to a Reuters/Ipsos poll, as Republican strategists count on the voting bloc to defend congressional majorities in November midterm elections. Some 54% of Evangelicals in the June 3-8 survey said Trump's use of the military in Iran was not in line with their understanding of Christianity, while 41% said it was, according to Reuters. Fifty-one percent said the administration's approach to immigration was not in keeping with Christian values, with 44% saying it was.

Trump's approval rating among Evangelicals stood at 52%, down from 61% in August, though well above his 35% rating among all U.S. adults. Evangelicals, who skew Republican by more than two-to-one, backed Trump 81% to 16% in 2024, per a Pew Research Center exit poll analysis.

White House spokeswoman Taylor Rogers told Reuters that Trump's policies have delivered for American Christians, citing the defense of religious freedom rights and the pardoning of pro-life activists convicted of federal charges. "There has never been a greater president for Christian Americans than President Trump," Rogers said.

The U.S. and Israel launched the war against Iran on Feb. 28 with the stated aim of preventing Tehran from fully developing a nuclear weapon. More than 3,000 people have died in Iran, with rights groups putting the figure closer to 3,600.

Washington DC: In a major security scare, the Federal Bureau of Investigation (FBI) and other law enforcement agencies reportedly disrupted an alleged plot targeting this weekend's UFC Freedom 250 event in Washington, DC, reported Fox News, citing officials. Until Monday (June 15), at least five people were taken into custody.

At least 23 people have been identified as (sic) plotters of carrying out the alleged attack. As per officials, the suspected plot involved deploying drones carrying explosives to strike buildings close to the event, triggering a large-scale evacuation and directing fleeing crowds toward a sniper unit positioned in advance.

According to authorities, the attackers had also allegedly planned a "second wave" operation, which involved attempting to breach the White House gates. The FBI came to know about the threat on June 10. A search operation was then launched to nab the plotters. One of the accused was arrested in Cincinnati.

Signal chats were later uncovered by the agency. In these chats, the suspects allegedly discussed attacking the UFC event, reported the media outlet. The investigation further revealed that one of the suspects' iPhones revealed that at least 23 Signal users held discussions about the attack. Some of the suspects even planned to travel to Fredericksburg, Virginia, on June 12 or 13 to make preparations for the attack.

Merlin Lu, 21, told NBC 5 Chicago that he was the person who burned the cross — but that he was protesting Trump. “In no way possible was that a hate crime. I understand why it was interpreted that way, and I apologize for that, but no, the intent was not there.” Pressed by NBC 5 on how he made it through four years in college without realizing how hateful burning crosses were, Lu admitted the extent of his research was reading a Wikipedia page.

“I just saw the Wikipedia page with the movie with the, like, I think it’s called like ‘Under One Nation’ or something like that,” he said, misidentifying the infamous 1915 movie “Birth of a Nation,” which popularized much of the modern KKK’s imagery. Exactly how it was supposed to be a protest of Trump was revealed in one small detail completely obscured by the flames, Lu claimed. “I put a red hat to signify the MAGA hat, the Make America Great Again hat,” he told NBC 5. “So that was, yeah, that’s what I tied on top. “I don’t want to wait till his term ends. I want him gone right now.”

Per Brazilian investigators, the latest findings from Operation *Rota do Norte* reveal a significant evolution in the relationship between transnational criminal organizations operating across South America. Authorities allege that the Venezuelan gang Tren de Aragua has established itself as a strategic supplier of heavy weaponry to Brazil’s Comando Vermelho (CV), providing assault rifles, .50-caliber machine guns, and grenade launchers capable of dramatically increasing the firepower available to Brazilian criminal groups.

Moreover, the case illustrates how the Tren de Aragua has evolved from a Venezuelan prison gang into a continental criminal enterprise with influence across multiple countries in the Americas. Although recent operations targeting its leadership may weaken the organization, security experts warn that its decentralized structure allows local cells and partnerships to continue functioning even after major leadership losses.

Ultimately, the findings of Operation *Rota do Norte* suggest that Brazil is no longer facing isolated domestic criminal organizations but increasingly integrated transnational networks capable of moving weapons, drugs, money, and personnel across national borders.

Multiple demonstrators arrested at the Delaney Hall ICE detention facility in Newark, New Jersey, came from outside the state, according to Newark police information and arrest sheets reviewed by the New York Post. At least two demonstrators were reportedly connected to the Sunrise Movement.

Anti-ICE organized resistance continues searching for terrain where it can force a confrontation with the Trump administration. Activists likely believe a new clash with ICE could rebuild momentum after Operation Metro Surge in Minneapolis ended. The Sunrise Movement remains part of the broader anti-ICE protest network and has supported direct-action tactics, including noise protests targeting hotels housing ICE agents during federal surges.

Analyst: The arrests signal that immigration enforcement sites remain priority targets for organized protest networks. Ordinary Americans could see disruptions around detention facilities, federal buildings, local police deployments, and surrounding neighborhoods. The primary risk is copycat action designed to provoke federal response and generate media momentum. Watch for protest calls, outside activist travel, detention-site security changes, and additional arrests near ICE facilities.

Passaic Man Charged with Attempting to Provide Material Support to ISIS

Mohamed Sagha, 22, of Wayne, New Jersey was charged by complaint with one count of attempting to provide material support and resources to ISIS. He made his initial appearance today in federal court. He was ordered detained.

“...As alleged, the defendant sought to support ISIS and expressed interest in violence directed at targets within the United States, including places of worship,” said U.S. Attorney Robert Frazer for the District of New Jersey. “Those who seek to advance the objectives of foreign terrorist organizations should expect a swift and coordinated response from federal

law enforcement. This Office will continue working relentlessly with our law enforcement partners to identify, disrupt, and prosecute individuals who support terrorism and threaten the safety of our communities...”

“The defendant allegedly wanted to attack targets in the United States in support of ISIS and its hateful ideology, but the FBI detected and put a stop to his violent plans,” said Assistant Director Donald Holstead of the FBI’s Counterterrorism Division. “This should be a stark reminder to the American people of the FBI’s resolve to pursue anyone who tries to harm Americans and provide material support to terrorist organizations, and we will work with our Justice Department partners to make sure they face justice.”

According to documents filed in this case and statements made in court:

From approximately December 2025 to June 2026, Sagha participated in one or more online chat groups wherein ISIS supporters discussed, among other things, potential attacks on targets within the United States, including places of worship. In or around October 2025, he met a confidential human source (“CHS”) online, whom he believed to be a member of ISIS.

In his discussions with the CHS, Sagha expressed an intent to assist one of the members of an ISIS-supporters online chat group with an attack on a place of worship. He also told the CHS he was contemplating carrying out an attack of his own, possibly on a National Guard location or on a Jewish place of worship. He then shared images and/or videos of both locations with the CHS, and stated that they were near his residence in Wayne, New Jersey.

During these conversations, the CHS repeatedly held himself out as an ISIS fighter, sending Sagha messages and photographs that indicated the CHS was in ISIS territory in Syria. These included a photograph of the CHS in the back of a truck holding an ISIS flag, as well as a photograph of the CHS leaning against a vehicle over which the ISIS flag was draped, holding what appeared to be an AK-47-style assault rifle. Sagha, in turn, repeatedly expressed a desire to travel to ISIS territory, and even made an unsuccessful attempt at doing so in early March, 2026.

Between on or about May 31 and June 2, Sagha and the CHS discussed the use of a Virtual Private Network (VPN) for the CHS and other ISIS fighters referred to as “brothers.” VPN

technology enables users to conceal their online activities, mask their locations and identities, and communicate with greater anonymity. In the hands of members of a foreign terrorist organization, the technology can assist efforts to evade detection, maintain communications, and further the organization's activities. Sagha ultimately purchased a VPN, sent it to the CHS — whom he believed to be a member of a terrorist organization — and explained to the CHS how to use the VPN.

The count of attempt to provide material support and resources to a foreign terrorist organization has a maximum penalty of twenty years' imprisonment, a \$250,000 fine, and a term of life of supervised release.

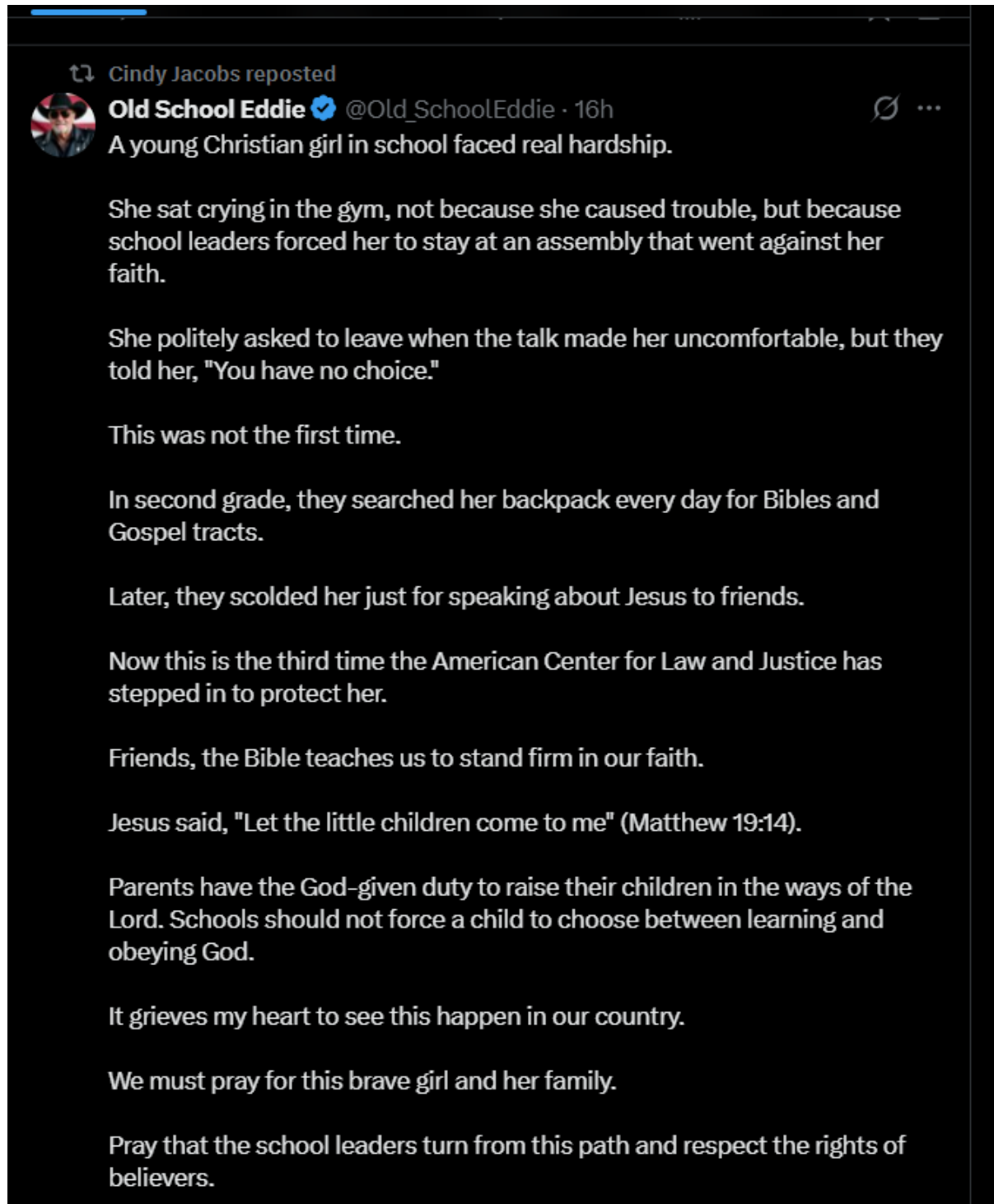

All 5 victims were transported to a hospital in non-life-threatening condition and treated for skin burns and peeling.

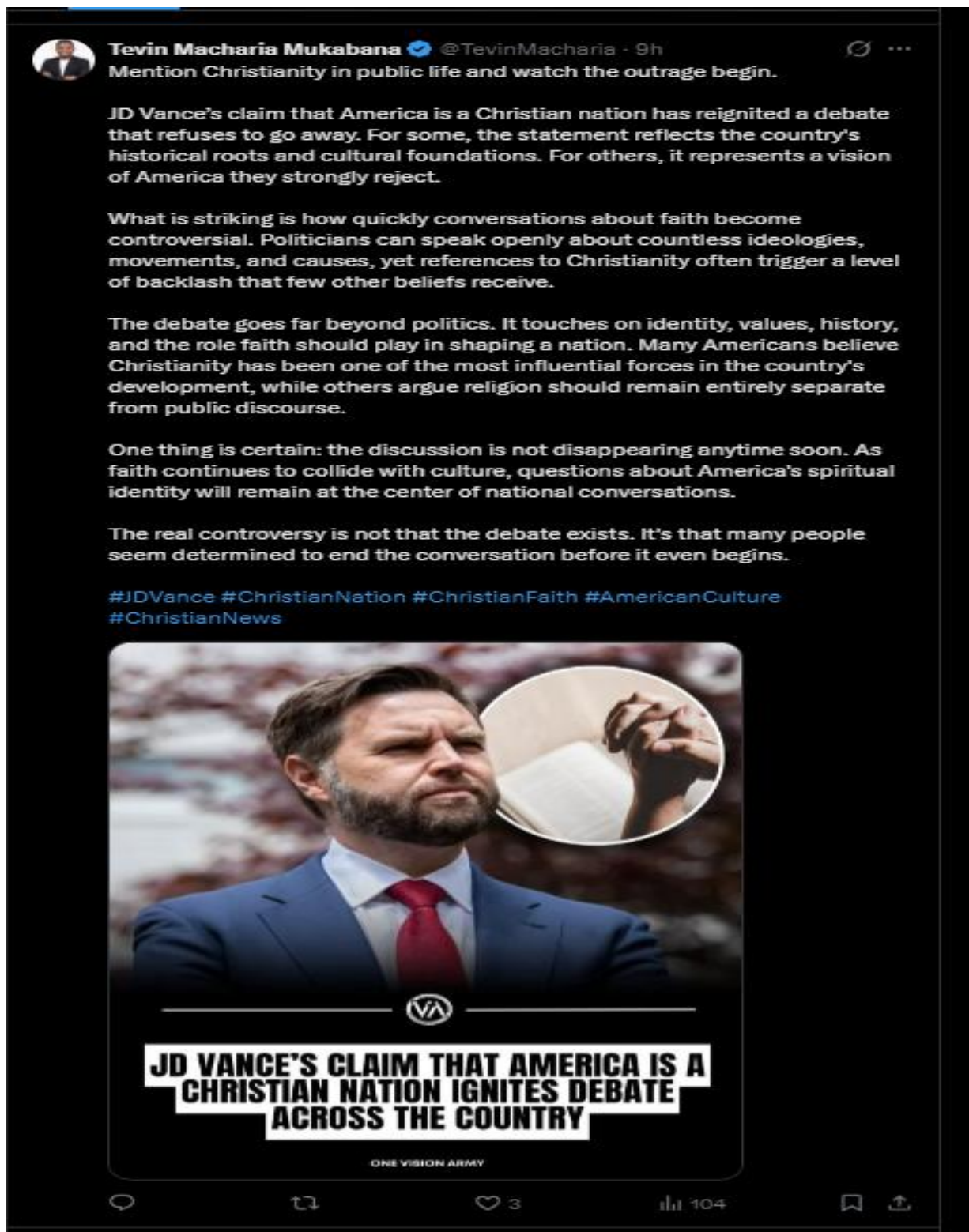
