Bisaam Ghafoor, 21, of Leawood, Kansas; Elias Shamsaldeen, 21, of Porterville, California; and Bereen Dzayee, 25, of Lakeside, California, were arrested on a complaint filed in the District of Kansas for conspiring to provide material support to terrorism after collectively providing over \$2,000 to an individual they understood to be a member of ISIS.

- Electronic messaging, Ghafoor exclaimed it would be “sick” if his name could be written on the drone used in an attack on Americans.
- Dzayee suggested that targets of drones should include U.S. Special Forces.
- Shamsaldeen expressed a desire to stab and injure a U.S. servicemember. Ghafoor said he has always wanted to kill a female soldier by beheading, and added, “I wish I could kill 300,000,000 Americans.”

- From at least February 2025 to about June 2026, the suspects communicated about several plans to support ISIS, including through the provision of personnel, services, and money.
- Through Discord chats, voice calls, and other messaging platforms, they pledged allegiance to ISIS and its leader. They're also accused of exchanging messages in social media groups promoting violence in furtherance of ISIS.
- Ghafoor's name was written on the projectile of one of the rocket-propelled grenades purportedly to be used in an attack overseas to kill U.S. servicemembers. Shamsaldeen allegedly provided financial resources for the purpose of purchasing drones, which, in turn, were to be used to attack and kill U.S. servicemembers deployed overseas.
- The suspects and others communicated their desires to travel outside the United States to fight on behalf of ISIS, the release said. In some of these communications, they expressed a willingness to die on behalf of ISIS.

The finding comes from the Center for Strategic and International Studies (CSIS), whose [Global Terrorism Threat Assessment 2026](#) names terrorism in Africa as the greatest source of uncertainty in the U.S. threat picture. Nearly 80 percent of all Islamic State activity worldwide during the first 11 months of 2025 took place in Africa, a 50 percent increase over the prior year, according to Armed Conflict Location and Event Data (ACLED) figures cited in the report. The continent has become the group's center of gravity, and two organizations anchor the threat there.

The report assesses the Islamic State West Africa Province (ISWAP), active across the Sahel and the Lake Chad basin, as probably the largest and most capable Islamic State province anywhere in the world. Its closest rival for that distinction is al-Shabab, the al-Qaida affiliate in Somalia, which the authors call Africa's most capable group overall and the only one known to have plotted a mass-casualty attack against the U.S. homeland.

The St. Paul City Attorney is refusing to prosecute the invaders who disrupted a church service at Cities Church. The church's attorneys condemned the decision. The attorneys representing Cities Church in St. Paul, Minnesota, condemned the local prosecutor's decision not to press charges against agitators who invaded the church in the middle of a January service.

City Attorney Irene Kao announced Tuesday that she would not press charges against the agitators, who staged a takeover inside the church's sanctuary. The agitators said they opposed the church because one of its pastors works for Immigration and Customs Enforcement.

"This decision should not be interpreted as an endorsement of unlawful behavior or public disorder," Kao said. "The right to peacefully protest is protected, as is the right to exercise one's religious beliefs. Balancing these equally important rights is paramount to our decision today." "However, acts of violence, property destruction, or threats to public safety—none of which occurred here—remain serious concerns and will be prosecuted when supported by admissible evidence," she added.

The Church Responds

True North Legal attorneys representing Cities Church, a reformed evangelical church affiliated with the Southern Baptist Convention, condemned the decision.

"The St. Paul City Attorney assures the public that violence, property destruction, or threats to public safety would have been prosecuted, but that draws an arbitrary line that conveniently excludes statutory charges for other kinds of unlawful conduct," Renee Carlson, general counsel at True North Legal, said in a statement Wednesday. "Just because the agitators didn't break any windows doesn't mean they didn't break the law."

"The St. Paul City Attorney's decision treats the church like it's a public sidewalk—as if the sanctuary were an open forum that anyone may seize mid-service, rather than private property where a congregation has the right to worship undisturbed," Doug Wardlow, director of litigation for True North Legal, said.

“By wrongly characterizing the invasion and takeover of a worship service as First Amendment-protected conduct, the city attorney’s office sends an unmistakable signal: The law will bend for those whose cause aligns with the politics of those in power,” he argued.

Jonathan Parnell, the church’s lead pastor, warned that this precedent would excuse the invasion of a mosque or other houses of worship, as well.

“According to the St. Paul City Attorney’s logic, it is perfectly fine for agitators to invade a mosque, a cathedral, or a temple, intimidate the families and children inside, and shut down their religious gathering,” he said. “Just call it a ‘protest.’”

“City Attorney Irene Kao’s decision not to charge the agitators who invaded our church on January 18, 2026, leaves us to question whether her commitment to protect religious people includes evangelical Christians,” Parnell added.

ST PAUL, Minn. — No state criminal charges will be filed in connection with a January protest at a St. Paul church. The St. Paul City Attorney's Office reviewed the incident after dozens of people were arrested for entering Cities Church on Jan. 18 to protest against Pastor David Easterwood, saying he held a local leadership position with Immigration and Customs Enforcement.

Among the people arrested were [journalists Georgia Fort and Don Lemon](#), as well as [attorney and activist Nekima Levy Armstrong](#). "Our office has a legal and ethical obligation to file charges only when the available evidence establishes probable cause and supports a reasonable likelihood of conviction beyond a reasonable doubt," the St. Paul City Attorney's Office said in a statement Tuesday. "Following a careful evaluation of the video footage, investigative reports, and other available materials, prosecutors determined

Attendees of Cities Church in St. Paul continue to be harassed by anti-ICE protesters every Sunday when they attend worship services, a churchgoer recently told Crime Watch Minneapolis. Cities Church was invaded by an anti-ICE mob on Jan. 18 when individuals halted the service and encircled churchgoers and pastors, screaming chants and recording.

The mob, led by activist Nekima Levy Armstrong and St. Paul school board member Chauntyll Allen, entered the sanctuary after the sermon began and interrupted lead pastor

Jonathan Parnell’s prayer with shouts of “Justice for Renee Good” and “ICE out.” Video footage showed agitators screaming in the faces of women and children, and harassing families as they tried to leave. Court documents allege that the agitators blocked stairways to the childcare area, preventing parents from reaching their children amid the chaos.

The disruption stemmed from claims that Cities Church pastor David Easterwood holds a leadership role with ICE. The mob accused the church of “harboring” an ICE agent following the fatal shooting of Renee Good by an ICE officer earlier in January.

Crime Watch Minneapolis posted to X saying that protesters have been present outside the church building every Sunday since the initial incident. “They block the sidewalk and are cussing us out as we walk into church,” a churchgoer said.

A March 22 post to the 50501 Facebook group shows protesters standing outside the church holding signs. “Bring the heat, melt the ICE,” one individual’s sign reads. “Detox from FOX,” another says.

“This is a weekly protest,” the Facebook post says.

The churchgoer told Crime Watch Minneapolis that attendees can hear the protesters during and after the service. “We are followed and they now have high res cameras. They are taking pictures of us walking into church and are threatening to follow us, take pics of our plates and publish photos of our faces,” the person said.

They explained that police have told them that what the protesters are doing is not illegal. “I just want the freedom to worship without [fear] and not be hounded or harassed,” the person told Crime Watch Minneapolis.

Federal authorities have launched investigations and pursued charges against participants in the Jan. 18 mob, including for potential violations of the Freedom of Access to Clinic Entrances (FACE) Act, which also protects places of worship. Arrests have included Armstrong, Allen and former CNN anchor Don Lemon, who livestreamed the event.

Cities Church leaders called the incident shameful and unlawful, while Southern Baptist figures and lawmakers condemned it as an attack on religious freedom.

Man Who Threatened To Bomb TPUSA Event Spent Months Obsessing Over Erika Kirk

Wenske was a politically active left-wing social media user whose online activity became increasingly saturated with anti-MAGA and anti-TPUSA content in the months before his arrest. He devoted growing attention to Erika Kirk ahead of the attack, according to an open-source intelligence report from the Network Contagion Research Institute, which analyzes online activity.

The NCRI researchers describe Wenske as having an unusually large and exposed digital footprint centered on Facebook — a platform they noted is increasingly uncommon for someone his age to use so heavily. A review of a 170-page archive of his public posts showed a near-constant stream of political content, particularly following the September 2025 assassination of Charlie Kirk.

Researchers said Wenske’s account posted multiple times daily following the TPUSA founder’s assassination, with content frequently focused on “Christian nationalism,” Trump supporters, ICE, and right-wing politics before activity slowed somewhat in December. Wenske repeatedly used and amplified the phrase “Christian nationalism” online — the same language later referenced in the alleged threats sent to TPUSA.

According to official documents, Wenske called for the deaths of “Christian nationalists” in a bombing he claimed would occur at every TPUSA rally or event.

Researchers also found extensive engagement with online creators known for anti-conservative content, including Sammy Obeid, Harry Sisson, Cameron McCloud, April Ajoy, Isaiah Martin, Dean Withers, and The Butterfaces. Wenske frequently reposted their videos that mocked Charlie and Erika Kirk, often using hashtags such as #erikakirk, #charliekirk, and #jdvance.

Wenske repeatedly shared posts that mocked Erika Kirk, portrayed her as a grifter, circulated conspiracy-themed content about her public profile, and reposted videos speculating about a relationship with Vice President JD Vance.

A well-stocked anti-ICE coalition tent outside New Jersey’s [embattled Delaney Hall immigration detention center](#) was raided by federal authorities Monday — exposing what activists were keeping inside as mayhem continues to plague the area.

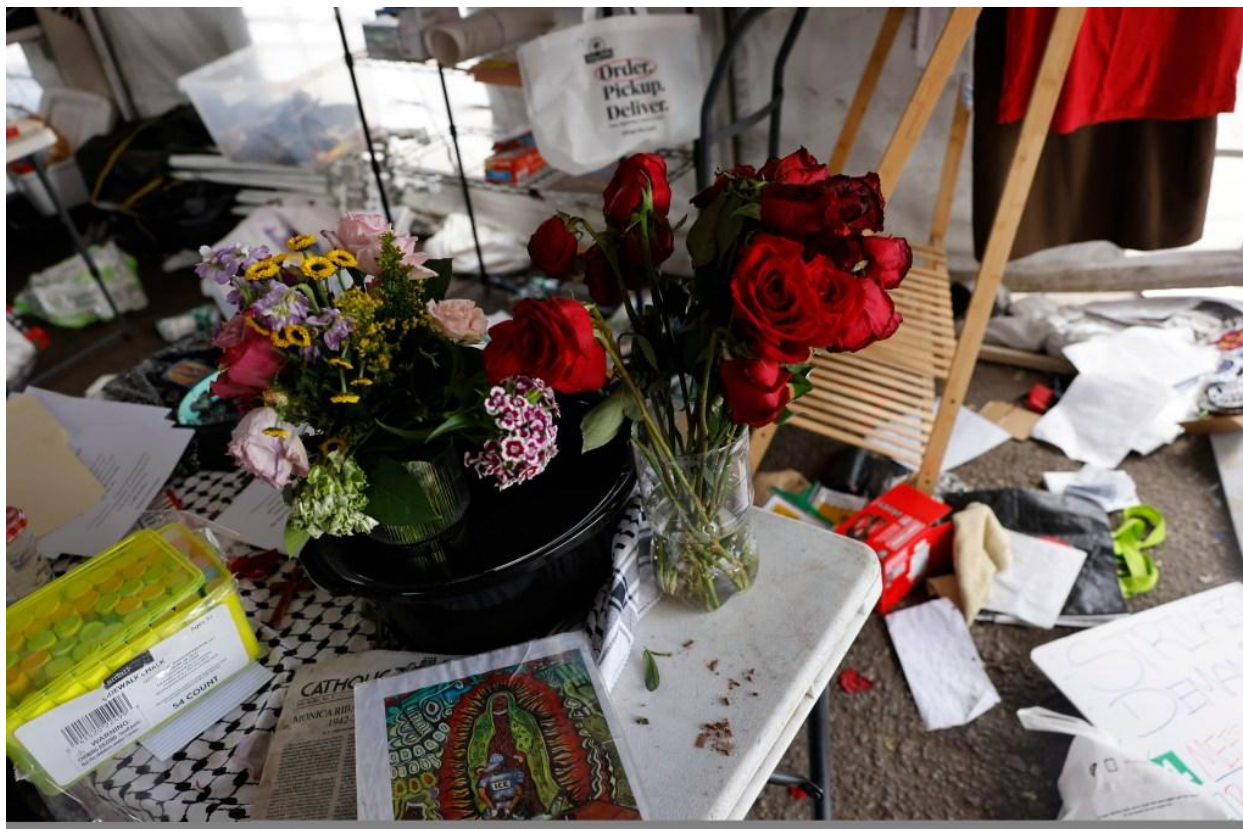

At 11:30 a.m. on June 3, an activation signal went out on social media calling protesters and agitators to swarm Delaney Hall, the Newark, N.J. ICE detention facility that has become one of the nation's most contentious immigration battlegrounds.

"CURFEW IS OVER. BACK TO DELANEY," read an Instagram post, promoted by a fiery collection of anti-Israel, Marxist and Democratic organizations — from "Palestine Solidarity Working Group" and Al-Awda to Indivisible and 50501 — that have joined tumultuous against the ICE, Newark police and New Jersey state troopers over the past couple of weeks.

Within minutes, the call to action spread through secret groups on Signal, an encrypted messaging platform, activating hundreds of anti-ICE activists with secret monikers like "framed.unrest" and "Wicked Something," collaborating on transportation, logistics and supplies, like goggles, protections against pepper spray, respirators and protective knee pads.

A Fox News Digital investigation, gathering information on the ground in Newark, in secret chat groups on Signal and from scores of tax filings, strategy documents and social media posts, reveals the protests outside Delaney Hall are no organic outpouring of spontaneous rage. They are the result of years of strategic planning by a network of well-funded, well-organized groups that have once again exploited a local controversy to wage a wider attack on federal immigration policies and the U.S. in general.

The activities of this network have motivated a group of tech sleuths on the X — @DataRepublican, @Astrarce, @bitchuneeedsoap and @gunshymartyr — to penetrate these groups, their Signal chats and their operations like a digital Avengers squad.

According to Fox News Digital's analysis, the network behind the Delaney Hall protests includes about 100 groups, some of them big names like the ACLU, Indivisible and Democratic Socialists of America. Together, these organizations report collective annual revenues of about \$825 million, approximately equal to the annual budget of Newark. The groups didn't respond to requests for comment.

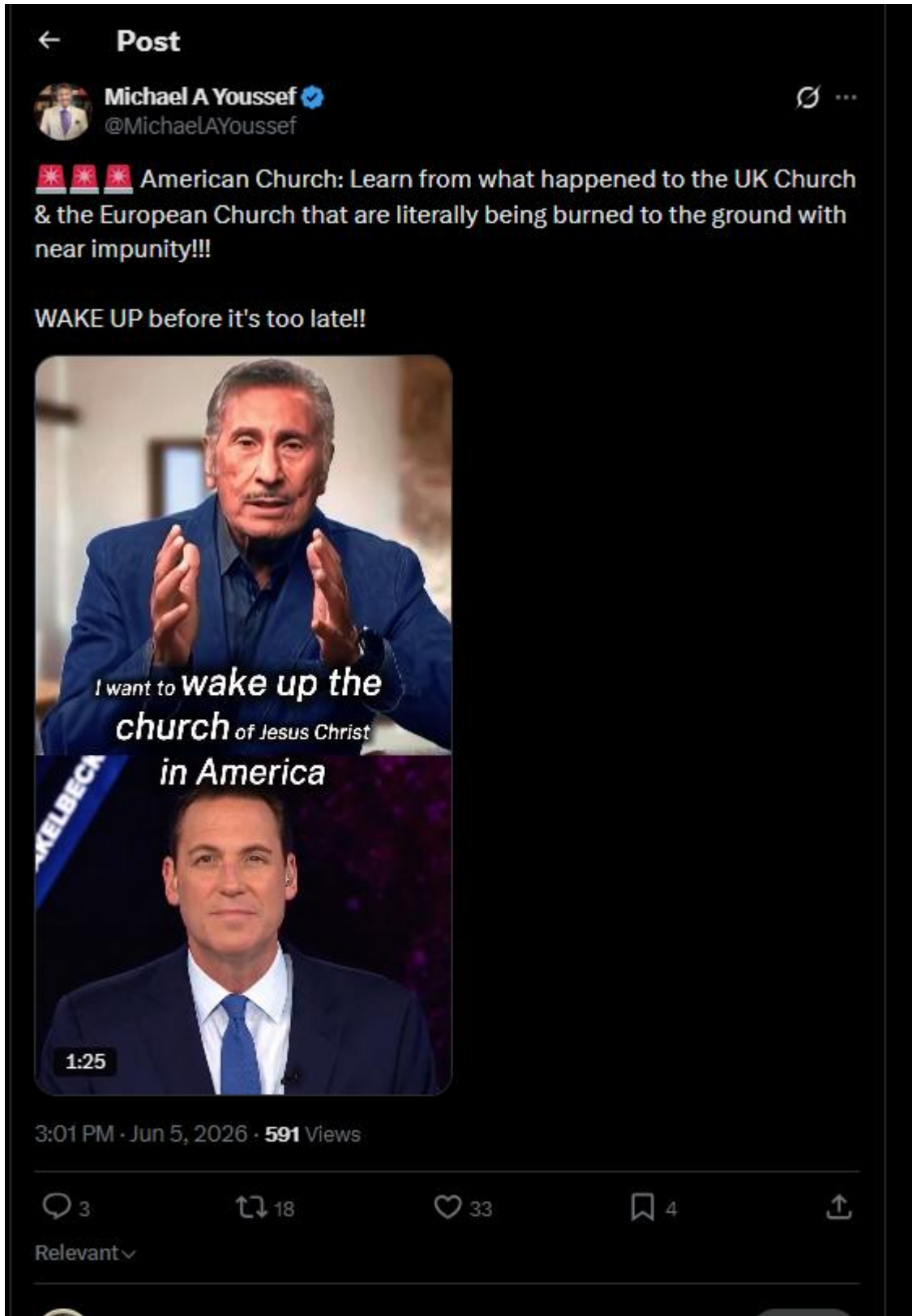



MAYOR RAS J. BARAKA STATEMENT ON SCALING BACK POLICE PRESENCE AT DELANEY HALL

"For the past year, advocates have peacefully assembled at Delaney Hall with discipline, purpose, and unwavering commitment.

"That commitment was disrupted on Memorial Day, when a sharp and troubling shift occurred. ICE increased its presence and engaged protesters in ways that escalated tensions and led to unnecessary confrontation.

"Since the City stepped in, we have worked to restore calm and uphold our values. As a result of our involvement, arrests have dropped dramatically, from 80 to just 3. We have accomplished this without the use of force, tear gas, or aggressive policing. The Newark Police Division has remained focused on de-escalation and ensuring protests remain peaceful.

"We must also be clear about the limits of the City's role. It is not the responsibility of the Newark Police Division to secure a private facility. We have made clear to the GEO Group, who has its own private security firm, that securing their facility is their responsibility, not the City's. Our intention was never to protect Delaney Hall or HSI but to bring calm. It is a clear contradiction to the City's position with GEO group to remain there.

"Therefore, we will not continue to spend resources and tax dollars in an already strapped budget to safeguard a privately-owned facility, especially when it places our officers at unnecessary risk. Nor will we ask our officers to engage in practices that contradict our values of fairness, restraint, and respect for human rights.

"Given the significant reduction in arrest, the City will begin scaling back its presence at Delaney Hall. After tonight, NPD will focus on traffic management and public safety, ensuring the protection of both protesters and motorists.

"We urge all protesters to remain peaceful so that attention remains focused on the urgent health and safety needs of detainees and the closing of Delaney Hall."

Cooper has built her career on this kind of rhetoric. Rutgers keeps promoting her while the school takes in hundreds of millions of dollars in federal taxpayer funding every single year. Swap the races. Picture a white tenured professor at a major state university saying the exact same thing about Black Americans. That person would be gone by the next afternoon with wall-to-wall media coverage. Yet Cooper remains in her position years later.





Taxpayers should not be forced to subsidize this. Public universities have rules against creating hostile environments based on race. When professors cross that line on camera while collecting a government funded paycheck something has gone seriously wrong in higher education.

What will it take for universities to apply the same standards to everyone?



Braxton walked participants through “covert” and “accountable” direct action, explaining that covert actions allow activists to hide their identities and act “again and again,” while accountable actions mean “you can do more damage” because you are not planning an escape.

Braxton also described the group’s action agreement, which states that its actions seek to “disrupt, damage and destroy” targeted companies. She emphasized that actions operate on a “need to know basis” and warned participants involved in covert actions to ensure they cannot be identified in photos or videos.

Government and law enforcement can look away if they want, but that is on them. The purpose of this workshop was to recruit and mobilize like-minded individuals. This is not going away. It is spreading, organizing, and clearly ramping up.



He is now suing the Los Angeles County for religious discrimination and harassment.

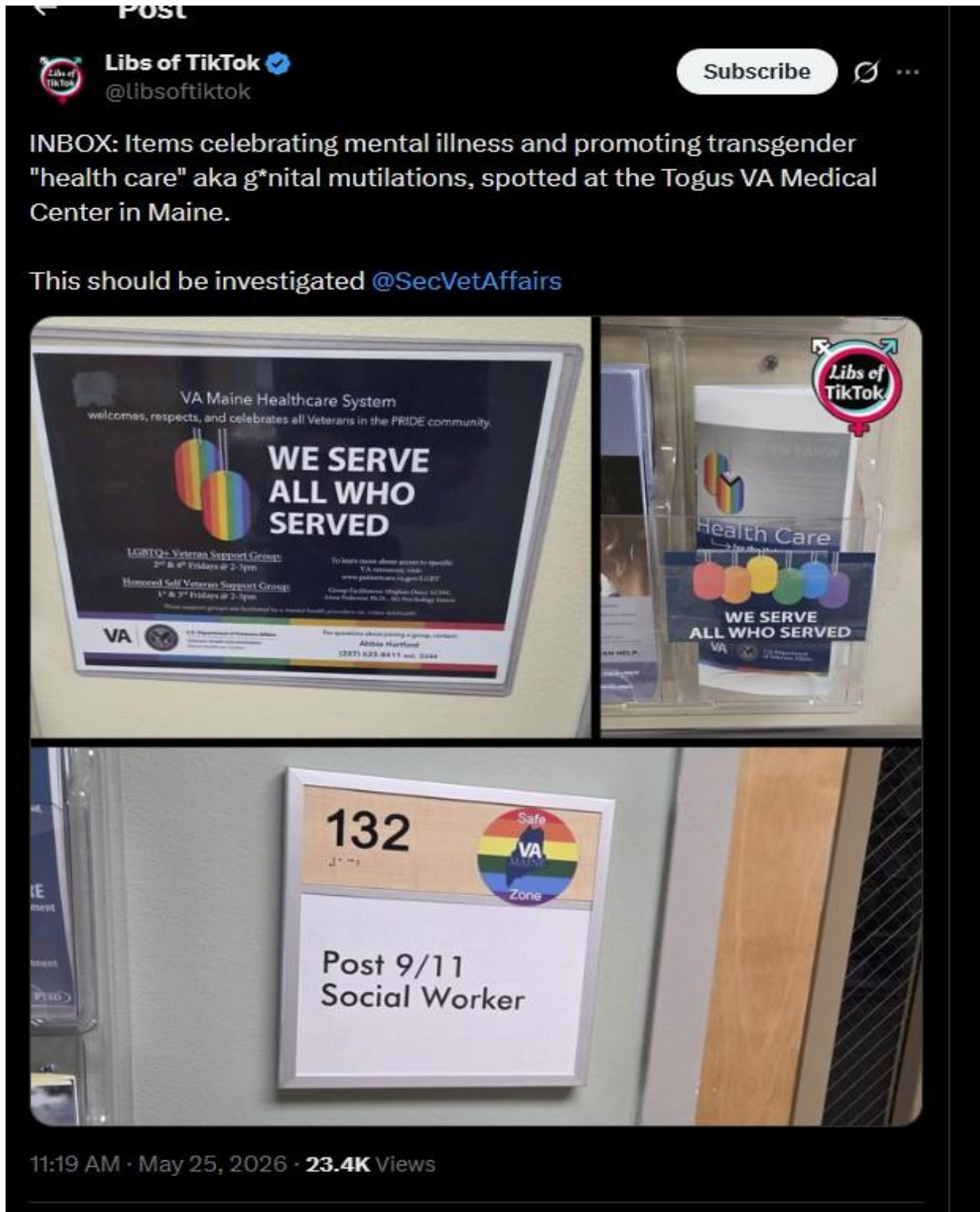
