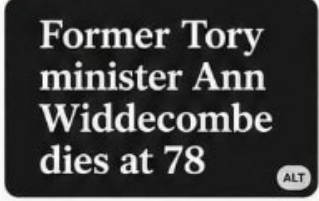

Responding to a reported domestic dispute. The caller told dispatchers their ex-spouse, 36-year-old Allison Howlett, had stolen their car that had several firearms inside. The caller said Howlett indicated wanting to carry out a mass shooting and die at the hands of police. SUBJECT was located at the Sunset Station casino parking garage. HE barricaded in the vehicle, where HE was sitting on a handgun in the driver's seat and had access to a fully automatic silenced MP5-style weapon in the backseat.

Police recovered from that vehicle 22 firearms and multiple rounds of ammunition. The search executed at SUBJECTS residence, another 30 firearms, grenade launchers, suppressors and thousands of rounds of ammunition, according to Koren. SUBJECT is known to police by several threats HE made over a period of time, including threats of wanting to become an active shooter and commit a mass attack in Las Vegas in 2024. Howlett's charges include making a threat related to an act of terrorism, assault with a deadly weapon, grand larceny, resisting a public officer with a firearm and multiple weapons-related offenses.

The Presbyterian Church (USA), the largest Presbyterian denomination in the United States, has passed a measure expressing support for body-deforming sex-change surgeries for youth exhibiting gender dysphoria. At a plenary session for the PCUSA's 227th General Assembly held last week, delegates voted 441-30 in favor of an overture called GEN-02, also known as "On Access to Healthcare."

The rationale for the overture describes so-called "gender-affirming care" as "medically necessary and evidence based for the well-being of many transgender, non-binary, and gender-expansive people who experience symptoms of gender dysphoria or distress that result from having one's gender identity not match their sex assigned at birth."

GEN-02 also denounces state bans on the chemical and surgical mutilation of children's bodies, labeling them as stopping young people "from accessing medically necessary, safe health care backed by decades of research and supported by every major medical association representing over 1.3 million US doctors."

The Rev. Olivia Lane, moderator of the 227th General Assembly's Gender and Sexuality Justice Committee, explained to those gathered that her committee amended the overture to remove the phrase "including minors" from the text, which originally read "the PC(USA) supports all individuals, including minors, to have access to all medically necessary, evidence-based gender-affirming healthcare."

(Florida) Deputies arrested a man at a North Fort Myers gas station who is accused of making bomb threats and saying he worked with the so-called Islamic State (ISIS). Israel's Channel 14 has reported that Iran's Islamic Revolutionary Guard Corps (IRGC) Quds Force has allegedly established a new unit known as Mukhtar, aimed at targeting U.S. officials, including President Donald Trump. Texas Man Arrested For Making Interstate Threats Targeting Synagogues, Zionists

(Texas) Ryan Thomas Griffin, of Austin, Texas, was arrested on Tuesday for allegedly making interstate threats targeting Jews, synagogues, and federal employees after the FBI linked him to months of violent, antisemitic posts on the social media platform Gab. According to an FBI affidavit filed on Monday in the U.S. District Court for the Western District of Texas, Griffin, 35, allegedly wrote, "I'm just a random nobody in the U.S., and I can pick any synagogue I want and go postal on it."
