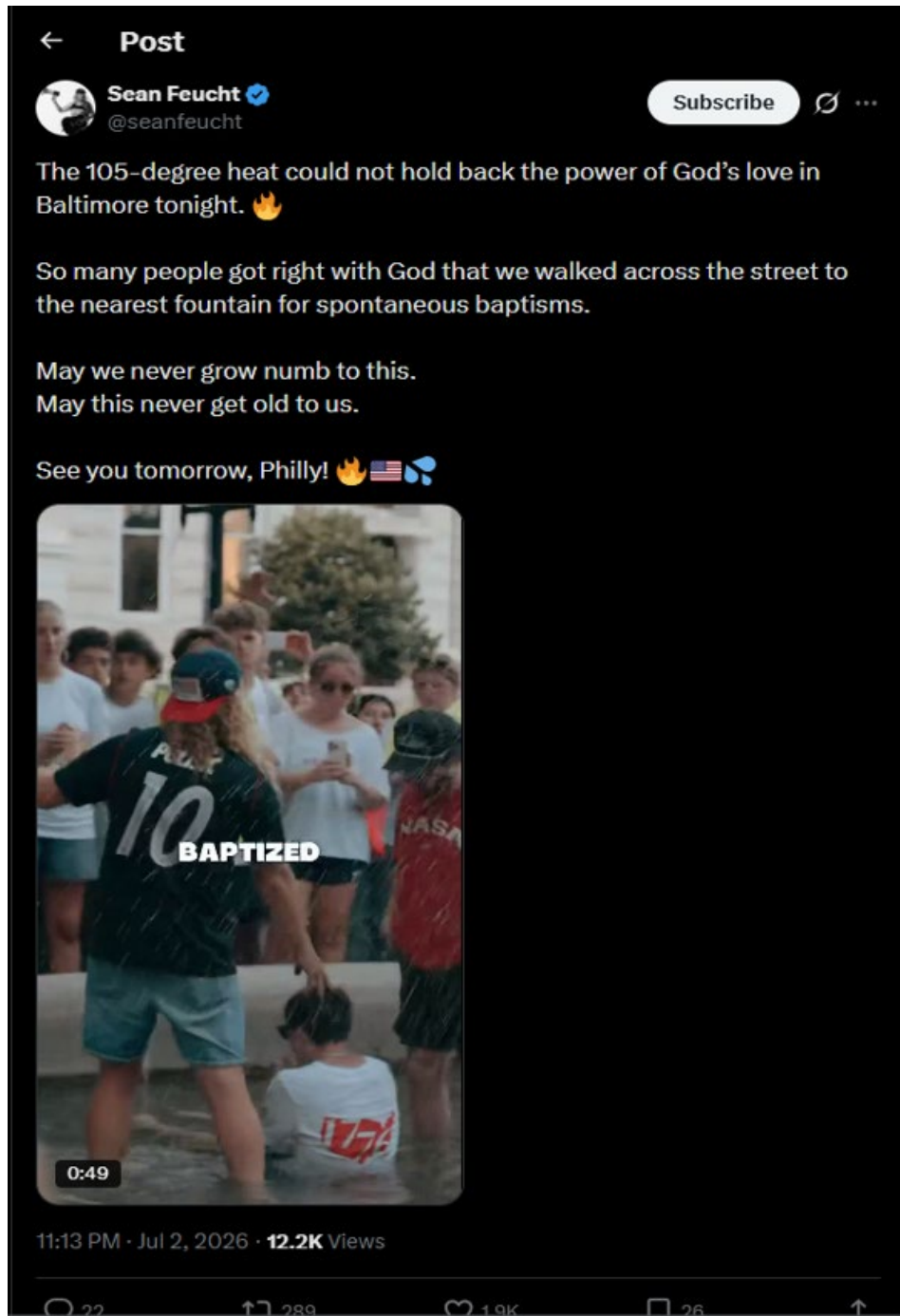

ALERT: Airport worker arrested for allegedly stealing a traveler's gun after he tracked it down using an AirTag.

Multiple travelers at the Portland International Airport in Oregon reported their firearms missing from their checked bags, which sparked an investigation by the FBI.

Through security footage, the FBI found that 51-year-old Terell Wayne Overton had access to the missing guns while loading bags onto the departing flights.

One customer had an AirTag in his Glock carrying case and tracked it down to an Alaska Airlines baggage area.

The FBI watched the security tapes and tracked Overton, whose movement corresponded to the AirTags.

Overton, who was convicted of selling cocaine in 2005, has been charged with theft and being a felon in possession of a firearm.

sustained assault could combine military, humanitarian and atrocity risks on a scale comparable to, and potentially worse than, the fall of El Fasher in October 2025.

El Obeid is a strategic corridor linking Darfur, Kordofan, central Sudan and the Nile Valley. It is also a humanitarian hub and a shelter city for large numbers of internally displaced people. Reported RSF and allied force build-ups around the city, combined with drone strikes on power, water, fuel and communications systems, have created the conditions for a predictable civilian catastrophe. The warning signs are visible.

Prevention remains possible, but only if international actors move from documentation and concern to deterrence and consequence.

Armed separatist rebels in Indonesia's easternmost Papua region claimed responsibility for an attack on a civilian aircraft, alleging they killed an American pilot and set the plane on fire after it landed in a conflict-hit area. Sebby Sambom, spokesperson for the TPNPB, said the group's fighters shot dead American pilot Nicholas F. Gosselin after his aircraft landed in the Balinggama district. According to the separatist group, the aircraft was allegedly being used to transport Indonesian military personnel into areas where clashes between security forces and rebels have intensified.



CARTEL DRONE OPERATIONS EXPANDING NEAR TEXAS BORDER

Customs and Border Protection agents near Presidio, Texas were warned of increased Sinaloa Cartel activity following the arrest of two armed cartel members this week. Investigators determined that the Cabrera faction of the Sinaloa Cartel is using drones to transport explosives for use against rival cartel factions south of the U.S.-Mexico border.

Analyst:

Investigators said the group is linked to overdose deaths, shootings and drug trafficking across Volusia County. Channel 9 first reported the operation Tuesday morning. Volusia County reporter Demie Johnson was the only reporter who rode along with the sheriff's office as SWAT teams raided a home on the property of Greater Harvest Ministries Church.

But concern is growing about deliberate arson, particularly in France, where a number of attacks have hit the headlines. A church steeple caught fire in Saint-Omer in northern France in September, with signs of forced entry. In 2016, a team of young jihadists attempted to set fire to Notre Dame Cathedral, but were caught and imprisoned, fuelling rumours that the 2019 fire was not accidental and the authorities were not honest about the cause.

This is why videos of church fires feature regularly on right wing social media, often with sarcastic comments such as “strange coincidence” or “I’m sure it’s just an electrical fault.” They imply Islamists are to blame, fuelling an anti-immigrant narrative. Yet it could be argued that Reuters ignored the real story: more reliable evidence of widespread attacks against churches that are fuelled by hatred of various kinds, of which Islamic extremism is just one.

[To this end, a map of France covered in red marks has been widely shared on social media, purporting to show a church arson crime wave. It was declared “false” or “misleading” by Reuters because it is out of date and represents an unofficial blog’s tally of all vandalism against churches – not just arson.](#)

The fire that destroyed St. Paul CME Church in Crawford, Alabama, is being investigated as a crime. According to Special Agent J. Bryce of the Alabama State Fire Marshal's Office, authorities are awaiting some lab results on evidence collected from the scene of the June 22 church fire. Webster County Sheriff's Office and the GBI are investigating a double homicide near Preston, Georgia. Bryce told WRBL on Monday that the lab results are expected to come soon, possibly within the same day. **He said he's not ready to say arson was the cause, but that the investigation is criminal in nature. The church had been standing since 1865. The fellowship hall was relatively new. It too was lost in the fire.**

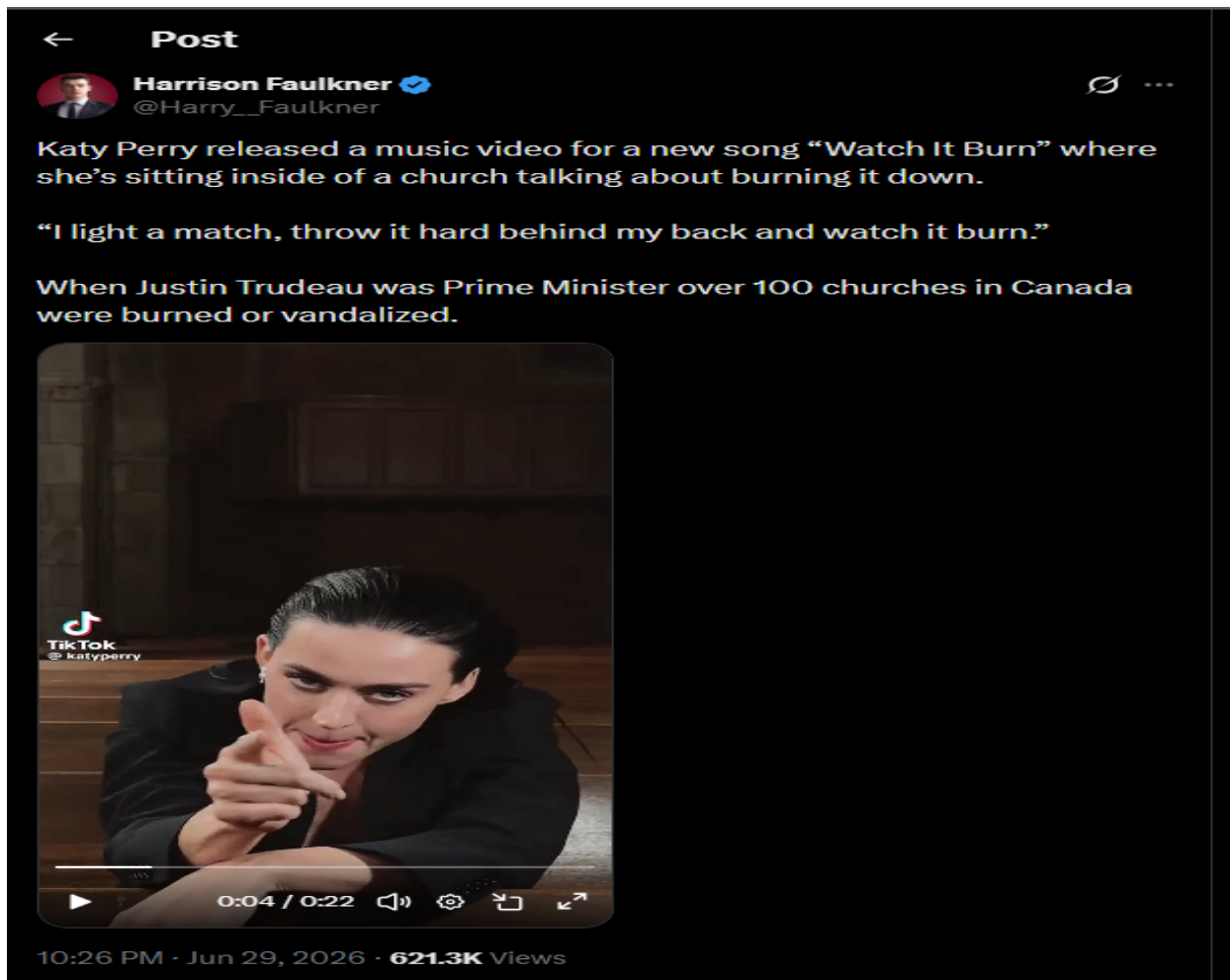

FIRST ON FOX: A New York woman accused of leading a radical extremist group and posing with hand grenades in front of a Hamas flag has been arrested after allegedly funneling tens of thousands of dollars to a Palestinian terrorist organization.

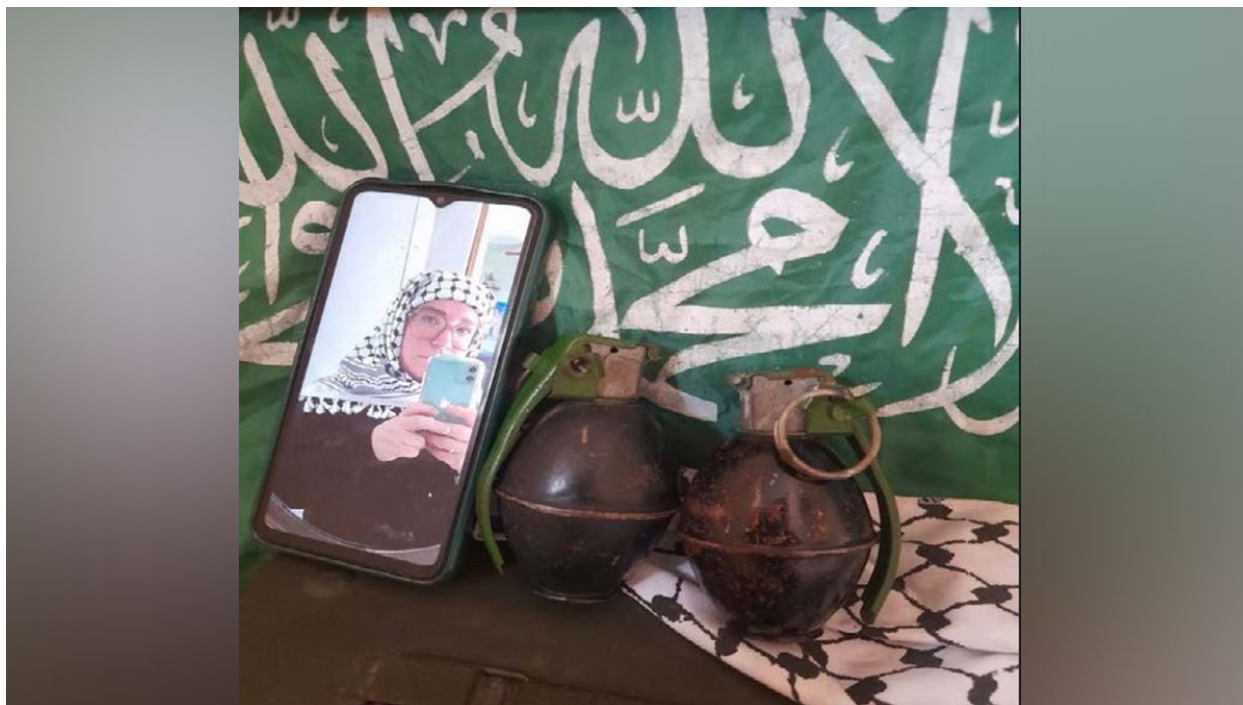
Catherine Beth Washburn, 37, of Irondequoit, a suburb of Rochester, is charged with attempting to provide material support to the Palestinian Islamic Jihad (PIJ), a designated Foreign Terrorist Organization. If convicted, she faces up to 20 years in federal prison and a \$250,000 fine.

Washburn was the leader of the **Direct Action Movement for Palestinian Liberation (DAMPL)**, a radical organization formed in the wake of the Oct. 7, 2023, Hamas terrorist attacks on Israel, according to the Justice Department.

The federal complaint noted that DAMPL rejects peaceful protests, opting instead for "direct action," including property destruction and acts of sabotage against entities it associates with Israel.

ALBANY, NEW YORK – Aaron Corey, a.k.a. “Baggeth,” age 23, of Albany, New York, has been charged in a federal criminal complaint with attempted murder for hire, solicitation of a crime of violence, and obstruction of justice, related to his attempts to hire a hit man kill the two FBI Special Agents and the Assistant United States Attorney (“AUSA”) assigned to investigate and prosecute him in an unrelated federal criminal case.

According to the complaint, the inmate who received Corey’s letters sent them to his attorney, who informed the FBI, and at the FBI’s request the other inmate provided the phone number of an undercover law enforcement officer (the “UC”) to Corey. The complaint further alleges that Corey, believing the UC to be a real hit man, wrote a letter to the UC offering to pay \$200 down and \$5,000 total for his electronic devices to be stolen

Corey allegedly spoke with the UC multiple times and arranged for his fiancée, who lives abroad, to send the requested down payments of \$200 and \$500 to the UC, which she did.

The complaint, which was unsealed today, alleges that Corey self-identifies as a member of the “764,” a criminal organization of Nihilistic Violent Extremists operating within the United States and abroad. Among other things, those involved with the 764 network methodically target vulnerable, underage populations by using social media to encourage the possession, production, and sharing of extreme gore media and child sexual abuse material (CSAM).

The complaint further alleges that Corey, who is being detained pending trial on unrelated federal child pornography charges, sent multiple letters to another inmate asking for help to hire someone to steal from the FBI the electronic devices seized from him for use at his upcoming trial and to murder the two FBI agents and the AUSA assigned to that case. Specifically, Corey allegedly directed that the victims be kidnapped, injected with fentanyl, and then put through a woodchipper. When the AUSA assigned to Corey’s case left the U.S. Attorney’s Office to take another job, Corey allegedly updated his request and added to his hit list the name of the AUSA who took over the case.

The NCTV says the overall risk of a terrorist attack in the Netherlands remains “substantial,” unchanged from six months ago and still at the fourth level on a five-point scale. The agency notes that jihadist-related threats remain the main driver of this risk but says the number of attacks has been limited thanks to “effective and timely intervention” by police and intelligence services.

It is very difficult to understand the rationale of this blatant and complex attack considered simply a “homegrown extremist.” While the threat there remains low, reminiscent of the recent NYC and New Orleans attacks, the very title above attributes ISIS linkage, and SUBJECT’S Home of Record is listed as Alexandria, Virginia, indicative of (1) Foreign enemy nexus and (2) Interstate Travel coming under FBI-JTTF purview.

(The) NJOHSP assesses that while the threat to New Jersey from ISIS remains low, homegrown violent extremists may draw inspiration from the foreign terrorist organization and could engage in violence, as developments in the Middle East continue to receive national media attention.

critical analysis and investigative support to assist BCPO in identifying the subject's radicalization and actions in support of terrorism.

On June 18, Fasihullah Safar, of Alexandria, Virginia, received an 18-year prison term for attempting to kill a Florence Township (Burlington County) police officer and assaulting two others in early 2025.

Safar, then 16-years old, **intentionally struck a Florence Township Police Department patrol vehicle multiple times** on March 21, 2025, while the officer was responding to a report of an overturned vehicle. After hitting the police car, Safar's vehicle became inoperable. Safar exited the vehicle and **ran directly towards the officers on the scene, charging at them while swinging a knife**. As a result, **one officer was stabbed multiple times in the chest and suffered facial injuries**, and two other officers sustained injuries.

"The successful resolution of this case underscores the critical importance of partnership and coordination among law enforcement agencies," said NJOHSP Director Thomas Hauck. "I want to recognize the dedicated work of our team and our colleagues at the Burlington County Prosecutor's Office, the Florence Township Police Department, and the New Jersey Office of the Attorney General. NJOHSP remains vigilant in detecting and thwarting terrorism-related threats statewide, and this investigation exemplifies our steadfast commitment to safeguarding all New Jersey communities"

Safar admitted following ISIS in the months before the incident and posting on social media his intent to join the group. He acknowledged screaming "Allahu akbar" during the attack and confirmed his intention was to promote terrorism by killing an officer.

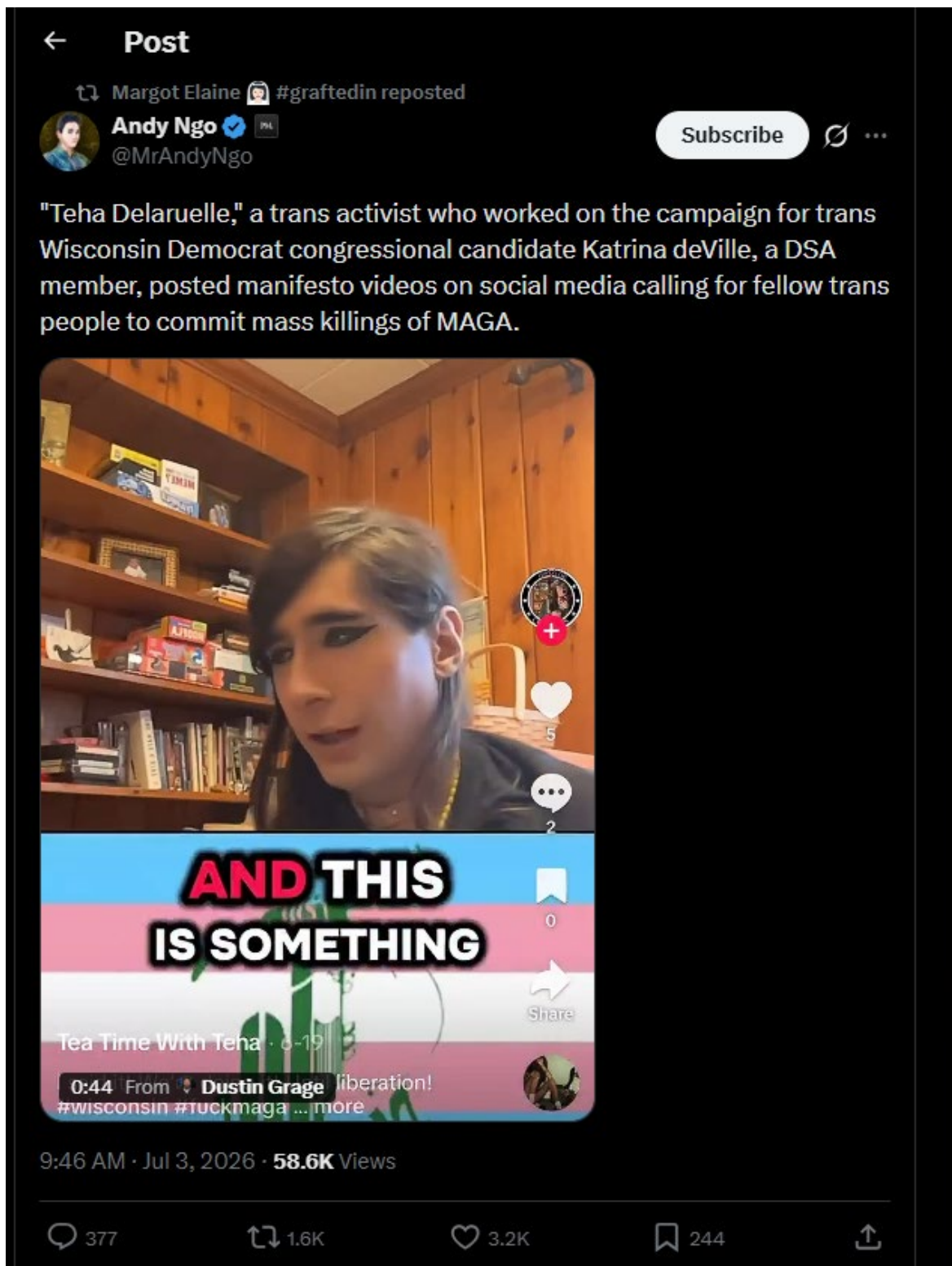

Sources may use TLP:RED when information cannot be effectively acted upon without significant risk for the privacy, reputation, or operations of the organizations involved.	Recipients may therefore not share TLP:RED information with anyone else. In the context of a meeting, for example, TLP:RED information is limited to those present at the meeting.
 TLP:AMBER Limited disclosure, recipients can only spread this on a need-to-know basis within their organization and its clients. Note that TLP:AMBER+STRICT restricts sharing to the organization only.	Sources may use TLP:AMBER when information requires support to be effectively acted upon, yet carries risk to privacy, reputation, or operations if shared outside of the organizations involved.	Recipients may share TLP:AMBER information with members of their own organization and its clients, but only on a need-to-know basis to protect their organization and its clients and prevent further harm. Note: if the source wants to restrict sharing to the organization only, they must specify TLP:AMBER+STRICT.
 TLP:GREEN Limited disclosure, recipients can spread this within their community.	Sources may use TLP:GREEN when information is useful to increase awareness within their wider community.	Recipients may share TLP:GREEN information with peers and partner organizations within their community, but not via publicly accessible channels. TLP:GREEN information may not be shared outside of the community. Note: when “community” is not defined, assume the cybersecurity/defense community.
 TLP: CLEAR Recipients can spread this to the world, there is no limit on disclosure.	Sources may use TLP:CLEAR when information carries minimal or no foreseeable risk of misuse, in accordance with applicable rules and procedures for public release.	Subject to standard copyright rules, TLP:CLEAR information may be shared without restriction.
