Facebook, pastor Peter Anderson said she had "been to many places and served people", adding that her death was a "tragic loss".

An Afghan professional boxer who arrived in Greece on a small boat before marrying an American Christian has been arrested over the murder of Briton Elisabeth-Jane Ross in Athens. Sharif Ahmadzai, 26, is suspected of killing the 38-year-old, who was also known as Lisa, before putting her body in a bag and dumping it in a derelict building.

Detectives trawled CCTV which allegedly shows him leaving the apartment where Ms Ross was staying with a suitcase and dropping it where her remains were found on July 16. Ahmadzai reached the island of Lesbos in 2016. He then converted to Christianity and married US-born Christian Alaina Hall in 2023 before they set up a ministry helping refugees in Athens. The couple are believed to have known Ms Ross, who was also a Christian volunteer, through their work. They had a key to the flat she was staying in as it was owned by their organisation, Love Every Nation Athens, police sources told the Daily Mail. **CONNECTED REPORTING:**

### **Christian Persecution is Exploding: New Report Reveals the World's Worst Hotspots**

A persecution watchdog is sounding the alarm about the worsening situation for Christians unfolding around the globe. Shawn Wright, president of International Christian Concern (ICC), told CBN News that his organization's 2026 Global Persecution Index exposes some truly diabolical situations in various nations. But at the core of the shocking statistics and metrics is a sobering reality: people's lives are being upended and even destroyed.

"Behind every statistic is a real person, a husband, a wife, pastor, or a child who has chosen faithfulness to Christ despite enormous persecution," he said. "The index is not simply a report about persecution. It's a call for the global church to stand with our brothers and sisters who suffer for their faith, because behind every statistic is a real person — and they've chosen Jesus over safety." Wright said Christians shouldn't be surprised by rising persecution, explaining that he believes the New Testament is very clear on the matter. Jesus himself warned believers that they, too, would face pushback for following Him. Regardless, he said Christians need to stand up and take action.

"Hebrews 13:3 is very clear that we are to remember those who are imprisoned for their faith just as if we're chained with them," he said. As for the biggest surprises in the ICC's 2026 Global Persecution Index, Wright said Nigeria is top of mind.

"In Nigeria, in particular, the rise [of persecution is] in such an unfathomable measure," he said. "Before [2024], we were looking at maybe in a one-year period, 500, 600 people who were killed in Nigeria, and just in the past year, that number has gone to over 2,500 and is

WASHINGTON – The United States Department of Homeland Security (DHS) released the following statement after U.S. Immigration and Customs Enforcement (ICE) arrested a criminal illegal alien who had been arrested for **carrying multiple Molotov cocktails** in Illinois.

[According to local reporting](#), police in Mokena, Illinois arrested **Hamed Mohammed Hamed Alsaïdi**, a criminal illegal alien from Jordan, after he displayed suspicious behavior in the early morning hours of August 1. Police officers first encountered him at a closed gas station, told him he could not be there, and took him to another gas station

that was open. **He gave the officers an alias of Hakmat Saidi.** Later that same morning, he was seen walking in lanes of traffic, after which he was arrested. Officers learned his real name and found **EIGHT Molotov cocktails** in his possession.

Alsaidi now faces charges of **felony unlawful possession of a weapon** and **obstructing identification**. His criminal history includes a prior arrest for **domestic battery**.

ICE lodged a detainer with Will County the same day Alsaidi was arrested. Will County sanctuary politicians refused to honor the detainer and released him on August 2 without notifying ICE, after Will County Judge Theodore Jarz granted Alsaidi a pretrial release. ICE law enforcement arrested Alsaidi on August 4.

*“This criminal illegal alien was arrested after he was found to have **EIGHT Molotov cocktails in his possession and gave a false name to officers.** He now faces charges of **unlawful possession of a weapon** and **obstructing identification**,” said a DHS Spokesperson.*

*“Even though ICE lodged a detainer, sanctuary politicians in Will County, Illinois refused to honor it and released him without notifying ICE. Fortunately, thanks to the brave men and women of ICE, we have apprehended him and he remains in ICE custody. Governor J.B. Pritzker and his fellow sanctuary politicians need to stop putting American lives at risk with their reckless, America Last policies.”*

Alsaidi illegally entered the United States through California in March 2024. He was then RELEASED into the country by the Biden Administration.

Under Governor Pritzker, Illinois has become a hotbed of illegal alien crime. Some of the recent illegal alien crimes in the sanctuary state include:

- In June, ICE lodged a detainer for [Janio Gionel Velasquez-Muro](#), an illegal alien from Venezuela, after he was arrested for **kidnapping and sexually assaulting a 9-year-old girl** in Kane County, Illinois.
- In June, ICE arrested [Giovanna Mercedes Moreno Occhipinti](#), an illegal alien from Venezuela and former teacher, for her involvement in **a Tren de Aragua mass shooting in December 2024 that killed three people and injured several others** at a house party in Chicago, Illinois.

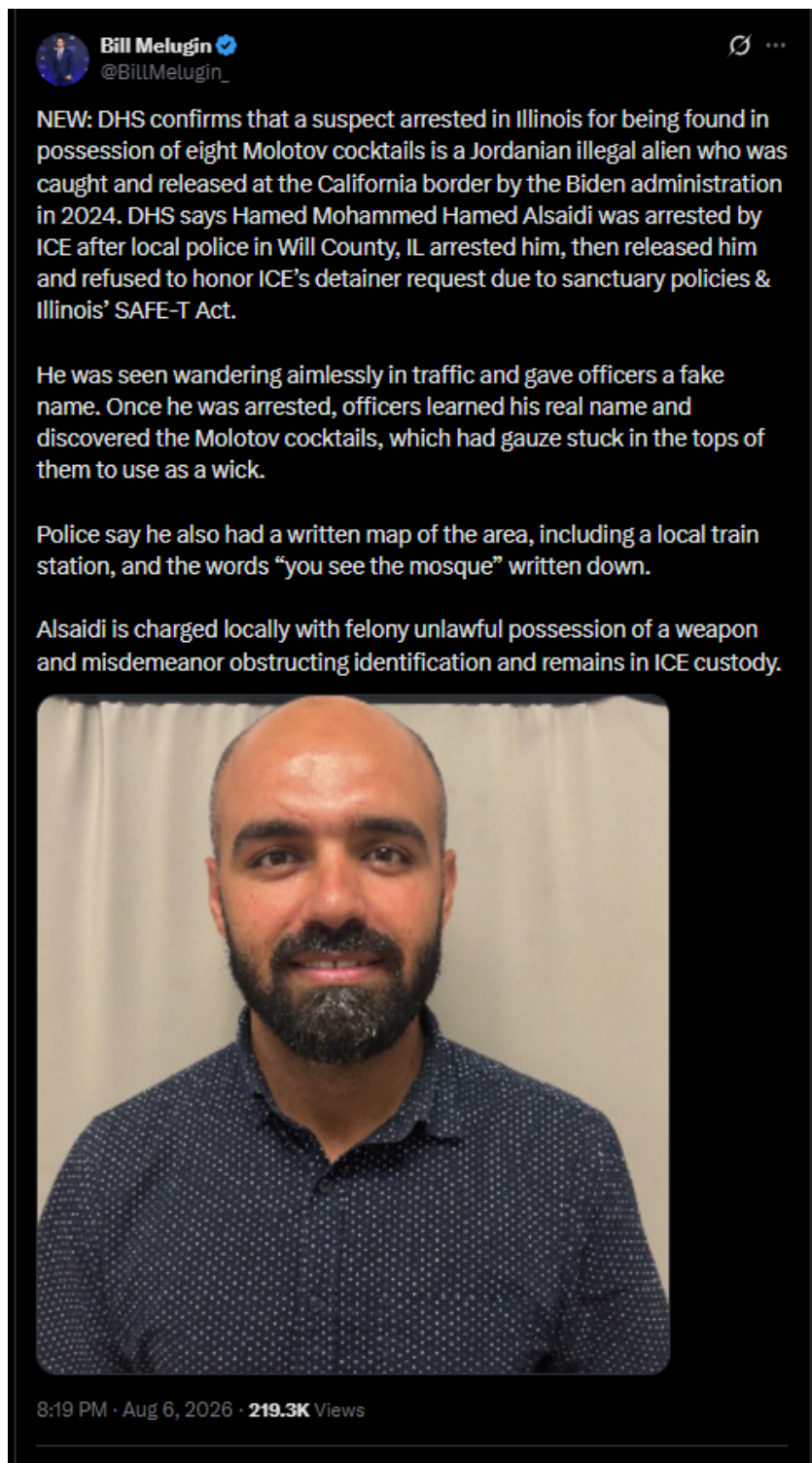

- In March, ICE lodged a detainer for [Jose Medina-Medina](#), an illegal alien from Venezuela, after he was arrested for **shooting and killing 18-year-old Loyola College student Sheridan Gorman** in Chicago, Illinois.
- In October 2025, ICE lodged a detainer for [Leyter Jeferson Arauz-Medina](#), an illegal alien from Nicaragua, after his arrest for **raping a 54-year-old woman** in Chicago, Illinois.
- In October 2025, ICE arrested [Radule Bojovic](#), an illegal alien from Montenegro, who was working as **a sworn police officer with the Hanover Park Police Department**.
- In September 2025, ICE lodged a detainer for [Jose Javier Coronado-Meza](#), an illegal alien from Venezuela, after he was arrested for **killing a man execution-style and then burying his body in concrete** in Cook County, Illinois.
- In July 2025, ICE arrested [Luis Mendoza-Gonzalez](#), an illegal alien from Mexico, after he was released by sanctuary politicians in Lake County, despite being arrested for **hiding the body of 37-year-old Megan Bos on his property**.
- In January 2025, Julio Cucul-Bol, an illegal alien from Guatemala, caused a **drunk-driving crash that killed 20-year-old Katie Abraham** in Urbana, Illinois. Cucul-Bol now faces charges of **leaving the scene of a crash resulting in death, aggravated driving under the influence resulting in death, and reckless homicide**. **Brooklyn church arson suspect kept journal filled with violent threats, prosecutors say in call for detention** By Max Parrott, A.M. NY, Posted on August 6, 2026

The U.S. Attorney's office is seeking pre-trial detention for John Jones, a 24-year-old man facing arson charges for allegedly starting the arson fire that tore through Brooklyn's South Bushwick Reformed Church on June 19.

In a letter to Eastern District of New York Magistrate Judge Peggy Kuo on Thursday, Assistant U.S. Attorney William Bristow argued that Jones should be detained after police recovered a notebook that seemed to contain violent threats.

When he was arrested on Wednesday, federal prosecutors said, that Jones had in his possession a notebook that contained an entry resembling a chart, with headings including "murder them," "kill them," "stab them," "make them pay," and "rape him."

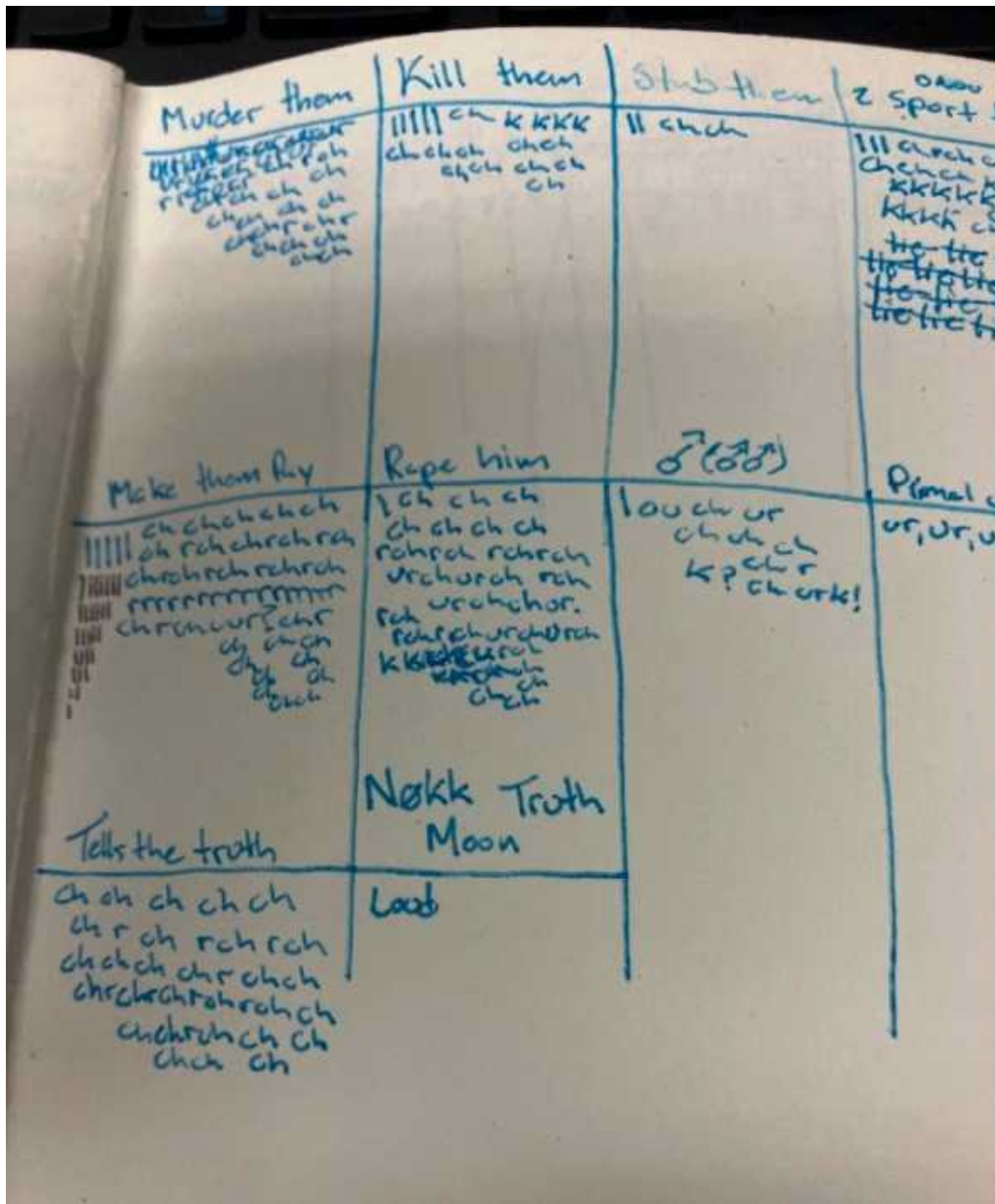
"The defendant's highly concerning journal entries... suggest the defendant's interest in committing acts of violence against individuals or groups of individuals in the community," Bristow wrote in the letter.

Several of the threats in the notebooks appear to include tally marks under them and repeated fragments of the word "church." The attorney's office wrote that Jones' alleged desire to burn down other churches is corroborated by parts of the journal.

Emergency crews responded to Troy Church of Christ on Trombley Road around 3:15 a.m. After entering the building initially, the roof reportedly suffered a partial collapse, which required firefighters to try and put the fire out from the outside. The building was unoccupied when crews entered.

“It’s hard for us. When we get here we want to put the fire out and save as much property as possible. And when we have to go to this defensive posture, it’s hard for our guys because they just want to go back in and put the fire out,” said Lt. Keith Young with the Troy Fire Department.

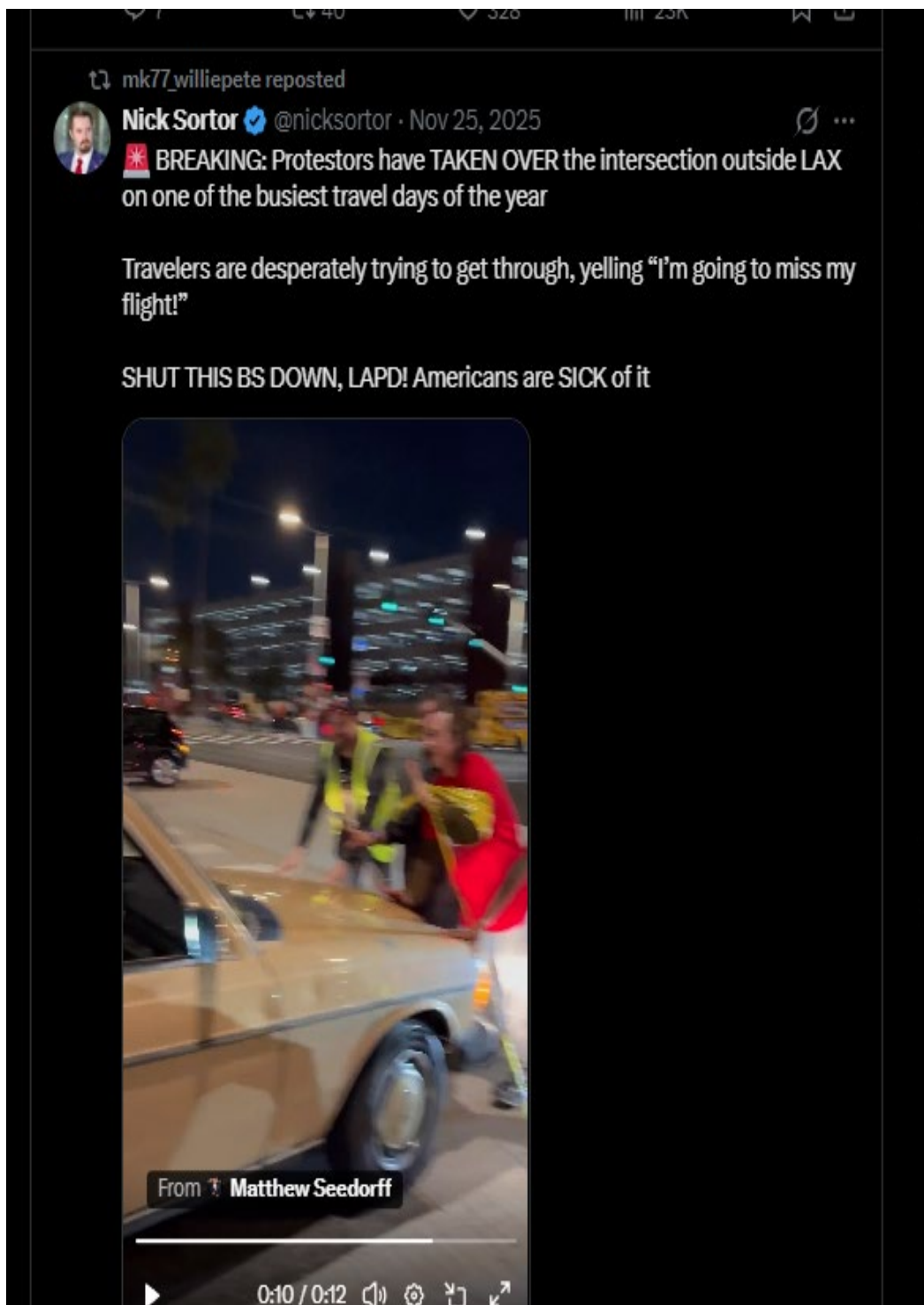

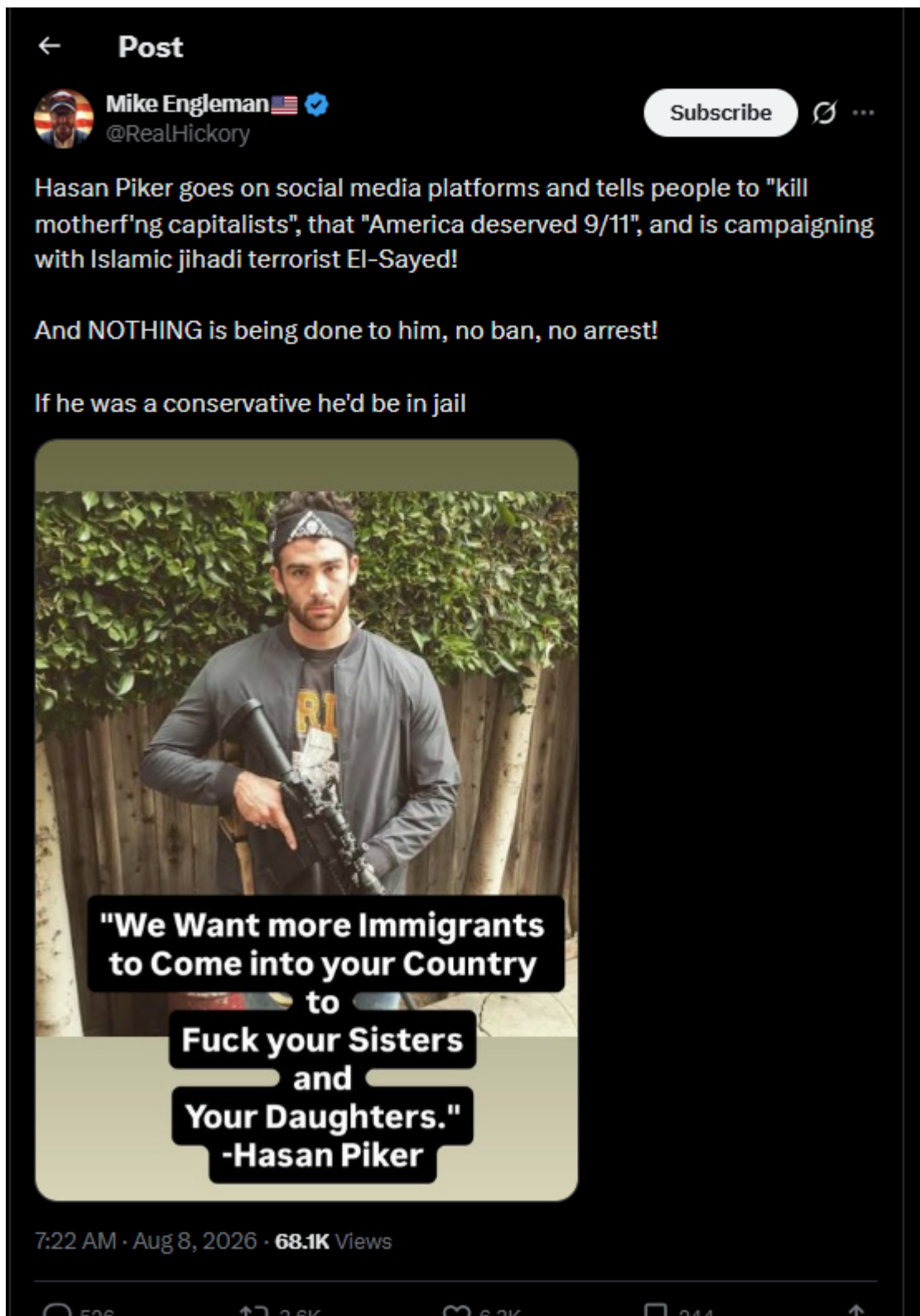

Iraq's highest appellate court has affirmed a Christian woman's right to be officially recognized as a follower of Jesus rather than as a Muslim.

Maryam was raised as a Christian but automatically registered as Muslim after her mother married a Muslim man. Once she reached adulthood, she challenged the designation, asking the government to recognize the faith she had personally chosen.

The Court of Cassation upheld a lower court ruling in her favor, ordering officials to change her religious listing from Muslim to Christian. Alliance Defending Freedom called the decision "a grant of freedom," emphasizing that individuals—not governments—should have the power to choose their faith.

Maryam's two younger sisters remain registered as Muslim but are expected to file similar cases after turning 18.

Jeanine John Taele, 38, of Downey, who was arrested at Trump National Golf Course Los Angeles in Rancho Palos Verdes, is charged in a federal criminal complaint with possession of an unregistered short-barreled rifle, a felony carrying a mandatory minimum sentence of 10 years in federal prison.

Taele was detained after being seen taking photos and video of security-planning activities ahead of President Trump's visit to the golf club today.

LASD deputies found ammunition in Taele's pocket, searched his vehicle, and seized a loaded pistol with a round chambered and a loaded magazine.

A search of Taele's residence seized high-powered firearms, ammunition, body armor, and a notebook.

Taele is charged in Los Angeles Superior Court with firearms-related crimes and a 2025 robbery. He was granted \$250,000 bail in that case.

He is expected to make his initial appearance in the United States District Court in Los Angeles soon after his transfer to federal custody.

While we are still investigating this individual's motives, we are thankful he was apprehended before the President's visit. The @FBILosAngeles, @LosAngelesATF, @SecretService, and @LASDHQ intervened early and prevented a potentially dangerous situation. We thank them for their quick work.

This remains an active investigation.



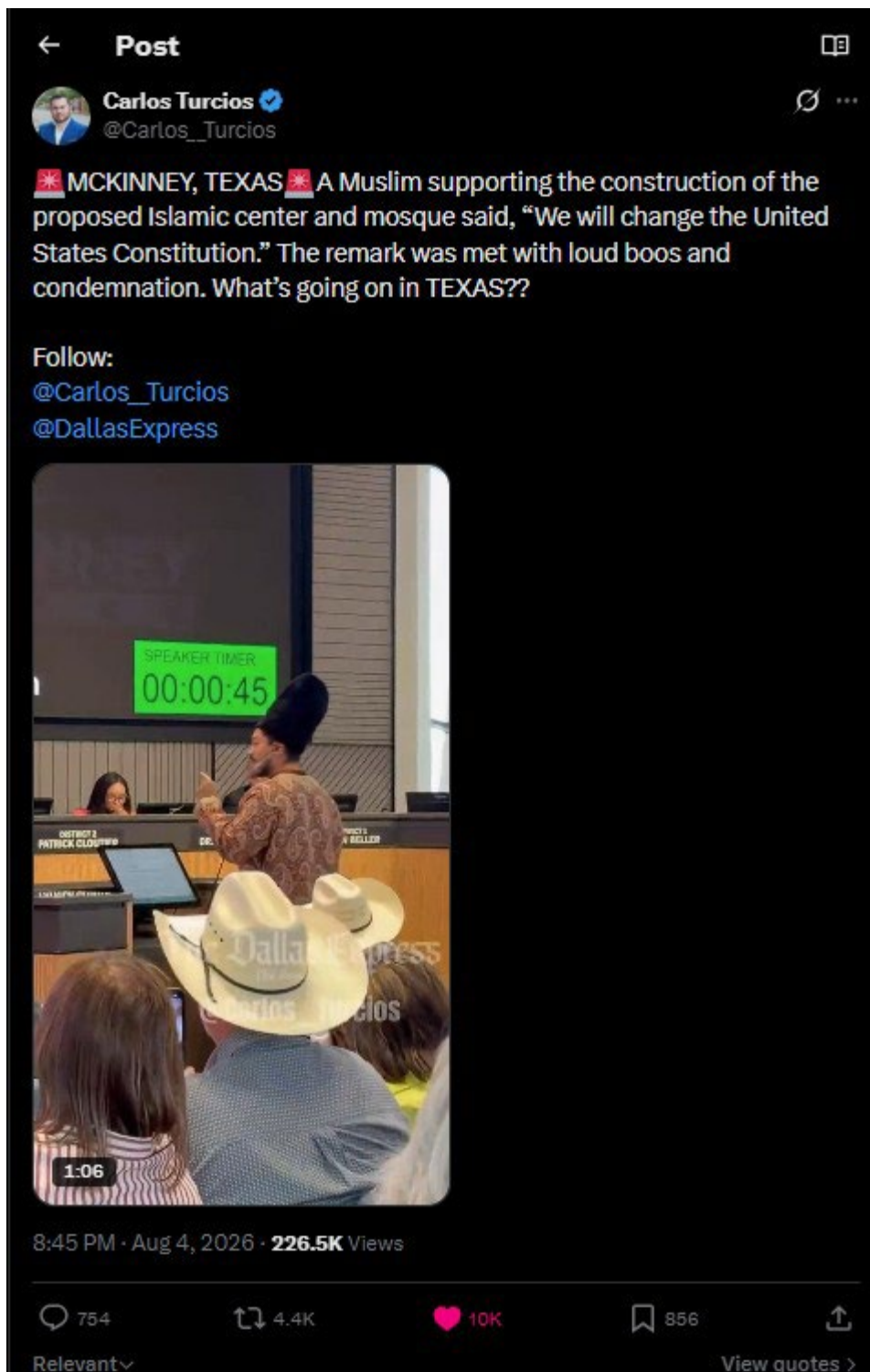
