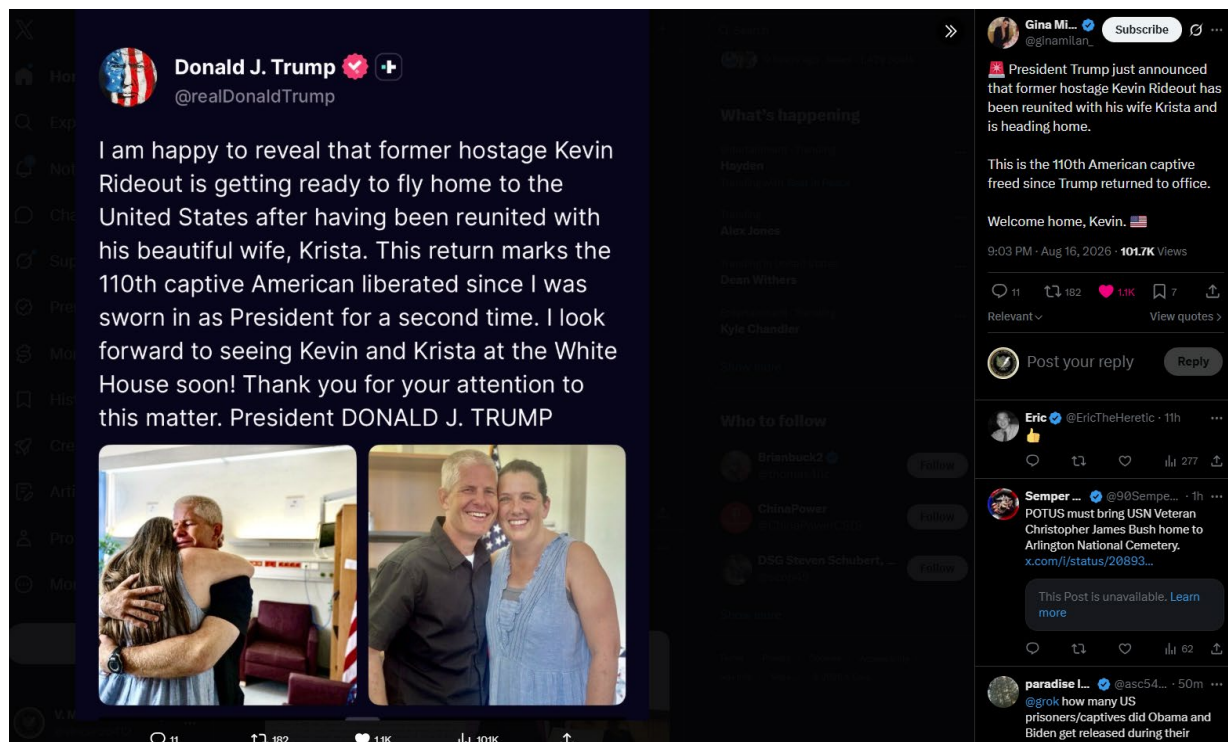

Las Cruces man accused of shooting at Catholic church faces federal charge

On May 4, Las Cruces Police Department officers responded to a reported shooting at St. Genevieve's Catholic Church in Las Cruces. Officers found five bullet holes in the church's front glass entrance and recovered five .380 caliber shell casings.

Surveillance footage showed a black sedan arriving at the church, after which a man exited the driver's side and fired multiple rounds at the entrance before leaving the scene, according to the U.S. Attorney's Office for the District of New Mexico.

On May 11, 2026, officers encountered the same vehicle while responding to an attempted burglary call at a Las Cruces business. The driver was identified as 40-year-old Matthew Alarcon. Officers conducted a search warrant on the vehicle, which led to the recovery of a handgun.

During a May 14 interview, Alarcon allegedly admitted to shooting at the church, stating he did so because of his religious beliefs and because he believed he was "the chosen one" to carry out the act, according to federal investigators. Alarcon is prohibited from possessing guns or ammunition due to a prior New Mexico felony conviction for possession of a controlled substance.

lip and injuries to her right forearm after being struck by the man,” an NYPD spokesperson also confirmed.

“As synagogue security was escorting him out, he struck a member of the congregation, damaged synagogue property, and then spit at and headbutted a member of the security team. “An NYPD sergeant working a paid detail at the synagogue immediately stepped in and took the individual into custody. “I have spoken with the rabbi of the synagogue, and I’m relieved that no one was seriously injured. Those who were hurt were evaluated at the scene and are doing well.

“There are no known additional threats at this time, and additional NYPD resources have been deployed to the synagogue. The investigation is ongoing.

FEDS: Terrorist Mexican Cartel Bought RPGs, Machine Guns from Czech Republic

Four members of the terrorist organization known as Cartel Jalisco New Generation (CJNG) are facing federal charges in the United States in connection with the purchase of RPGs, machine guns, mortars, and other weapons from the Czech Republic, as well as the production and smuggling of drugs into the United States. This week, four men from CJNG went before a U.S. federal judge in Florida, where they had their first appearance in connection with a series of charges detailed in a criminal indictment. The four men, who are from Mexico, had been originally arrested in the Czech Republic and extradited to the United States.

Authorities claim that in February 2026, Lopez Velazco and Diaz Jimenez negotiated the purchase and transportation of RPGs, machine guns, explosive devices, and other dangerous weapons from the Czech Republic to Mexico. The weapons were paid for using drugs that were smuggled into the United States by CJNG. Working with international law enforcement agencies, U.S. agents were able to arrest all four men in the Czech Republic in June. Also, on June 12, Mexican federal police forces raided Diaz Jimenez's lab in Zapopan, Jalisco.

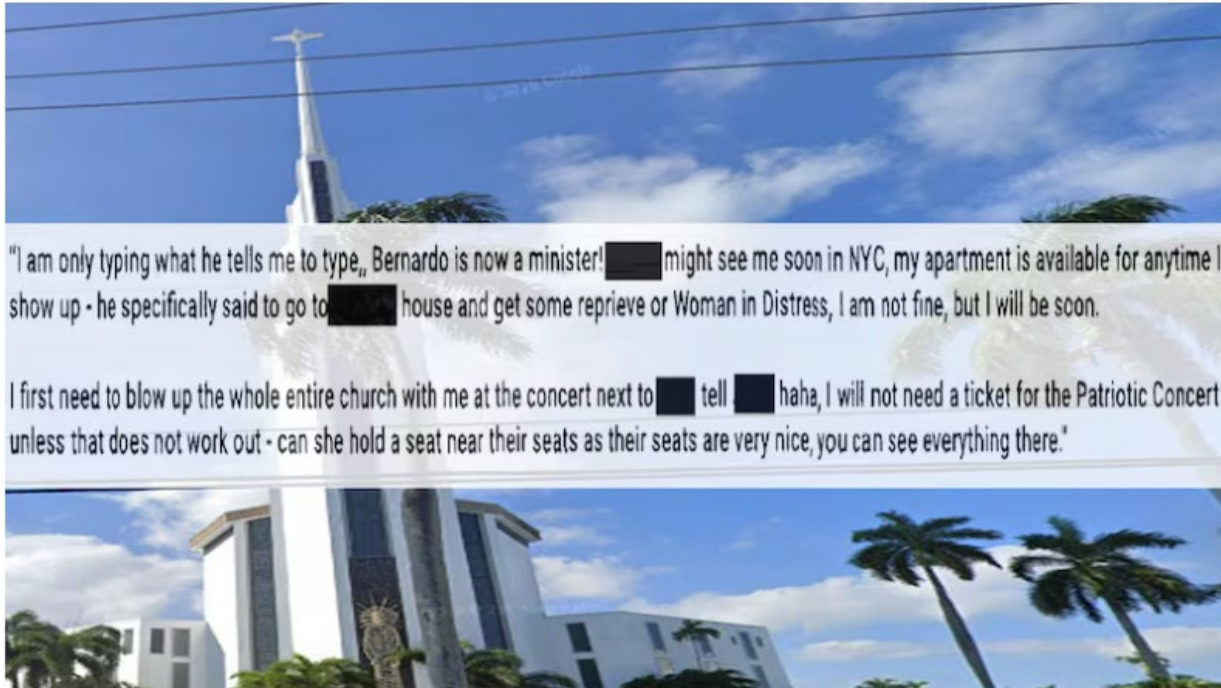

FORT LAUDERDALE, Fla. — A 27-year-old woman faced felony charges on Tuesday in Broward County after allegedly threatening “to blow up” the Coral Ridge Presbyterian Church in Fort Lauderdale. Melissa Redway is a former teacher at Westminster Academy, the church’s private school at 5601 North Federal Highway, according to police.

“After sustaining an alleged brain injury, and not able to conduct her teaching duties, she was laid off,” a police officer wrote, according to the arrest report. Redway, of Coconut Creek, is also a former member of the choir at the Coral Ridge Presbyterian Church at 5555 North Federal Highway, according to police. “During her time away and changing personnel, she lost her position. Redway did not accept the news well and attempted to rejoin the church choir,” a police officer wrote, according to the report.

A leader at the church reported Redway used Gmail to send a threatening e-mail at about 11 a.m. on Feb. 8 that raised concerns about the safety of a concert on Feb. 20 at the church, according to the report.

Dr. Johnny Sanders, the chair of the trustee board at Bethel Apostolic Temple in Miami's West Little River community, said when the deacons came in Sunday morning to set up for service, they noticed the lights weren't working. They then noticed many of their essential worship, sound and technology equipment were gone.

“Our mixers, the keyboard for the musician, our cameras similar to the ones you use were gone that we use to stream the service live,” Sanders said. “You certainly feel violated.” The church says they were forced to cancel service. Sanders said they checked their surveillance and watched two people break in through a back door and spend almost 30 minutes inside the church grabbing whatever they could get their hands on, before they cut the power.

“They took the console, the sound board, laptops, everything we need to facilitate service,” Sanders said. “It is a huge devastating hit.”

Each site, according to court records, functioned as a call center to solicit millions of dollars in donations; but investigators say, at times, people working on the site were not allowed to leave. 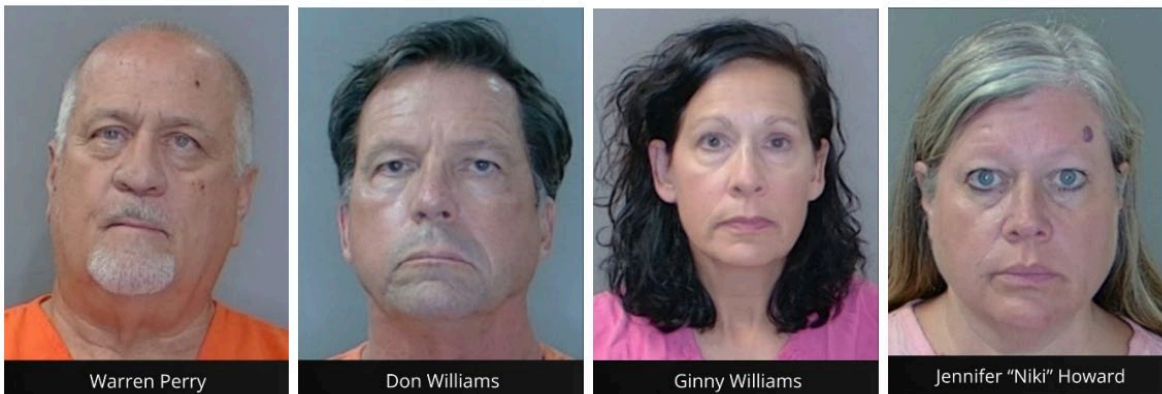

IN OBSCURA PREVIOUSLY POSTED THE INTIAL CRIMINAL CHARGES

A Southern Baptist church and school in South Carolina provided a known sex offender unrestrained access to children for several years and silenced a teacher who raised concerns about the situation, according to a federal lawsuit filed Aug. 4. The class-action complaint accuses Pawleys Island Community Church and its Pawleys Island Academy of allowing Warren Spencer Perry to volunteer as a maintenance worker at the school despite knowing of his prior conviction for sexual exploitation of a minor.

Defendants include former Senior Pastor Don Williams, his wife and former Guest Services Director Ginny Williams, former academy director Jennifer “Niki” Howard, the congregation’s elders and Perry. The Southern Baptist Convention and the SBC Executive Committee also are named in the lawsuit.

Venice man planned mass shooting at church, wanted to attack mosque: FDLE

VENICE, Fla. (WFLA) — A Venice man was arrested after he was accused of planning a mass shooting at a local church. A news release from the Florida Department of Law Enforcement said the FBI pointed the agency toward Giovanni Pimienta, 19, who was “communicating with other users online about obtaining weapons and conducting a mass shooting and glorifying other mass shootings.”

Haines City officer used Flock cameras to track estranged wife on 717 occasions: affidavit Pimienta posted a 61-page manifesto, which he said was written by the AI chat bot Grok, and an AI-generated video appearing to show him and a co-conspirator dancing in front of a mosque in South Carolina. Pimienta said he would “purchase an AR-15 and shoot up a mosque,” an arrest report said. The manifesto included “personal reflections, ideological arguments, calls for social collapse, praise of violence, and promotion of white supremacists, antisemitic, anti-Black, anti-Muslim, accelerationist viewpoints, and praising the actions of Caleb Vasquez, who perpetrated a deadly attack against the Islamic Center of San Diego,” according to an arrest report.

They say the social media threats included school shootings, bombings and other violence. Investigators say Kang did not have the means to carry out any of the threatened attacks.

Haitian bishop warns gangs are targeting Church as violence forces parish closures

The Catholic Church in Haiti is facing mounting attacks from armed gangs seeking to weaken one of the country's few remaining institutions willing to challenge them, according to a Haitian bishop. Bishop Joseph Gontrand Décoste of Jérémie told Aid to the Church in Need (ACN) that churches, clergy and religious communities were increasingly being caught up in the violence that has engulfed large parts of the Caribbean nation. Bishop Décoste described the Church as one of the last significant voices resisting the influence of armed groups. "We are the last remaining bulkhead - moral, ethical, spiritual and prophetic," he said. "That is why they want to eliminate us."

According to ACN, gangs are estimated to control between 70% and 90% of capital Port-au-Prince and have also established a presence in parts of the Artibonite and Centre departments. Armed groups are reportedly imposing illegal tolls in areas under their control, while widespread insecurity has forced churches, schools and religious communities to abandon their buildings.

BYRON CENTER, Mich. — Parishioners and officials with Byron Center Bible Church are picking up the pieces after the church caught fire early Monday morning. Pastor Chad Dejong learned about the fire from one of his deacons after leading services at the church just hours earlier. "I learned about it at about 4:30 this morning. One of our guys, our deacons who was here a little bit earlier and called that it was on fire," Dejong said.

The fire was called in by a passerby at 3:41 a.m. Monday while storms were moving through the area. The ATF is investigating the cause of the fire, though lightning may have played a role. Byron Township Fire Chief Eric Weeringa described the damage as extensive, but said some of the building can be salvaged. "We initially thought we were going to have to tear down part of the sanctuary and did have a meeting with church members while we discussed that. Thankfully, we only had to tear down the gymnasium and the classroom portion on the back," Weeringa said.

Evangelical YouTuber Mike Winger is asking Christians to financially support fellow content creator Michael Jones as he seeks to relocate his family. Jones said the move is necessary following alleged threats, stalking and the exposure of private information linked to his online ministry comparing the teachings of Christianity and Islam. Winger issued the appeal through a post on X, describing Jones as a personal friend and saying the family needed to leave its current residence because of ongoing security concerns.

Jones alleged that those responsible circulated his telephone number and an address they claimed belonged to him. He said they also issued threats of physical harm and sexual violence against his pregnant wife, who is expecting their second child. After consulting others about how to protect their family, Jones said he and his wife determined that moving was the most responsible option. He added that they would not release photographs, identifying information or the location of their new residence.

Jones also described an incident in Los Angeles in which a man he identified as the leader of the group harassing him allegedly followed him to a church where he was scheduled to speak. Jones said the man claimed to be carrying a weapon.

He further alleged that an FBI agent previously visited his home and informed him that a terrorist organization based in the Middle East had identified him as a target, referring to him as a "kafir" and regarding him as a threat.

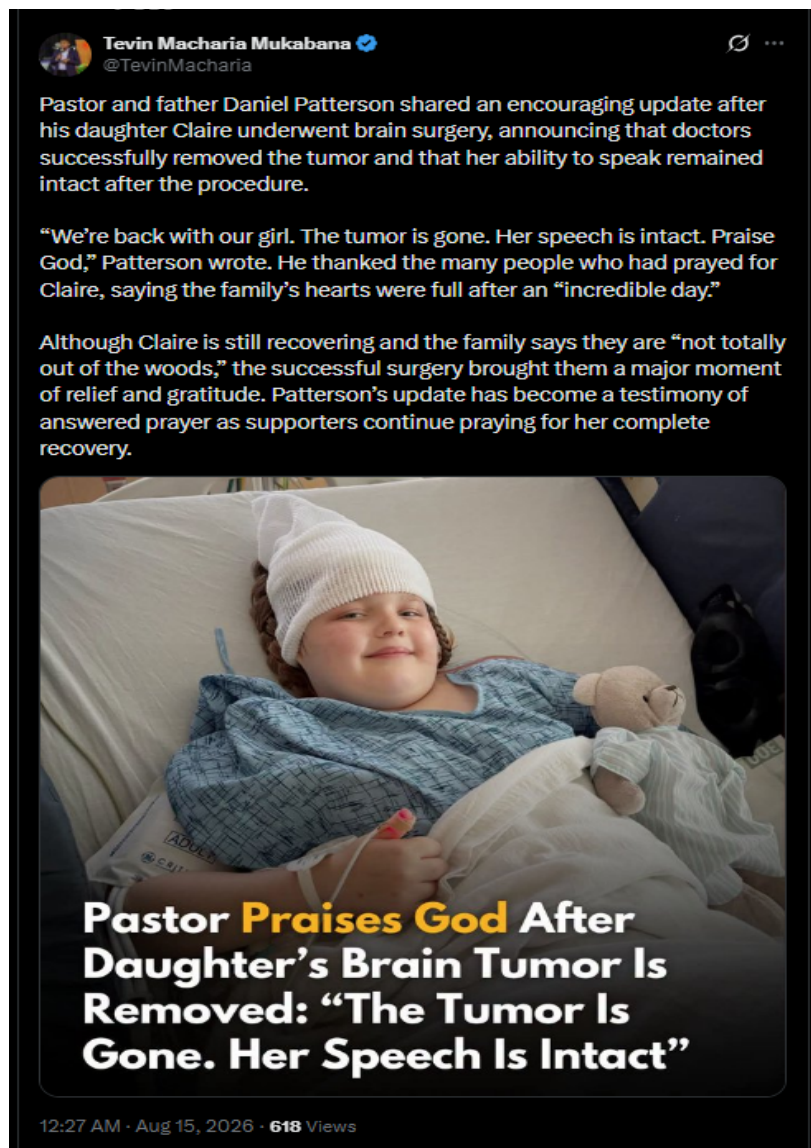
The Department of Defense Education Activity operates about 160 schools across 11 countries and educates roughly 70,000 students who are children of active-duty military or civilian service members. Conservatives have eyed the schools — which, unlike most public schools, are run by the federal government — as a testing ground for [reshaping education](#).

The Western civilization course planned for this fall will use a textbook published by Encounter Books, a conservative publishing house. Titled "The Golden Thread: A History of the Western Tradition, Volume I: The Ancient World and Christendom," it includes suggested lesson plans created in partnership with Hillsdale College, a conservative Christian school in Michigan that has also developed influential materials for K-12 schools.

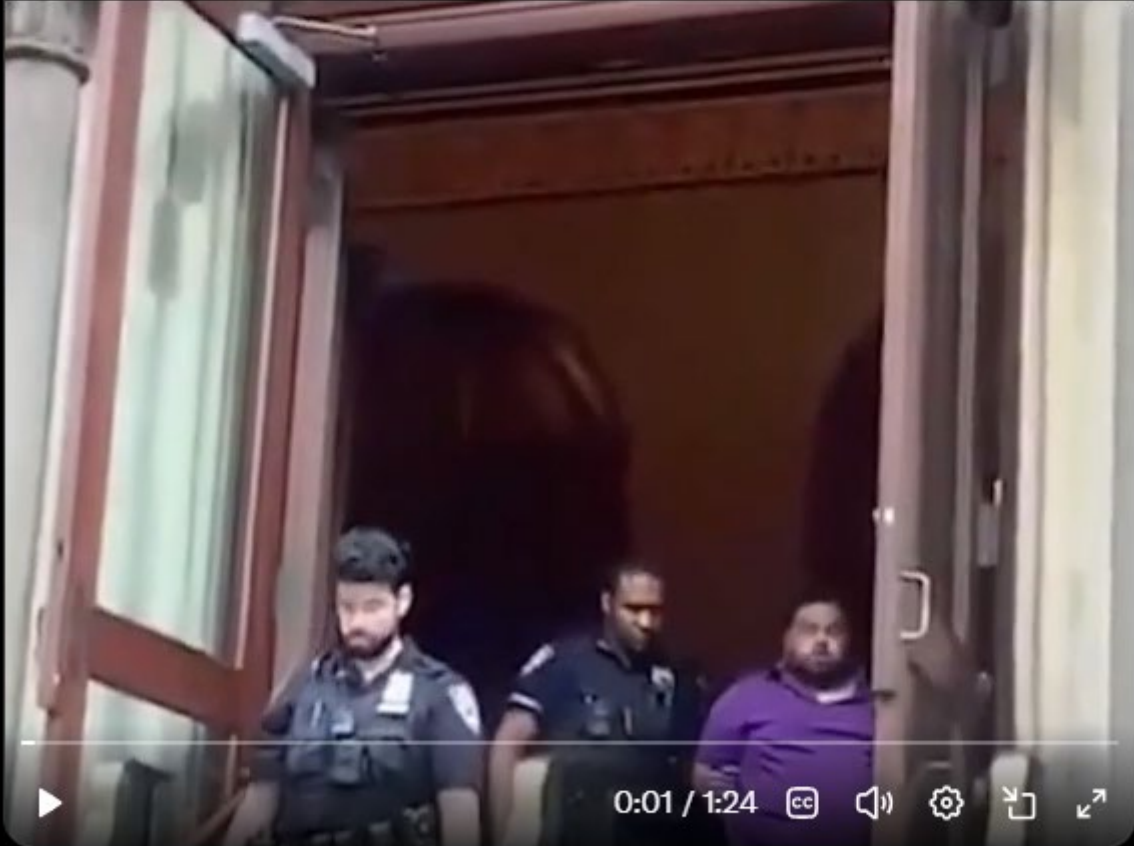

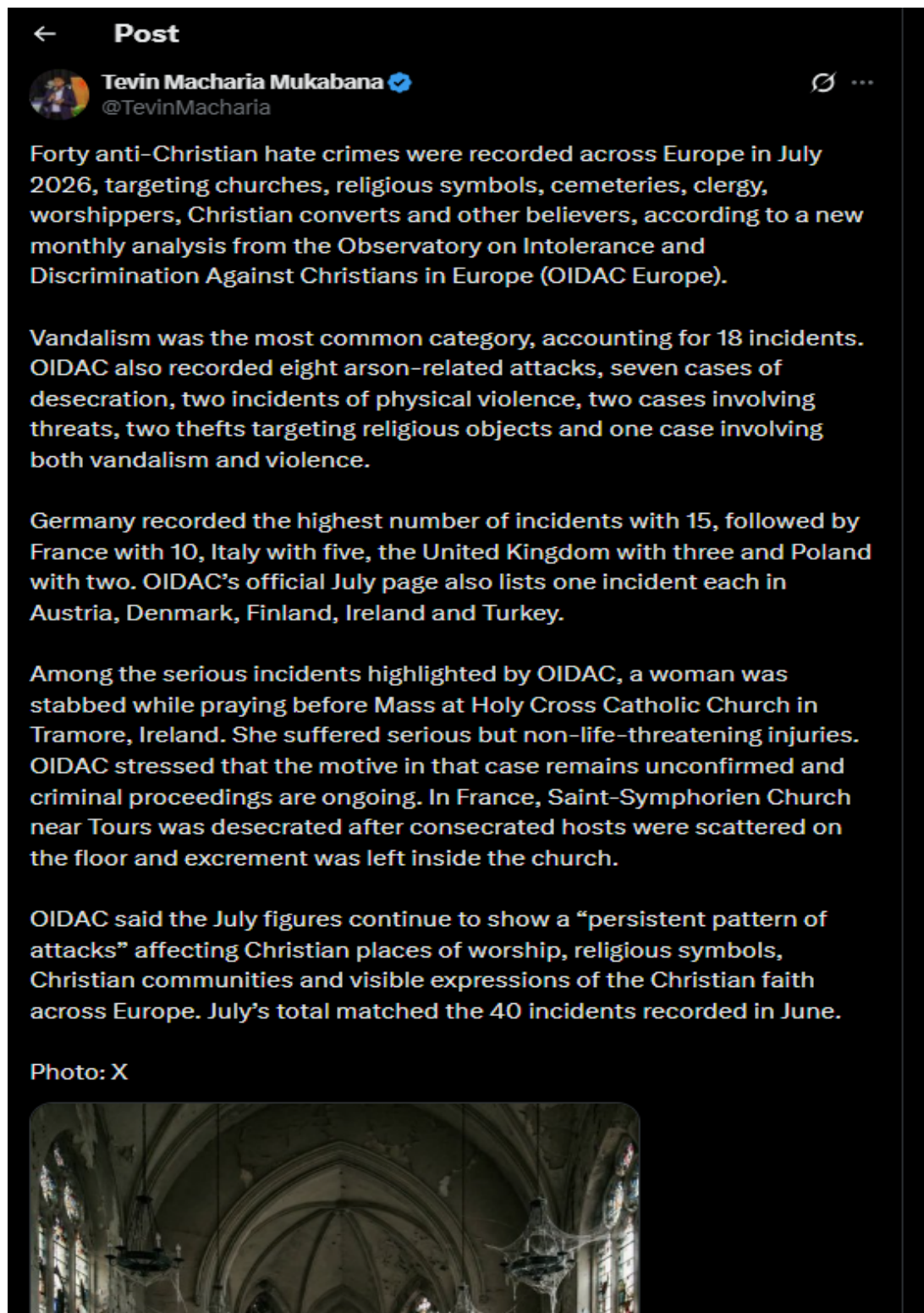

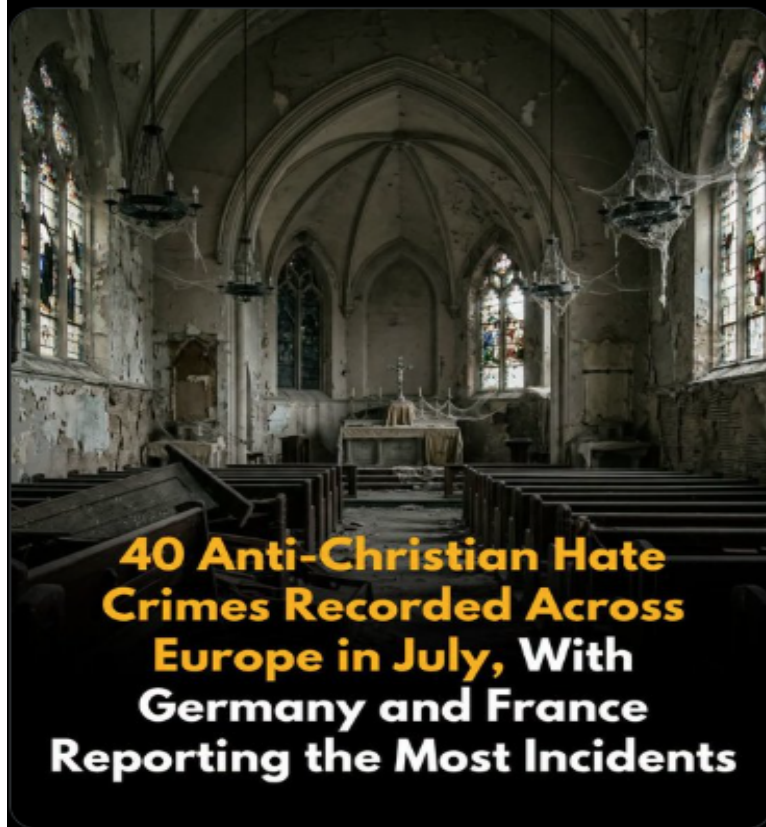

Among the serious incidents highlighted by OIDAC, a woman was stabbed while praying before Mass at Holy Cross Catholic Church in Tramore, Ireland. She suffered serious but non-life-threatening injuries. OIDAC stressed that the motive in that case remains unconfirmed and criminal proceedings are ongoing. In France, Saint-Symphorien Church near Tours was desecrated after consecrated hosts were scattered on the floor and excrement was left inside the church.

OIDAC said the July figures continue to show a “persistent pattern of attacks” affecting Christian places of worship, religious symbols, Christian communities and visible expressions of the Christian faith across Europe. July’s total matched the 40 incidents recorded in June.

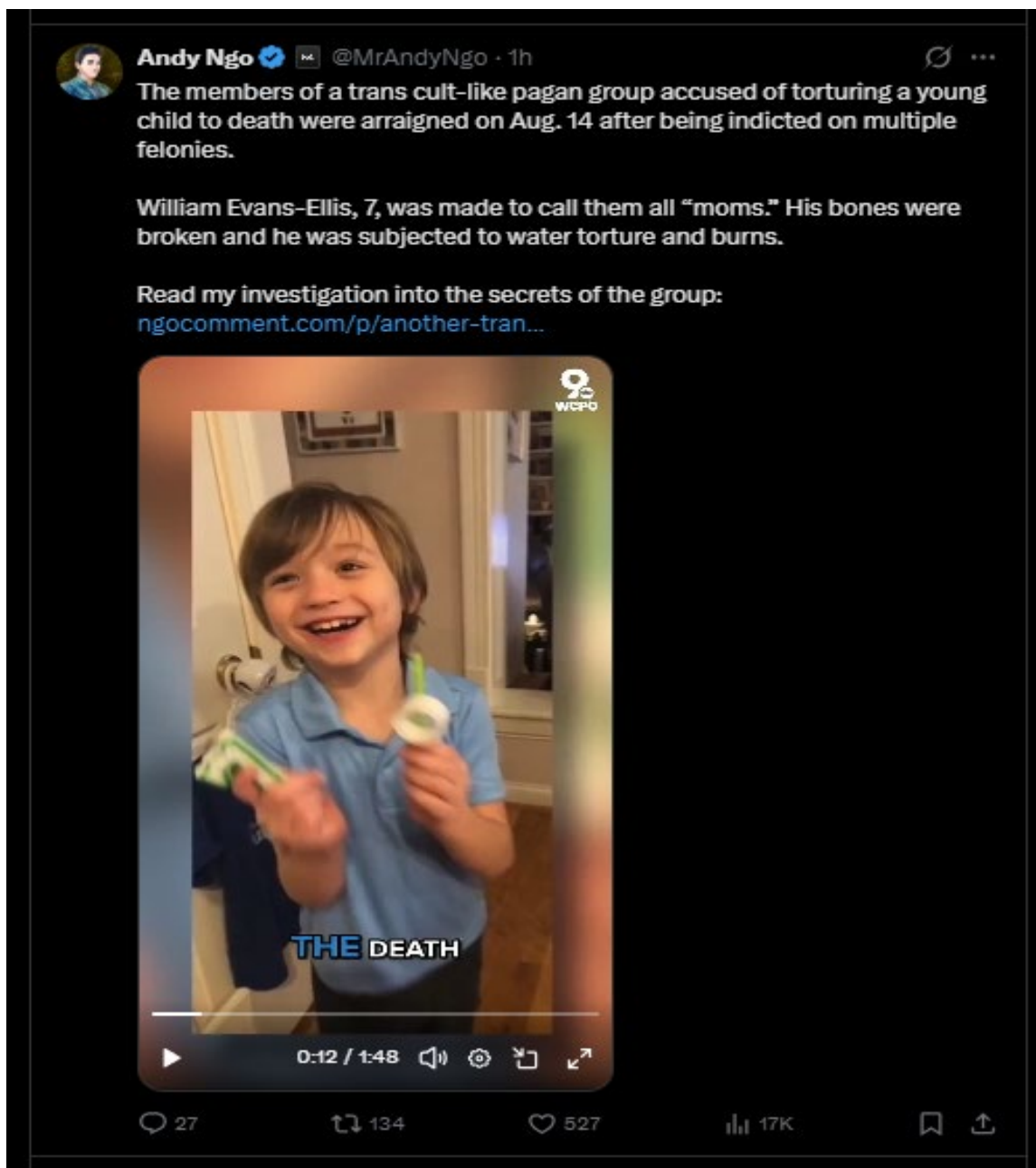
