Claudia Allen, executive director of the Adventist Peace Fellowship, addressed the crowd, framing the moment in biblical terms and criticizing what she described as a false narrative of peace amid ongoing violence:

“We gather in a **moment that Scripture would recognize** all too well.”

Referencing the prophet Jeremiah, she added, *“They have healed the wound of my people lightly, saying, ‘Peace, peace,’ when there is no peace... **As I stand before you today, there is no peace.**” Allen rejected the idea that current military actions reflect Christian principles.* “These are not the children of peace. These are not those who heed the command of Christ to be peacemakers. **“These are the makers of war.”**

Using imagery from Revelation, Allen delivered a pointed critique of U.S. policy and global conflict: **“The dragon says: ‘We bomb you in the name of peace... we will drive your children in the name of freedom... we will sanction the poor and call it Christian nationalism.’”**

She also condemned government spending priorities, **adding that resources are directed toward weapons while basic needs go unmet:**

“The dragon of Revelation 13 says: ‘We will spend 900 billion dollars on weapons and tell you there is **no money for your grandmother’s insulin, no money for your child’s lunch, no money for your veteran’s surgery.**”

Allen concluded by calling for unity across religious and cultural lines in opposition to war:

“The Adventist Peace Fellowship calls upon our neighbors of every faith—and those of no faith at all... **to stand against this unholy war,**” she said. **“May the God of peace, who is greater than the powers of war, make us troublesome.”** RELEVANT SOCIAL NETWORK GRAPHICS:

A Knoxville man has been charged after he allegedly made threats to a church and its congregation.

According to a warrant obtained by WVLT News, 35-year-old Phillip Larue made a post and several comments on social media about a church located on Hill Road in Knoxville on Sept. 2. Among Larue's comments was one that said, "The entire church is about to meet God, this time it's going to be a lesson," the warrant said. Additionally, he reportedly made other posts referring to firearms and "taking arms against those he perceives as doing injustice."

This caused the church to cancel events scheduled for Sept. 2 and make other plans to allow for a higher security setting, according to the warrant. LaRue was charged with threatening to commit an act of mass violence at a church. He appeared in court Friday morning and has a bond hearing scheduled for Tuesday morning.

ARAPAHOE—The smell of sweetgrass and sage clung to a shade tent tipped askew on the edge of the barrow ditch, the Northern Arapaho Tribe's red, white and black flag flipping and clapping in the wind. On that day — July 26 — there were more people outside Foundations For Nations Church than inside it.

It was the third week of protest over a controversy that sparked national headlines and united tribal leaders on the Wind River Indian Reservation. The clash has spurred legal questions focused squarely on tribal sovereignty and religious freedom. While both sides have promised they're ready to fight in court, Foundations For Nations made the first move Friday with a discrimination complaint filed by a legal nonprofit based in Florida.

Mohsen Mahdawi, the Palestinian Columbia University student who is facing deportation over his central role in the anti-Israel campus protest movement, has a previously undocumented history of "support for terrorists, terrorist organisations, armed violence and those who carried it out," according to a comprehensive investigation published Wednesday by two investigative journalists.

The findings undermine Mahdawi's own claims—as well as those by sympathetic media outlets—that he is being targeted by the Trump administration over his peaceful advocacy for Palestinian rights and those living in Gaza. The 100-page investigation, authored by journalists David Collier and Rachel Feldman, unearthed previously unseen statements in which Mahdawi, who's from the West Bank, promised to "annihilate the Jews," praised Hamas, honored dead terrorists, and bragged that the Palestinians "have the capacity and conviction to resist, to kill and to wound."

Bomb Arson Tracking System covers calendar year 2025 and recorded 244 fire incidents at houses of worship, of which 58 were classified as incendiary.

Family Research Council, which compiles publicly reported hostile acts against churches (vandalism, arson, threats and related crimes), documented 55 arson or attempted-arson cases in its most recent full-year report covering 2024. Those incidents formed part of 415 total events affecting 383 congregations in 43 states. No equivalent compilation for 2025 or 2026 has been released.

Reported fires in 2026 have occurred in multiple states, including Michigan, Montana, California, Kansas, Texas, New York and Ohio. Earlier tracking showed higher raw numbers in more populous states rather than a single concentrated region.

A limited number of 2026 fires have been publicly ruled arson. Examples include a juvenile arrest after fires at two Topeka, Kansas, churches in February, an Amarillo, Texas, fire tied to an attempted copper theft, and a Cleveland, Ohio, Baptist church fire determined to be intentional. Many other cases, including the Grand Rapids fire, remain under investigation with no official cause announced. Historical U.S. Fire Administration data indicate that accidental causes such as electrical faults, lightning and construction work account for a substantial share of fires at religious buildings.

Some observers and social-media users have pointed to the frequency of church fires and the number still listed as undetermined, suggesting a possible pattern of arson. Authorities have not endorsed that interpretation and continue to treat each incident individually pending forensic results.

There was no attorney information immediately available for Wonsia. A representative of Pocono Lake Bible Church, where the incident happened, didn't immediately return a request for comment Monday afternoon. Pocono Mountain Regional Police Chief Chris Wagner said the incident unfolded shortly before 11 a.m. at the church, 354 Route 940, in Tobyhanna Township, Monroe County. Worship is routinely scheduled for 10:30 a.m. Sundays, according to the church's website.

Wonsia was asked to leave after refusing to remove the sword, the chief said. He repeatedly stated that he "cannot leave" and "needed to go in," according to police. The church then went into a lockdown as Wonsia stayed outside. There were no reported injuries.

The incident unfolded Saturday near a church in Boynton Beach after a funeral for 19-year-old Nigel Beckford, who was fatally shot earlier this month. According to the Palm Beach County Sheriff's Office, deputies recovered four firearms during the stop, including two that had previously been reported stolen. Five people were taken into custody, and authorities said some of those arrested face charges that include inciting a riot and resisting an officer with violence. Officials had not publicly released all of the identities of those arrested as of the latest reports.

The average annual security expenditure for a Jewish institution was around \$225,000, the federations said, adding that the total cost could be used to provide Jewish day school tuition to around 44,000 children. Jewish community leaders have described the security costs as an additional “tax” on Jewish life. “Every dollar our community spends on guards and cameras is a dollar not spent on Jewish education, on caring for our elderly, on taking care of those in need,” said Eric D. Fingerhut, the head of the Jewish Federations of North America.

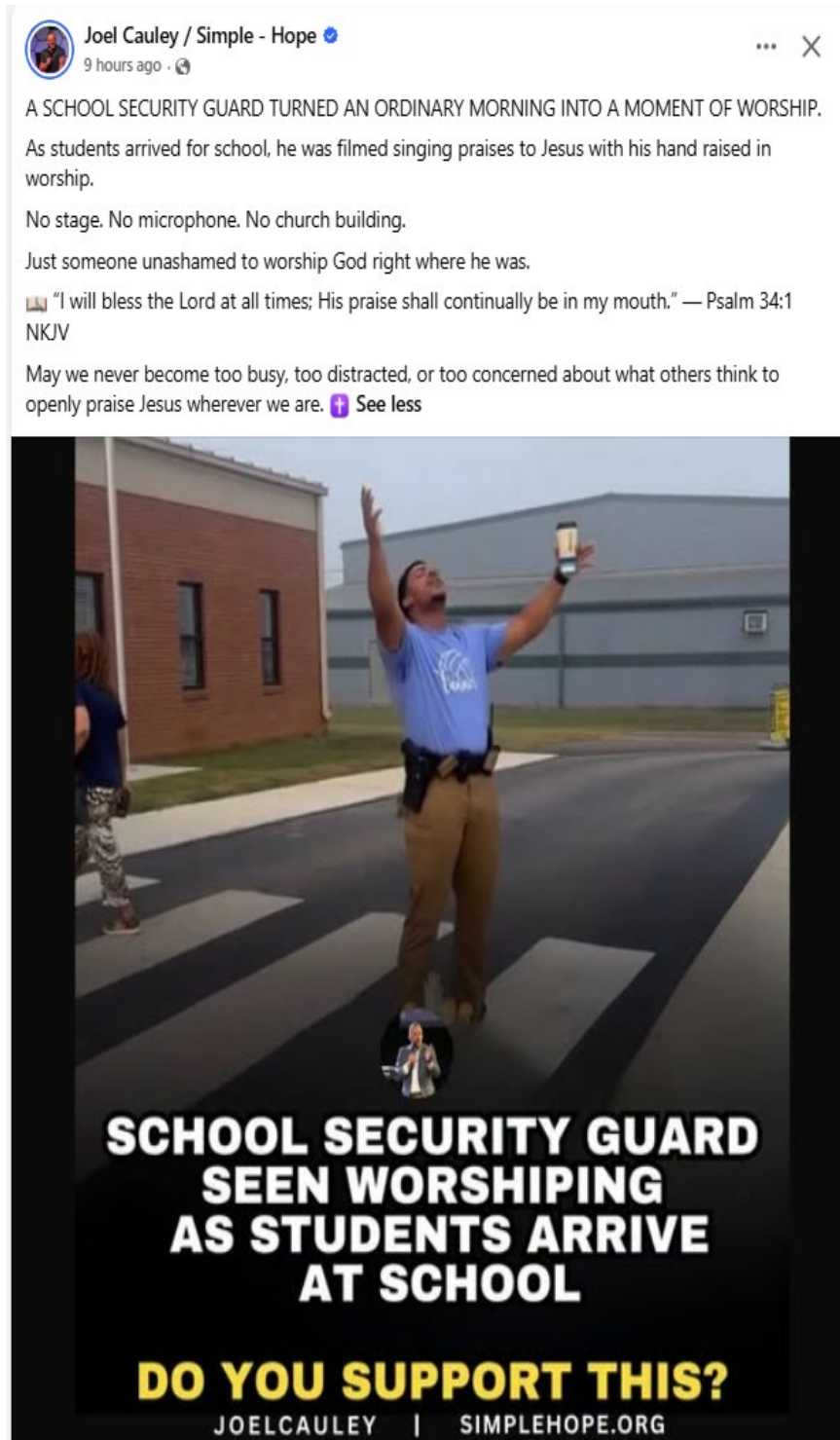
The ejection came days into the 10-day festival, which draws tens of thousands to the Nevada desert under its official theme of human connection and “radical inclusion.” In an Instagram video posted Wednesday, Hinerman addressed the camera directly as his group prepared to depart. “We have been asked to leave Burning Man. We’re packing up. They’re kicking us out. Satan’s mad. We have over 600 people who have given their lives to Jesus already, and Satan can’t do anything about it,” he said. He added that he “has a feeling God is about to move and do something huge.”

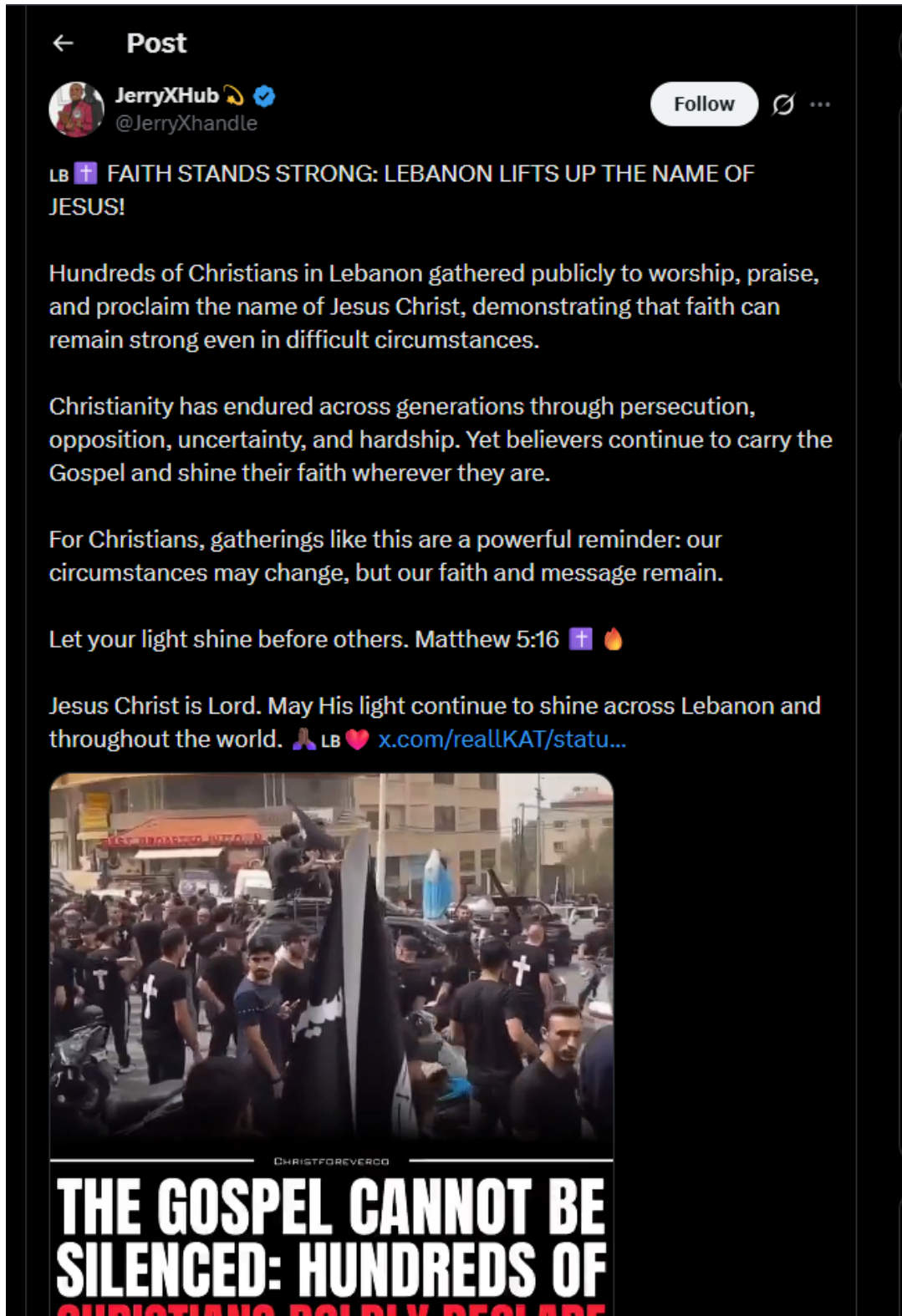

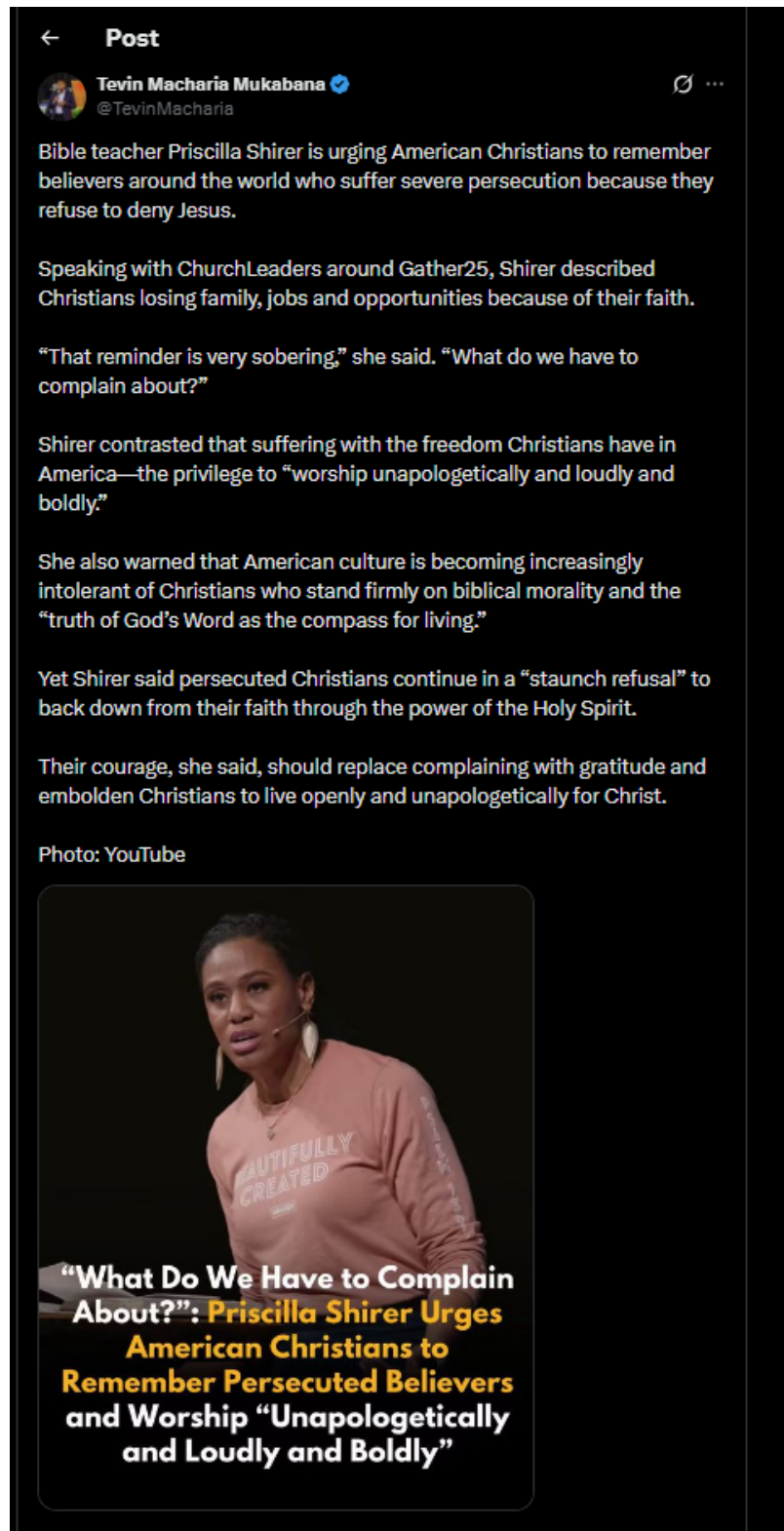
